Notes on statistical tables presented by citizenship country

A result of 'na' indicates that the country did not have a Working Holiday Maker arrangement with Australia during the specified period. This may be because the arrangement had not yet commenced or the arrangement is no longer in place. Refer to the table 'Australia's Working Holiday Maker arrangements' in the 'Background to the Working Holiday Maker visa program' section.

A citizenship country of 'Not Specified' can result from eligible dual nationality applicants where the non-eligible nationality has been recorded for the WHM application.

Note 1: Data in years prior to 2017-18 was revised on 1 October 2019, due to better source data becoming available. This may result in minor discrepancies with previously published statistics.

Definition of terms

Citizenship country:	The country of citizenship of the visa applicant or visa holder. Where a visa applicant or visa holder has more than one citizenship country, either the citizenship of the travel document or the citizenship nominated by the visa applicant is used.
Granted:	Unless otherwise specified, the number of visas granted includes all visa grants.
Snapshot date:	The snapshot date is a point in time at which a count is undertaken. In this report, the number of visa holders in Australia at a point in time is used.
Visa applicant:	Used to refer to clients applying for a visa.
Working Holiday Maker:	Refers collectively to both the Working Holiday (subclass 417) visa and the Work and Holiday (subclass 462) visa.

Background to the Working Holiday Maker visa program

The purpose of the Working Holiday Maker (WHM) visa program is to foster people-to-people links between Australia and partner countries, with particular emphasis on young adults. It has been in existence since 1975. Today, the WHM visa program includes two subclasses: the Working Holiday (subclass 417) visa and the Work and Holiday (subclass 462) visa. Partner countries initially comprised a relatively small number of Commonwealth countries. The program now has 44 partner countries and regions from across the world.

Australia has an overarching bilateral arrangement, usually in the form of a Memorandum of Understanding, with each partner country or region. Of the 44 partner countries or regions, 19 are Working Holiday (subclass 417) visa arrangements, and 25 are Work and Holiday (subclass 462) visa arrangements. The key difference between the two visas is that Work and Holiday visa arrangements generally have caps on the number of visas granted in each program year and additional eligibility requirements.

WHM arrangements are largely reciprocal, providing Australians with similar opportunities overseas. In considering whether to add new WHM partner countries, the Australian Government considers a range of factors, including the ability of the prospective partner to offer reciprocity to Australians, and the strength of any people-to-people links.

Eligibility requirements

WHM (both Working Holiday and Work and Holiday) visa applicants must:

- be aged 18-30 (inclusive) at time of application. For Canada, France and Ireland, the age is 18 to 35 (inclusive).
- hold a passport from an eligible partner country or region. A list of eligible countries and regions is provided in the 'Australia's Working Holiday Maker Visa Arrangements' section of this report
- not be accompanied by dependent children during their stay in Australia
- meet financial, health and character requirements.

Work and Holiday visa applicants must meet additional requirements, which may include:

- functional English
- successful completion of at least two years of undergraduate university study (except Israel & USA)
- a letter of home country/government support in association with their visa application (except Argentina, Austria, Chile, China, Israel, Portugal, Spain, Singapore and USA).

Working while in Australia

All WHMs may work for the full duration of their 12 month stay in Australia, but generally cannot remain with any one employer for longer than six months (by operation of mandatory visa condition 8547).

A visa holder may work for the same employer for a combined total of more than six months, provided the work is undertaken in a different location and work in any one location does not exceed six months. Studying while in Australia

All WHMs are entitled to study for a period of up to four months during their 12 month stay in Australia.

Background to the Working Holiday Maker visa program - continued

Second and third Working Holiday visas

First-time Working Holiday (subclass 417) visa holders who complete three months of 'specified subclass 417 work' during their stay acquire eligibility to apply for a second Working Holiday visa. Second Working Holiday visa holders who complete six months of 'specified subclass 417 work' during their stay acquire eligibility to apply for a third Working Holiday visa.

Specified subclass 417 work includes work in the agriculture, mining and construction industries, bushfire recovery work and critical COVID-19 work in the healthcare and medical sectors.

Second and third Work and Holiday visas

First-time Work and Holiday (subclass 462) visa holders who complete three months of 'specified subclass 462 work' during their stay acquire eligibility to apply for a second Work and Holiday visa. Second Work and Holiday visa holders who complete six months of 'specified subclass 462 work' during their stay acquire eligibility to apply for a third Work and Holiday visa.

Specified subclass 462 work includes work in the agriculture, construction and tourism and hospitality industries, bushfire recovery work and critical COVID-19 work in the healthcare and medical sectors.

Processing times

The Department is currently processing a large volume of Working Holiday Maker (WHM) visa applications received since the beginning of the COVID-19 pandemic. As we finalise applications that have not been prioritised due to travel restrictions, published processing times may increase.

The Department is processing some new and older applications at the same time to minimise processing times for as many applications as possible. Visa applications that contain all required information may be finalised faster than the published processing times.

Recent developments in the Working Holiday Maker (WHM) visa program (from 1 July 2020 to 31 December 2021)

- From 5 March 2022, eligible current and former WHMs in Australia will be able to apply for a WHM visa with nil VAC. This will provide another opportunity to meet the specified work requirements for a subsequent WHM visa.
- On 17 December 2021, a Free Trade Agreement (FTA) was signed 'virtually' between Australia and the UK. The agreement, which is yet to enter into force, includes new arrangements under Australia's WHM program and the UK's Youth Mobility Scheme. Under the FTA, citizens of both countries will be eligible to apply for a visa up to the age of 35 years. Eligible applicants will have the opportunity to stay in the other country for up to three years, with no requirement to undertake any 'specified work'. These arrangements are expected to be implemented within two years of the FTA entering into force.
- From 15 December 2021, fully vaccinated eligible visa holders, including Working Holiday Makers (subclass 417 and 462 visa holders) can come to Australia without needing to apply for a travel exemption. For more information, see [Vaccinated travellers](#).
- In line with arrangements announced by the Government on 22 November 2021, the Department is prioritising processing of new and existing WHM (subclasses 417 and 462) visa applications.
- From 1 July 2021 to 31 December 2022, holders and former holders of a COVID-19 affected WHM visa are able to make a nil VAC WHM application online. WHMs who are offshore and who were unable to come to Australia or had to leave early because of COVID-19 are able to apply for a replacement visa with nil VAC.
- From 22 June 2021, work undertaken in the tourism and hospitality sectors in northern, remote or very remote Australia can also be counted as specified work towards eligibility for a second or third WHM visa. This option will be available for WHM applications lodged from March 2022.
- From 8 May 2021, WHMs working in the tourism and hospitality sectors anywhere in Australia may now work for up to 12 months with the same employer or organisation without requesting permission.
- From 14 November 2020, former WHMs who transitioned to a COVID-19 Pandemic event visa to continue undertaking critical COVID-19 work in the healthcare and medical sectors could count this work as specified work towards eligibility for a second or third WHM visa. These arrangements recognise the contribution of WHMs doing critical COVID-19 work in the healthcare and medical sectors and ensure they can still access subsequent WHM visa options.
- From 19 August 2020, WHMs could count critical COVID-19 work in the healthcare and medical sectors undertaken anywhere in Australia after 31 January 2020 as specified work to apply for a second or third WHM visa.
- WHMs employed in critical sectors who were not eligible for a second or third WHM visa continue to be able to apply for a COVID-19 Pandemic event visa to continue their critical work in Australia.

Executive Summary

Key Points

The decrease in WHM program lodgements and grants in the period 1 July 2021 to 31 December 2021 can be attributed to the COVID-19 pandemic. The longer-term decline in demand for WHM visas observed over several years prior to the pandemic may have been influenced by changing currency exchange rates and economic and labour market conditions in partner countries and Australia.

- In six months from 1 July 2021 to 31 December 2021 compared with the same period in 2020, there was:
 - a total of 22,721 Working Holiday Maker (WHM) (subclass 417 and subclass 462) visas granted, a 8.5 per cent increase from 20,939;
 - an increase in first Working Holiday (subclass 417) visa grants from 348 to 14,945 a 4,194 per cent increase;
 - a 95.7 per cent decrease in second Working Holiday (subclass 417) visa grants from 12,035 to 514;
 - an increase in first Work and Holiday (subclass 462) visa grants from 83 to 1,726 a 1,979 per cent increase;
 - a 95.9 per cent decrease in second Work and Holiday (subclass 462) visa grants from 3,594 to 149; and
 - 3,429 third Working Holiday (subclass 417) and 1,142 third Work and Holiday (subclass 462) visas granted in this period.
- There was a 61 per cent decrease of WHM visa holders in Australia from 49,542 at 31 December 2020 to 19,324 at 31 December 2021.

1 Applications lodged for WHM program

In the six months to 31 December 2021, 23,424 visa applications were lodged for total WHM program, 22.7 per cent decrease compared to 30,294 in the same period in 2020.

For Working Holiday (subclass 417), first visa applications increased by 301 per cent to (11,570) and second visa applications decreased by 95.9 per cent to 633.

For Work and Holiday (subclass 462), first visa applications increased by 100.8 per cent to 3,445 and second visa applications decreased by 95.7 per cent to 177

2 Visas granted

Working Holiday (subclass 417) visa program

A combined total of 18,888 first, second and third Working Holiday visas were granted in the six months to December 2021, a 15 per cent increase compared to 16,425 in the same period in 2020.

First Working Holiday (subclass 417) visa program

A total of 14,945 first Working Holiday visas were granted in the six months to December 2021, compared to 348 in the same period in 2020.

Second Working Holiday (subclass 417) visa program

A total of 22,541 second Working Holiday visas were granted in the six months to December 2021.

This is a 95.7 per cent increase compared to 12,035 in the same period in 2020.

The top five countries or regions for second Working Holiday visa grants were:

- United Kingdom (118)
- Italy (82)
- Germany (66)
- Ireland (60)
- France (55)

In the six months to 31 December 2021, 78.4 per cent of those granted a second Working Holiday visa nominated agriculture as the industry in which they had undertaken "specified work" in order to acquire eligibility. A further 7.8 per cent nominated construction, 2.3 per cent mining.

Third Working Holiday (subclass 417) visa program

A total of 3,429 third Working Holiday visas were

granted in the six months to 31 December 2021.

The top five countries or regions for third Working Holiday visa grants were:

- Taiwan (720)
- United Kingdom (682)
- Ireland (400)
- France (338)
- South Korea (279)

In the six months to 31 December 2021, 72.8 per cent of those granted a third Working Holiday visa nominated agriculture as the industry in which they had undertaken “specified work” in order to acquire eligibility. A further 12.9 per cent nominated construction, and 4.5 per cent mining.

A combined total of 3,833 first, second and third Work and Holiday visas were granted in the six months to 31 December 2021, a 15.1 per cent decrease compared to 4,514 in the same period in 2020.

A total of 1,726 first Work and Holiday visas were granted in the six months to 31 December 2021, compared to 83 in the same period in 2020.

A total of 149 second Work and Holiday visas were granted in the six months to 31 December 2021, compared to 3,594 in the same period in 2020.

The top five countries for second Work and Holiday visa grants were:

In the six months to 31 December 2021, 53.7 per cent of those granted a second Work and Holiday visa nominated hospitality as the industry in which they had undertaken “specified work” in order to acquire eligibility. A further 41.6 per cent nominated agriculture.

A total of 1,142 third Work and Holiday visas were

granted in the six months to 31 December 2021.

The top five countries for third Work and Holiday visa grants were:

- Argentina (184)
- China (180)
- Chile (175)

In the six months to 31 December 2021, 46.7 per cent of those granted a third Work and Holiday visa nominated agriculture as the industry in which they had undertaken “specified work” in order to acquire eligibility. A further 44.3 per cent nominated hospitality, and 6.5 per cent construction.

3 Grant rates

The grant rate for first Working Holiday visas in the six months to 31 December 2021, was 99.7 per cent. The grant rate for second Working Holiday visas was 81.7 per cent. The grant rate for third Working Holiday visas was 97.6 per cent.

The grant rate for first Work and Holiday visas was 99.3 per cent. The grant rate for second Work and Holiday visas was 88.2 per cent. The grant rate for third Work and Holiday visas was 97.7 per cent.

The generally high grant rates for WHM visas are indicative of the low risk nature of this caseload. The large proportion of online applications for this caseload also contributes to the high grant rate. A number of automated eligibility checks occur during online applications, alerting clients early in the process if they do not meet visa requirements.

As at 31 December 2021, there were 15,096 first, second and third Working Holiday visa holders in Australia. This is a 61.6 per cent reduction compared to 39,309 on 31 December 2020.

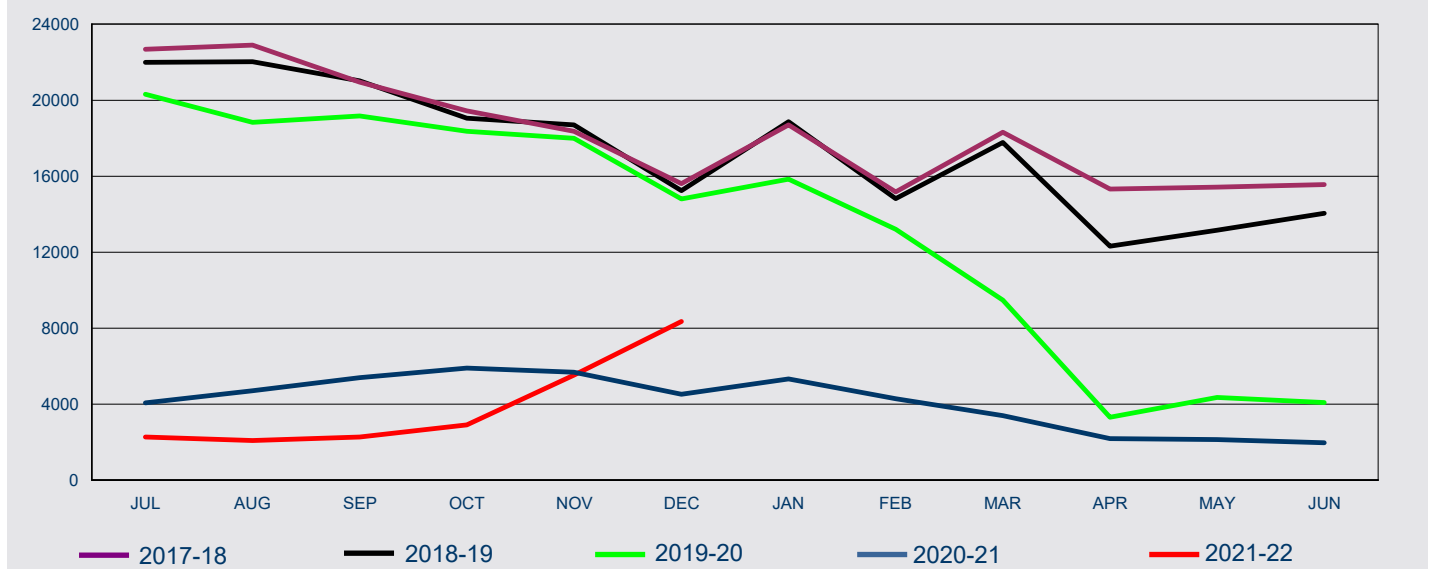

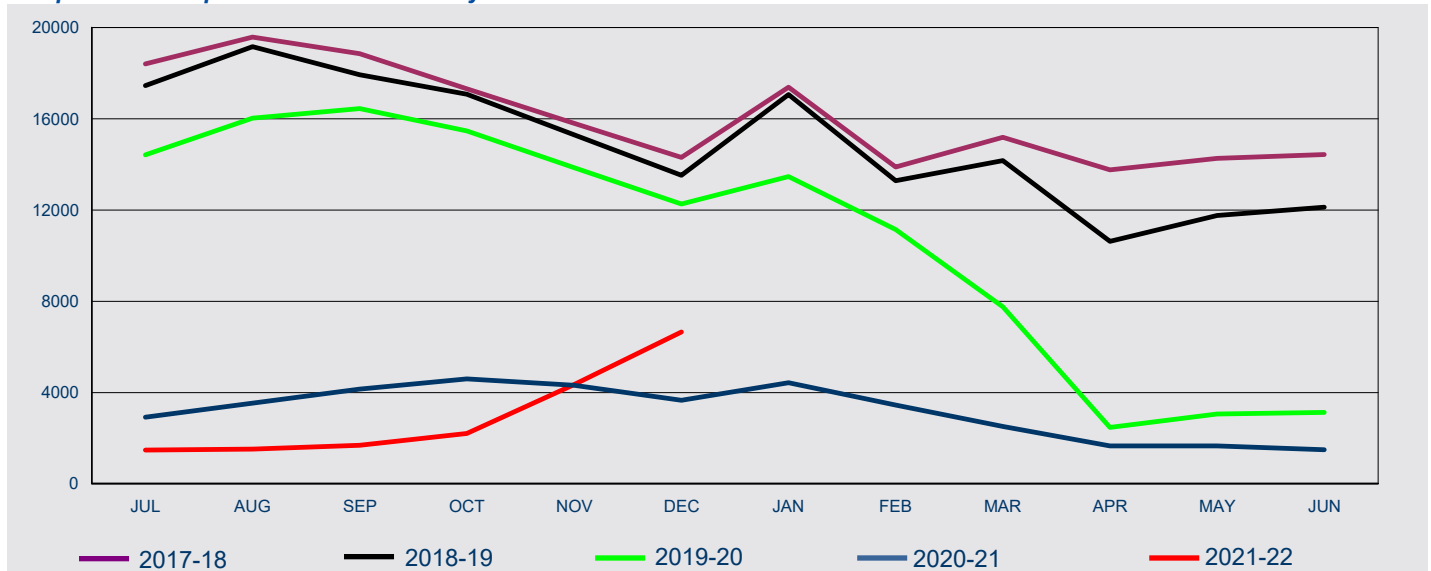

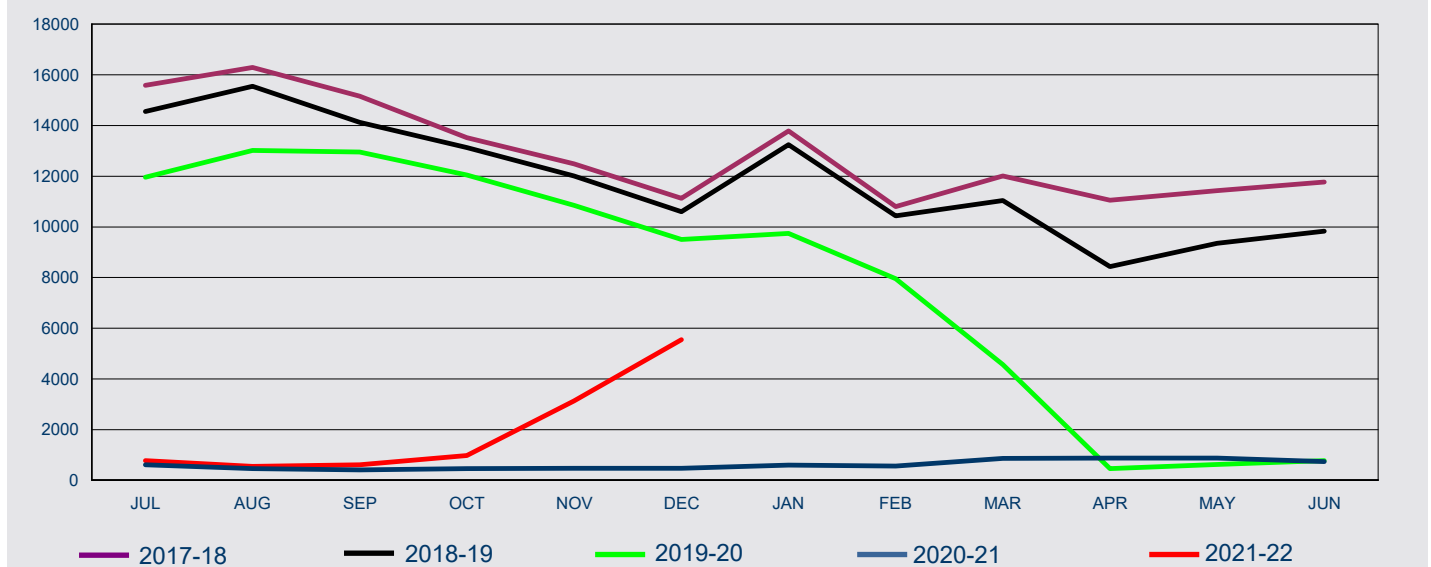
1.02 Total number of Working Holiday (subclass 417) visa applications lodged in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

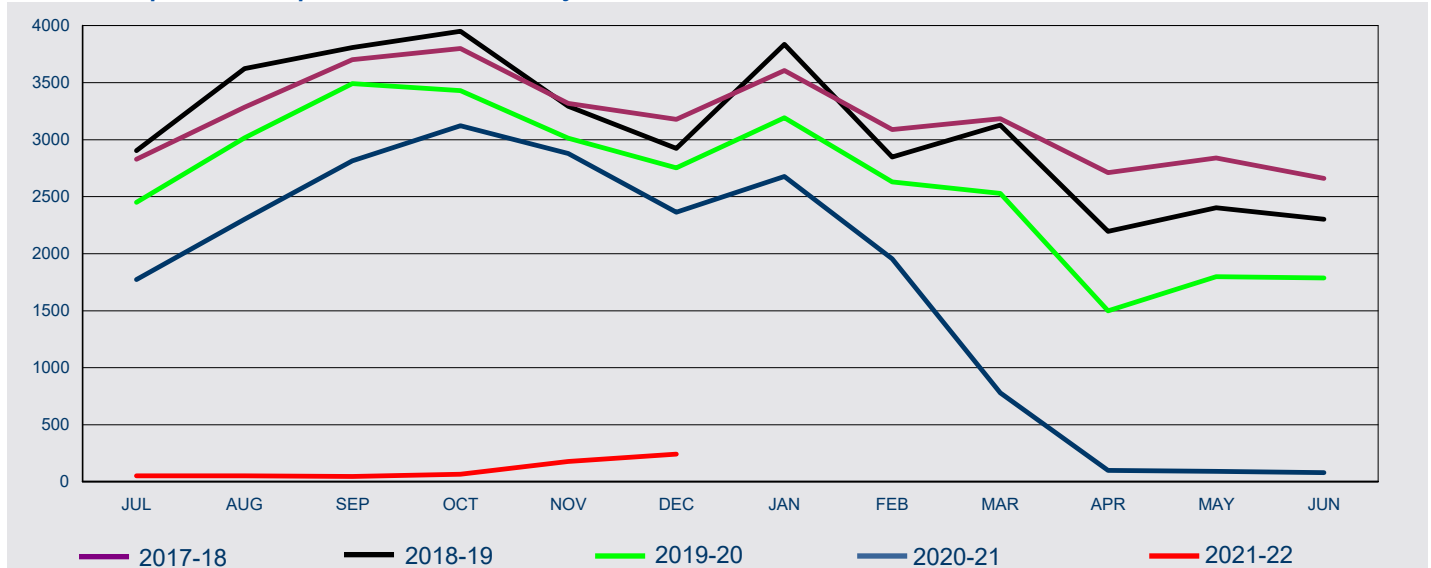

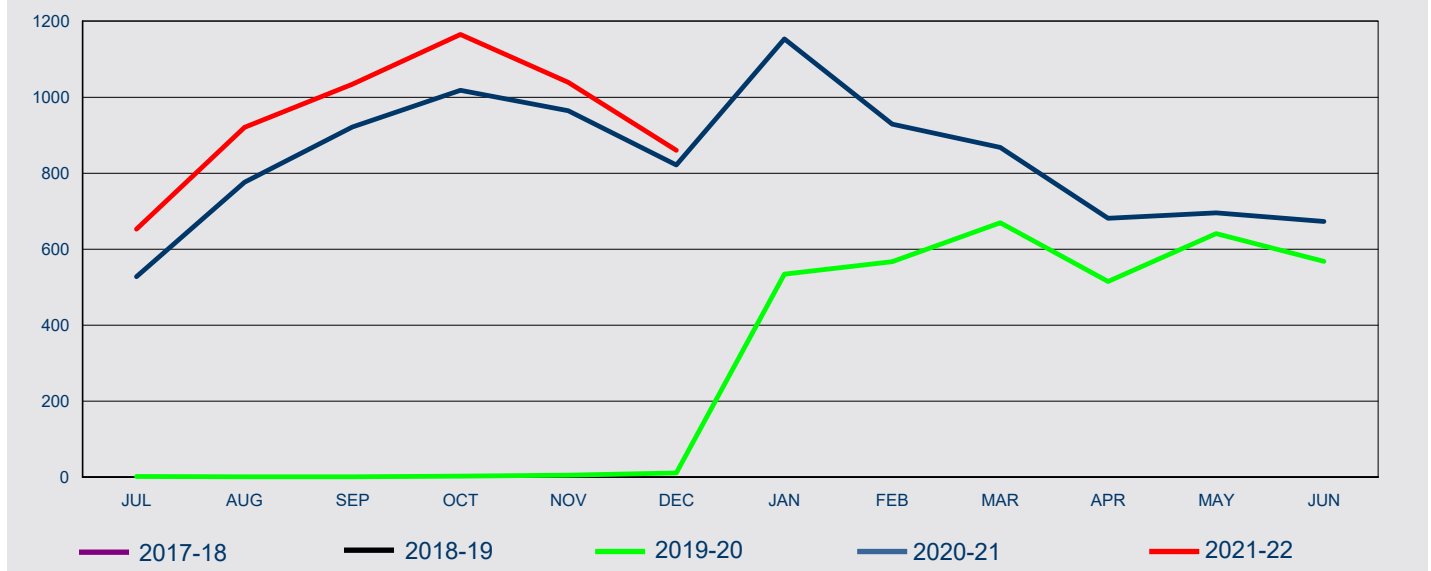
1.04 Number of second Working Holiday (subclass 417) visa applications lodged in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

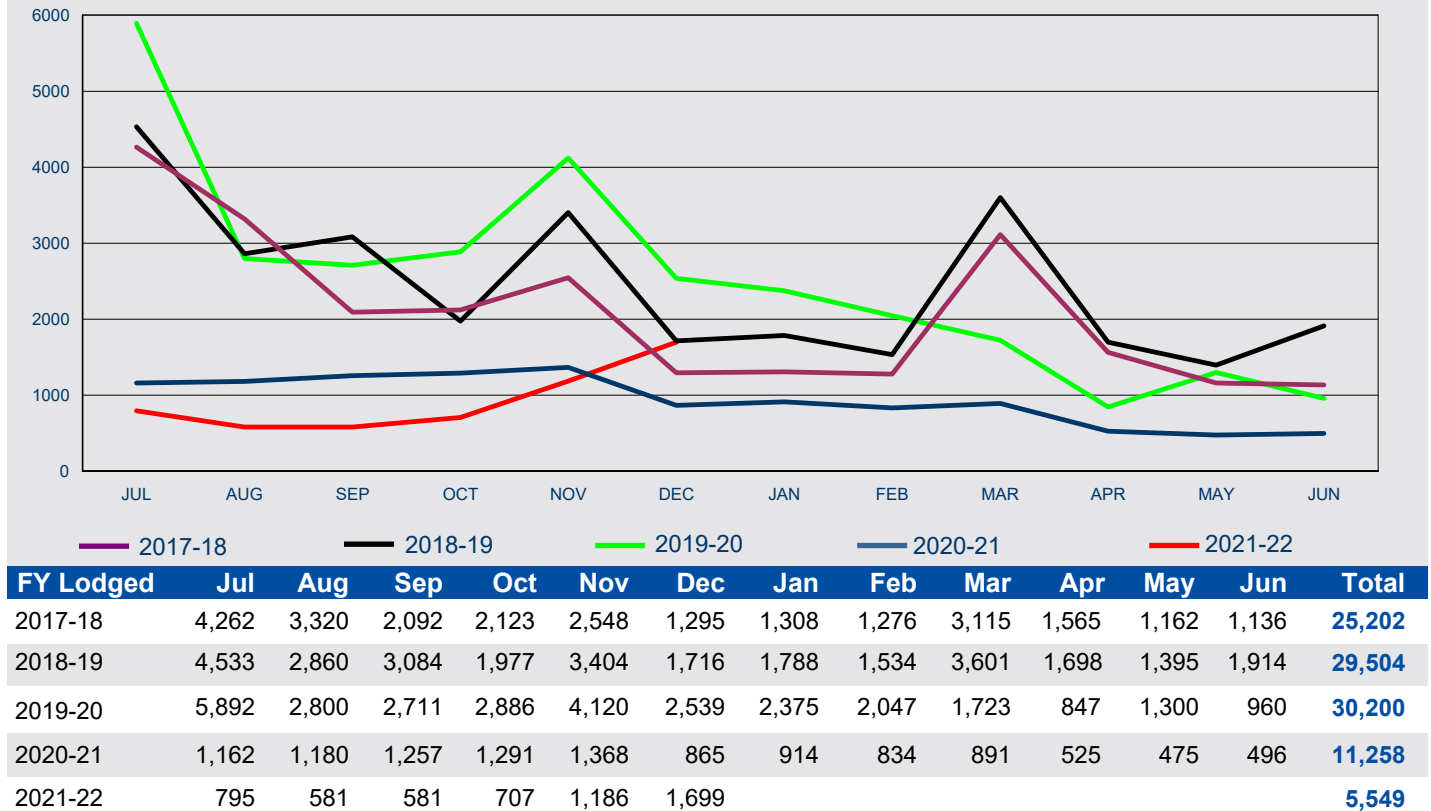
1.05 Number of third Working Holiday (subclass 417) visa applications lodged in 2021-22 to 31 December 2021 by month - comparison with previous four financial years



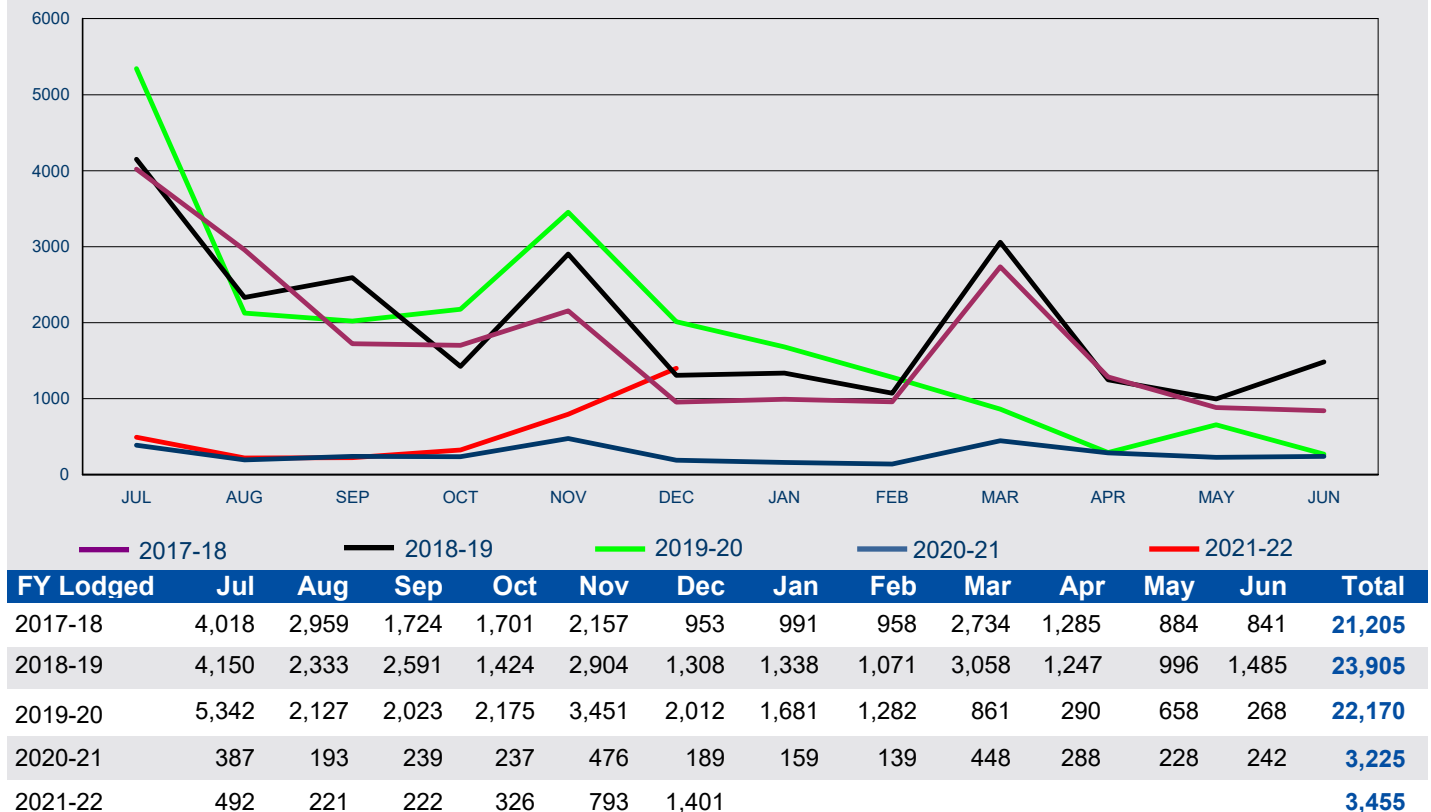

1.06 Total number of Work and Holiday (subclass 462) visa applications lodged in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

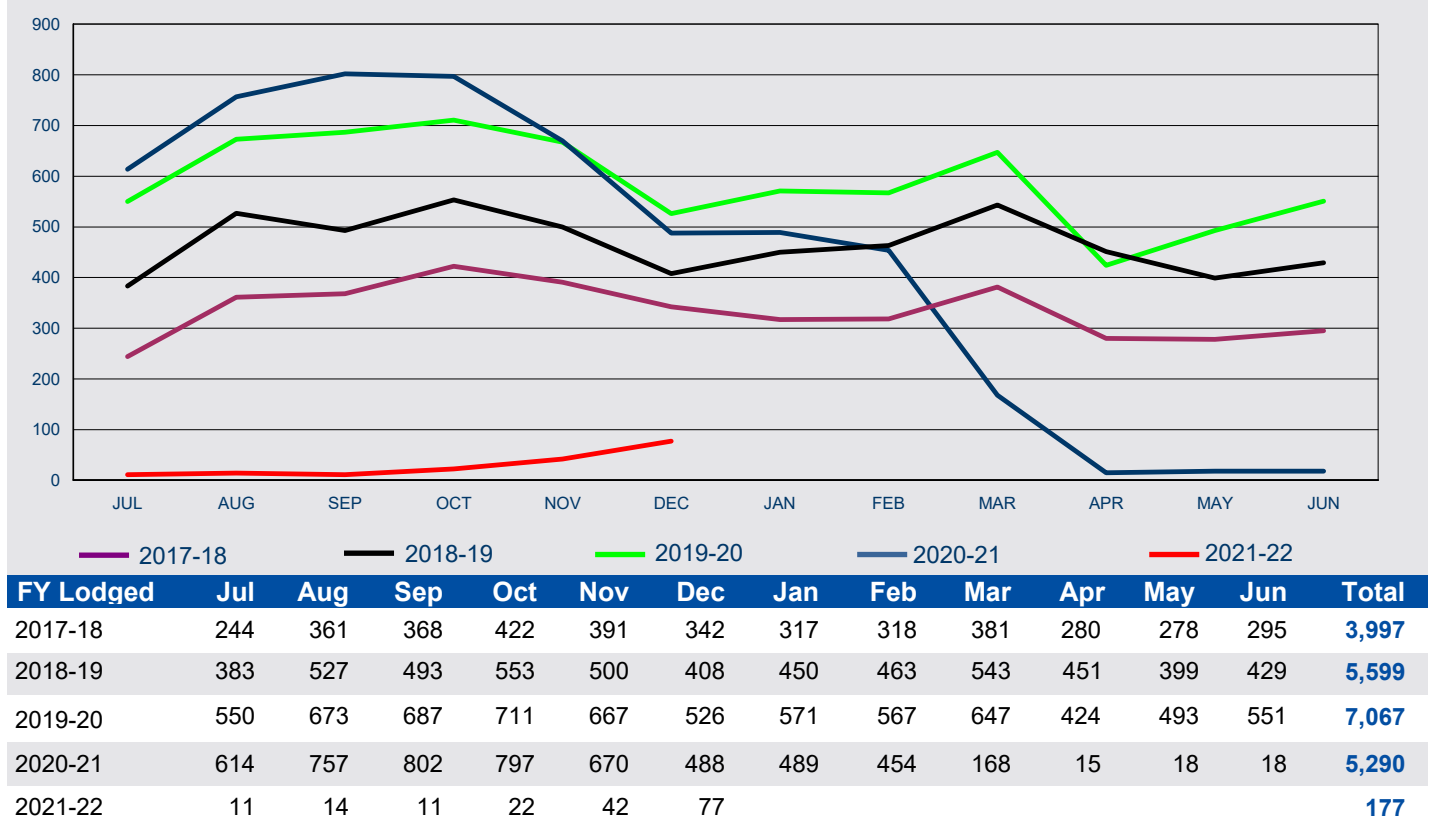


1.07 Number of first Work and Holiday (subclass 462) visa applications lodged in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

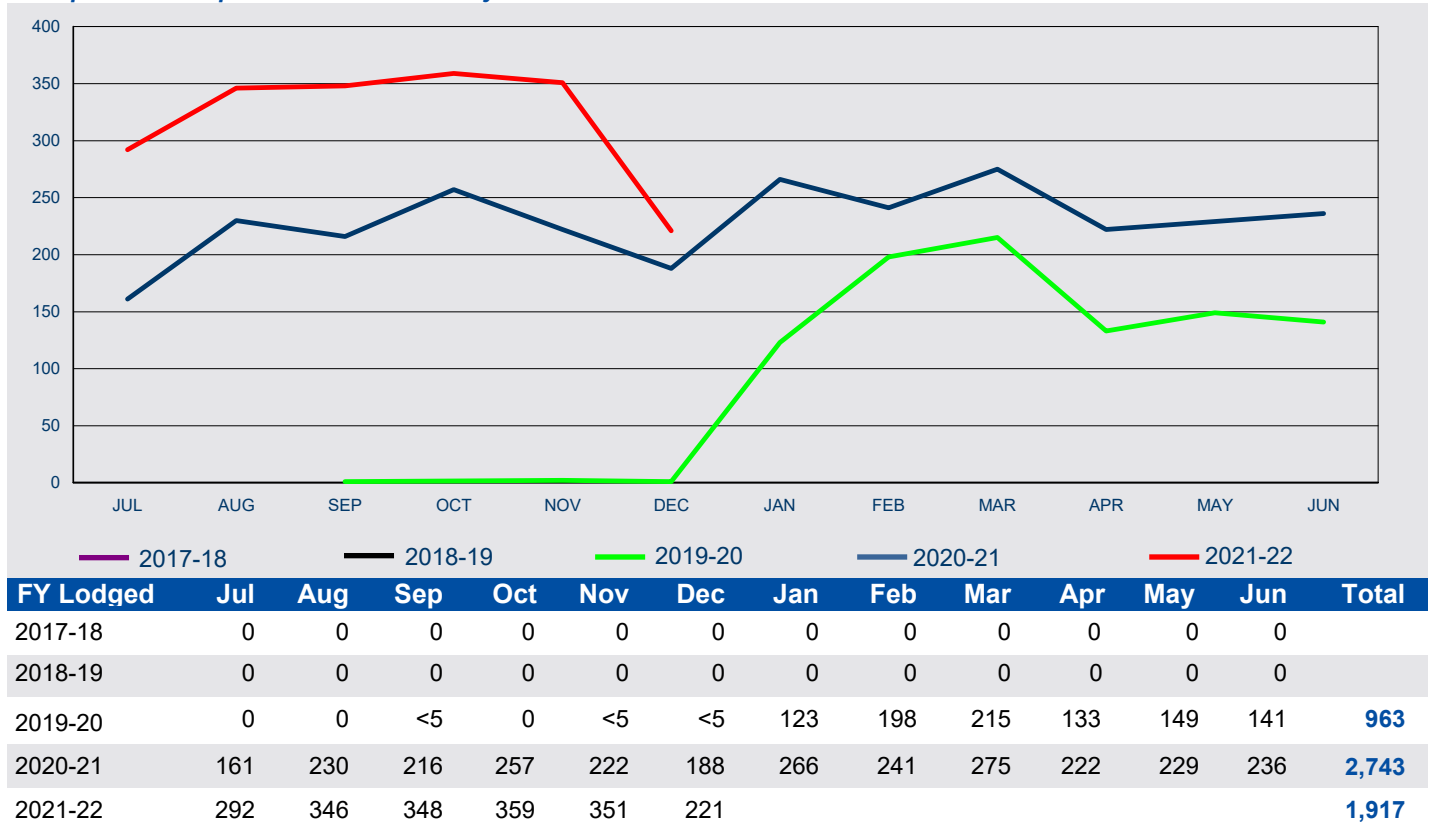

1.09 Number of third Work and Holiday (subclass 462) visa applications lodged in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

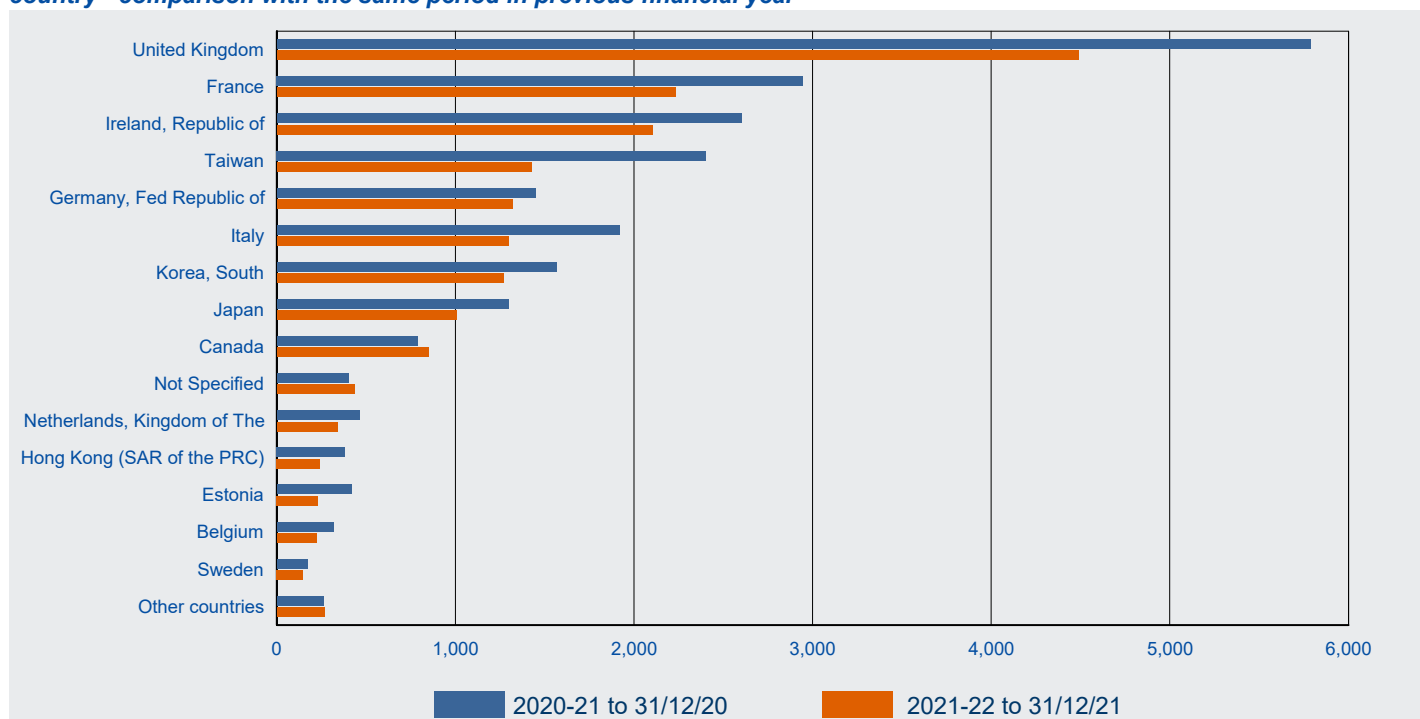

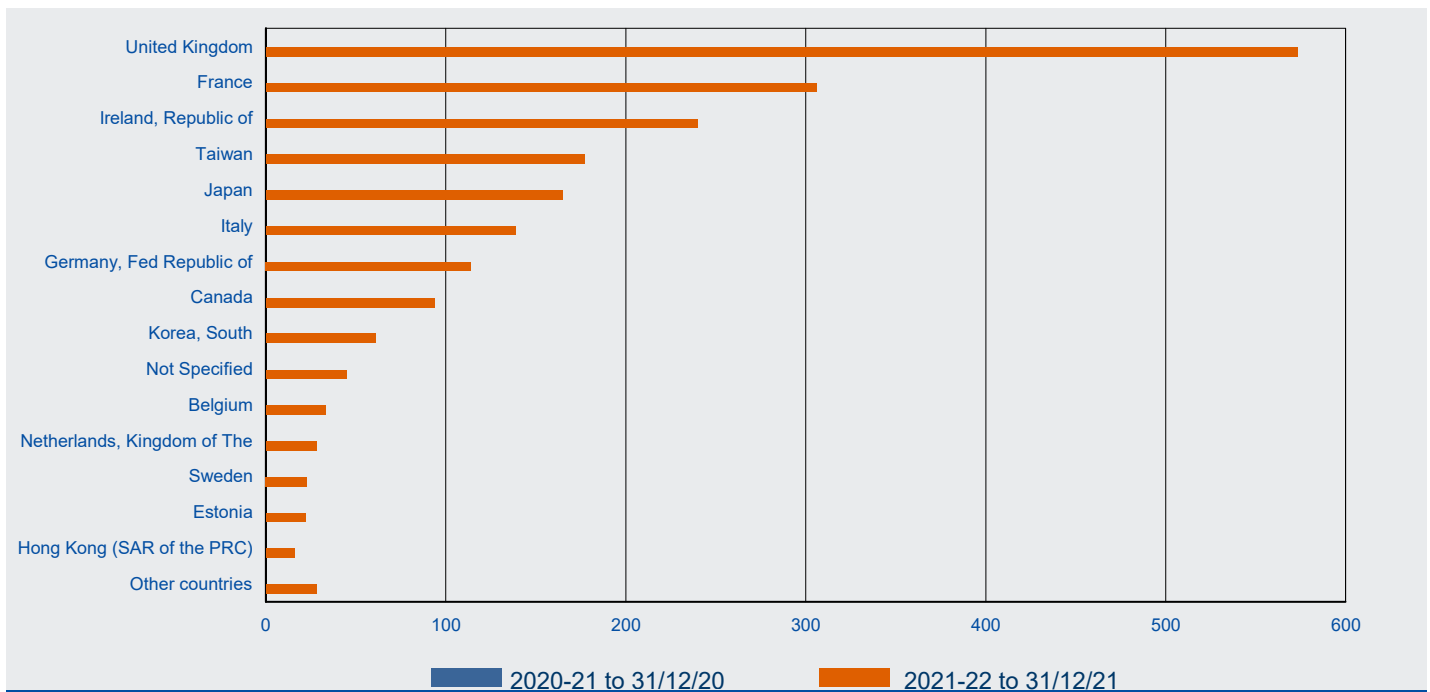

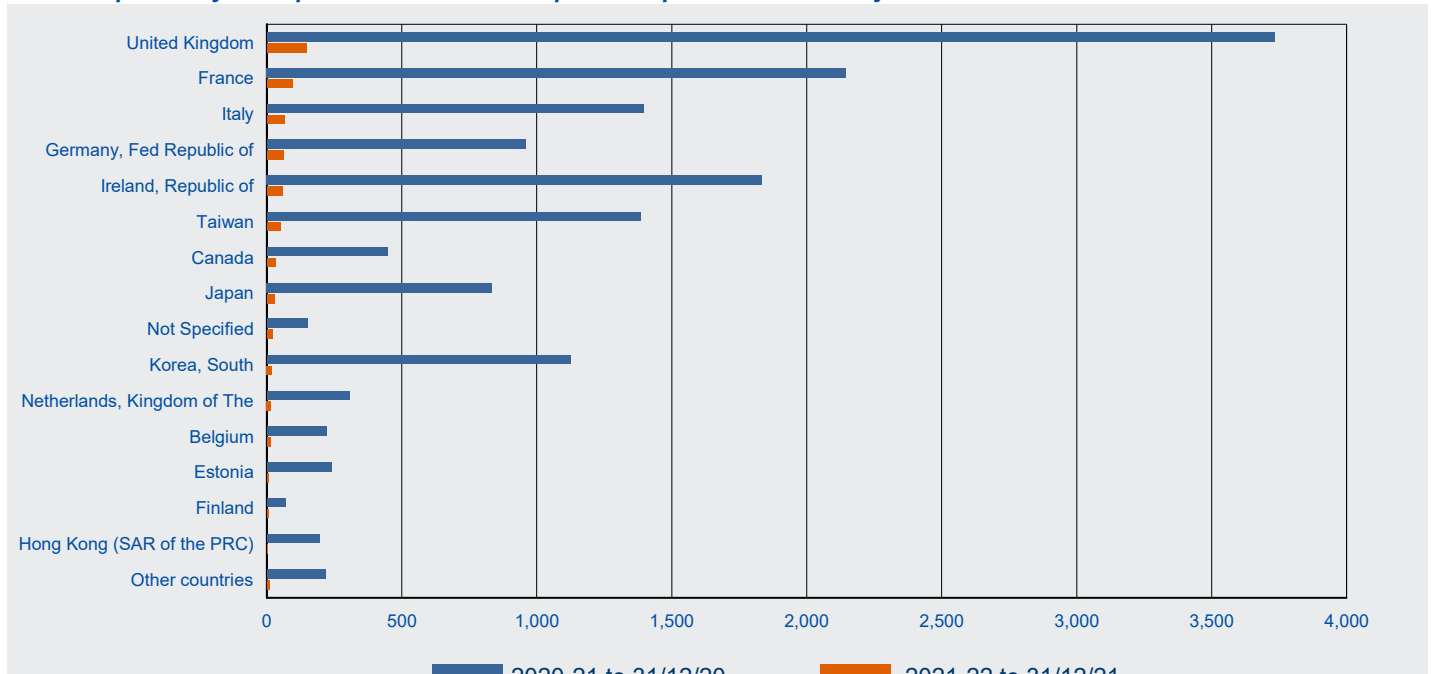

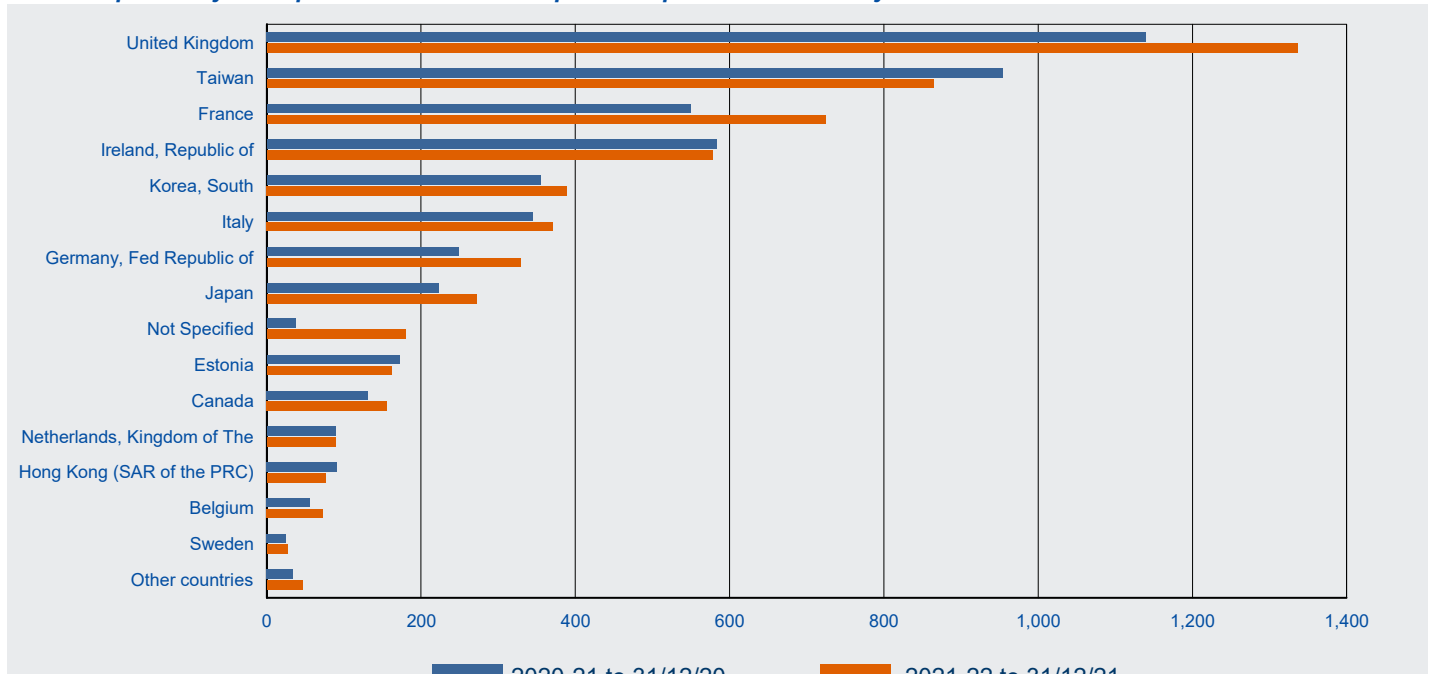

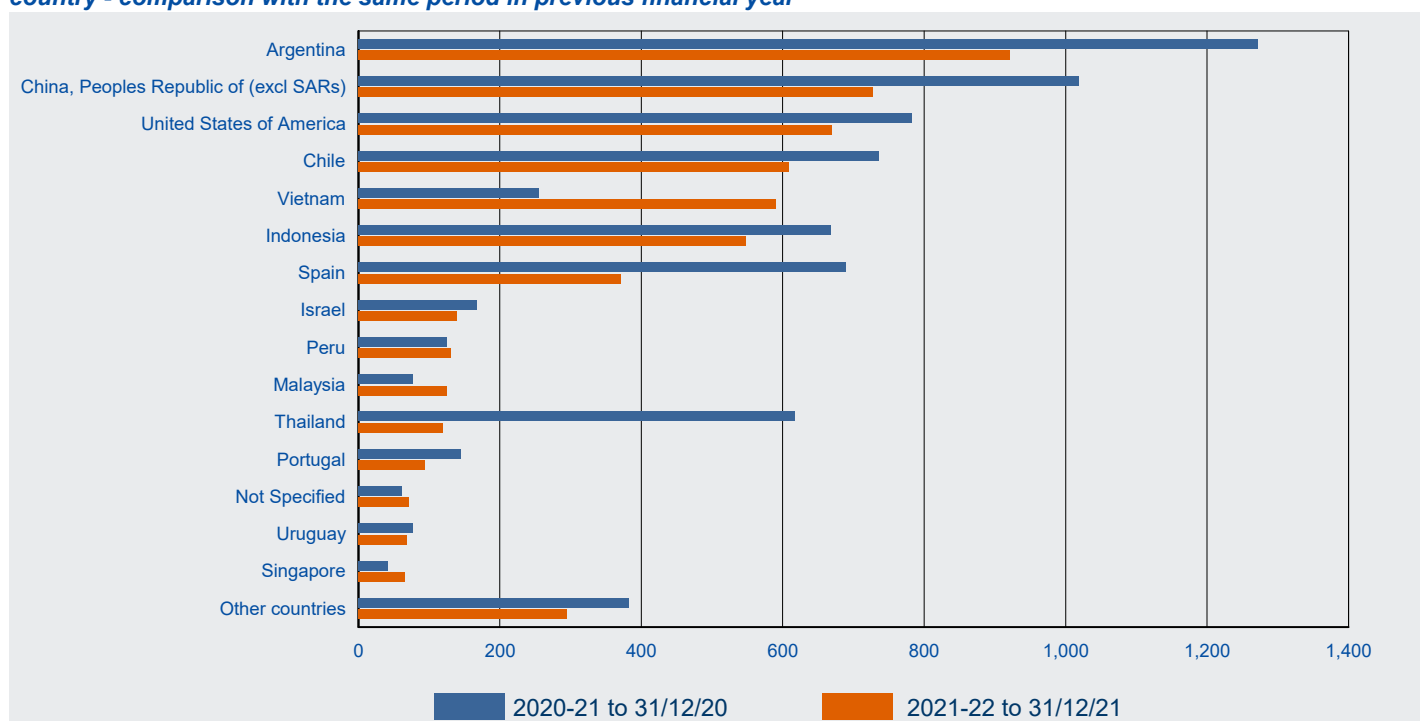

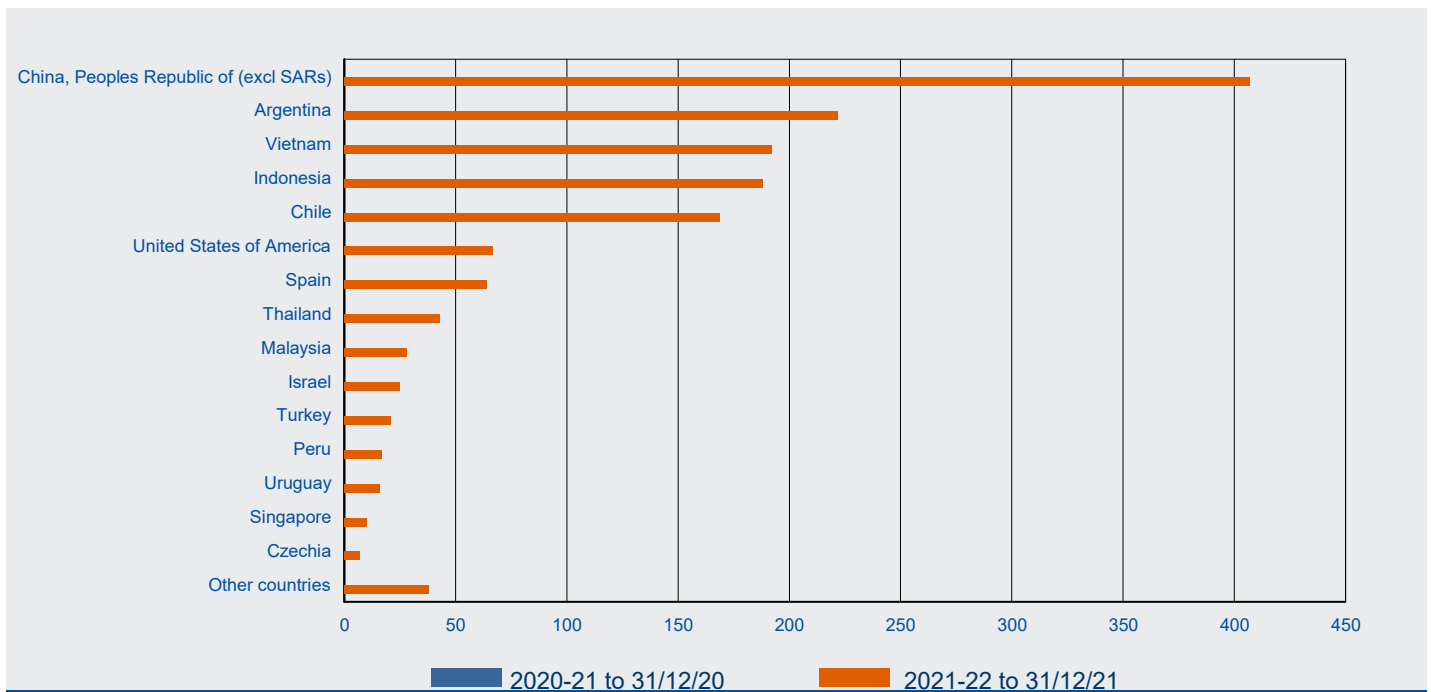

2.01 Total number of Working Holiday Maker visa applications granted in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

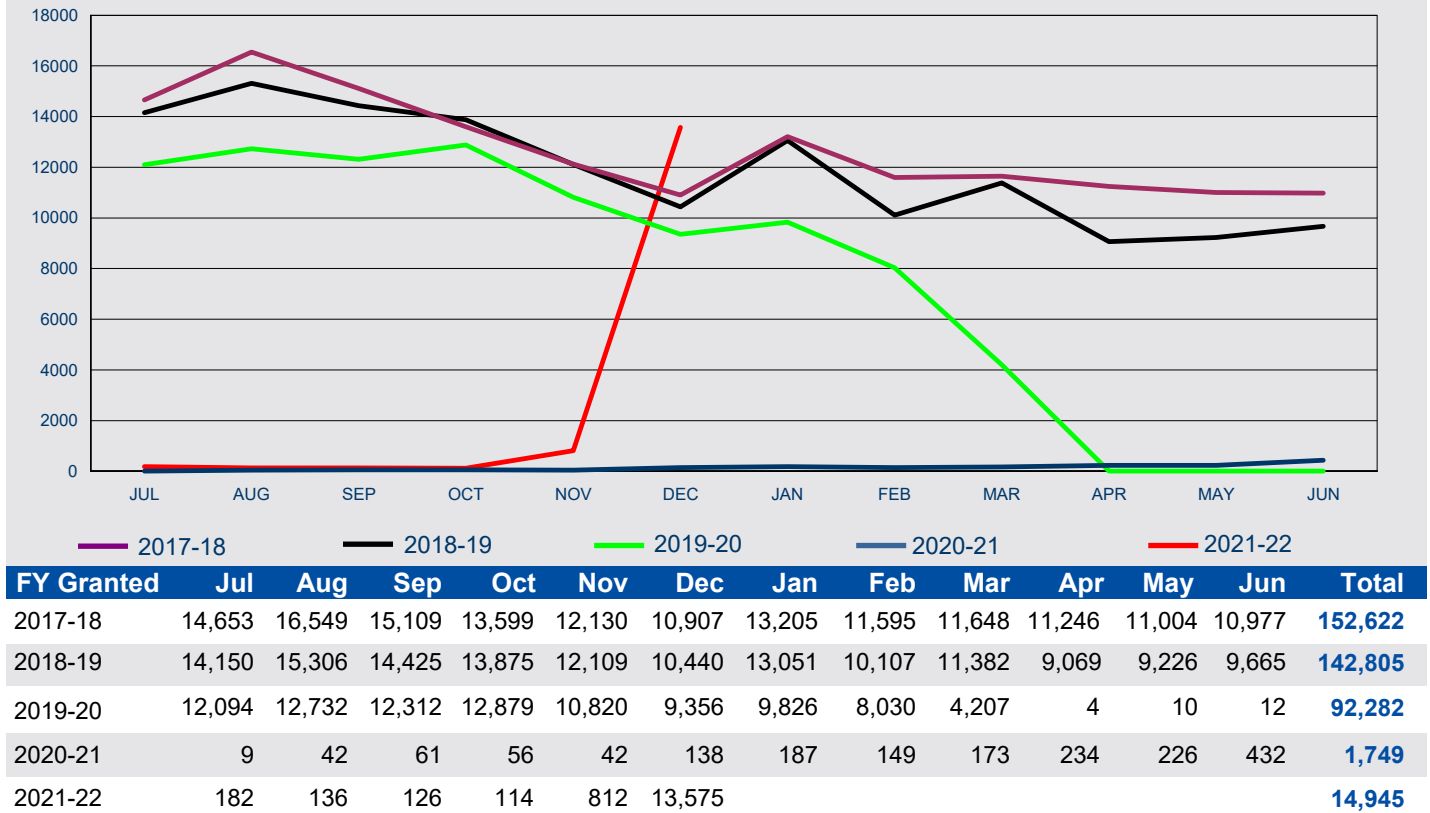


2.02 Total number of Working Holiday (subclass 417) visa applications granted in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

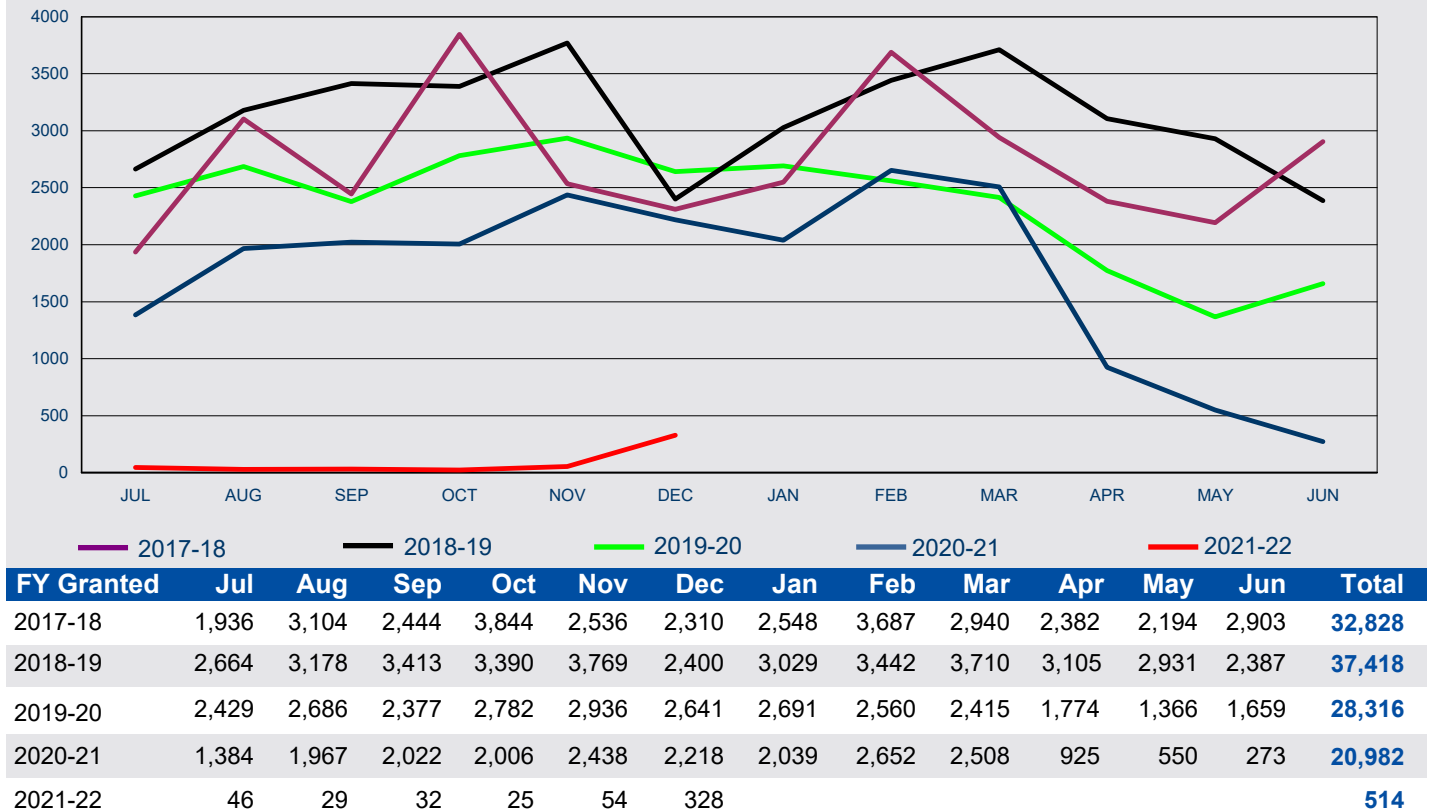

2.03 Number of first Working Holiday (subclass 417) visa applications granted in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

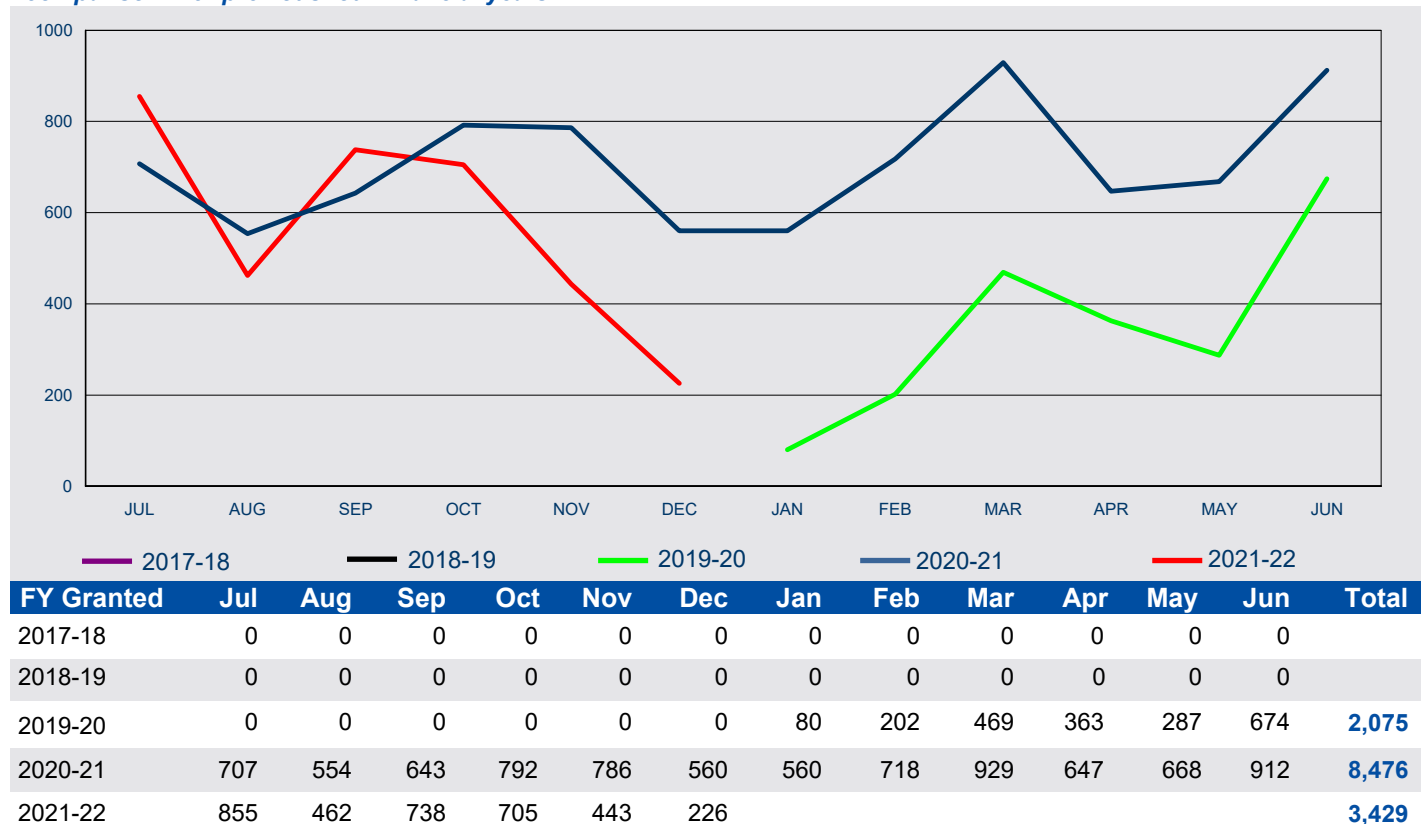


2.04 Number of second Working Holiday (subclass 417) visa applications granted in 2021-22 to 31 December 2021 by month - comparison with previous four financial years



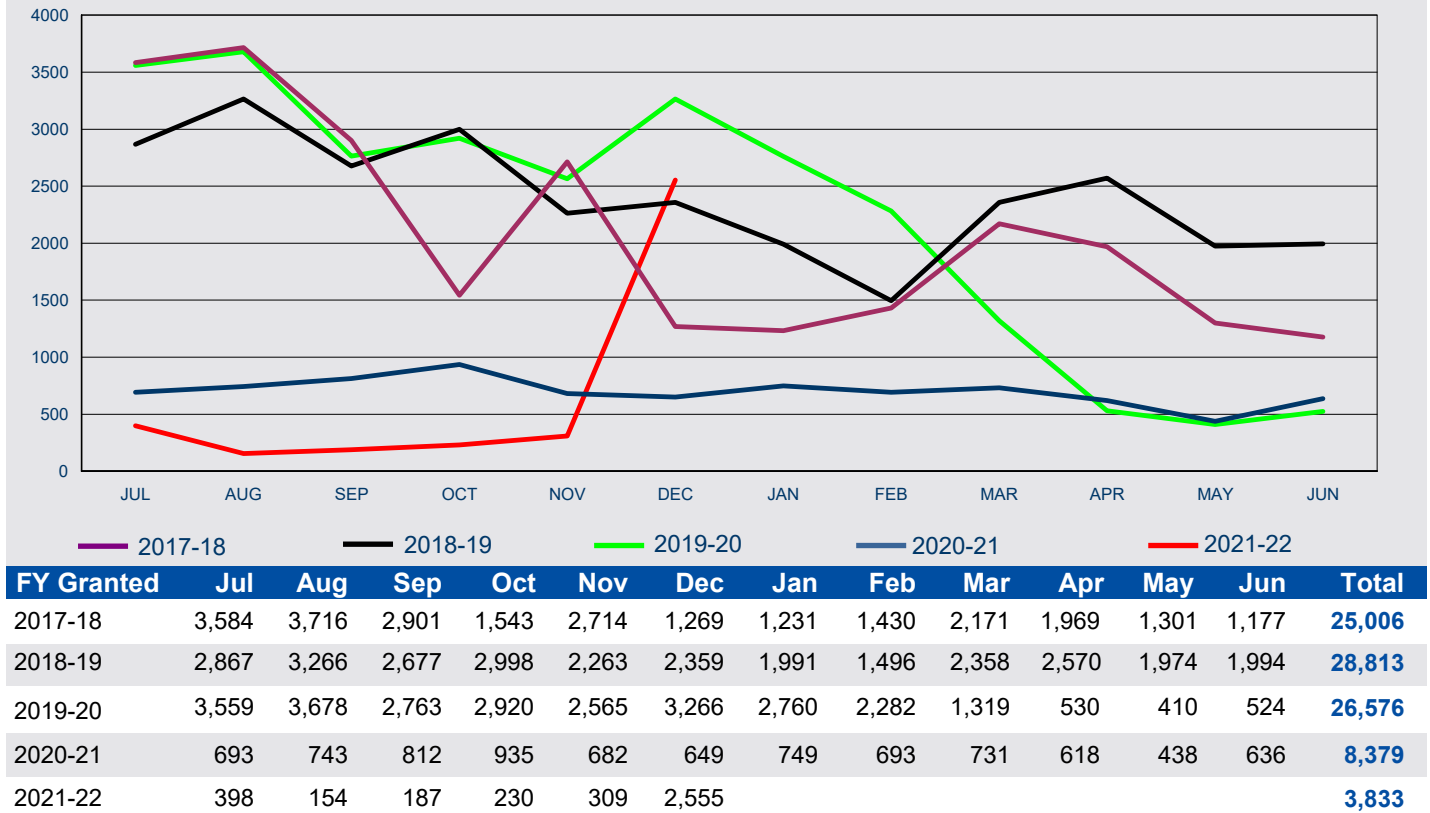

2.05 Number of third Working Holiday (subclass 417) visa applications granted in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

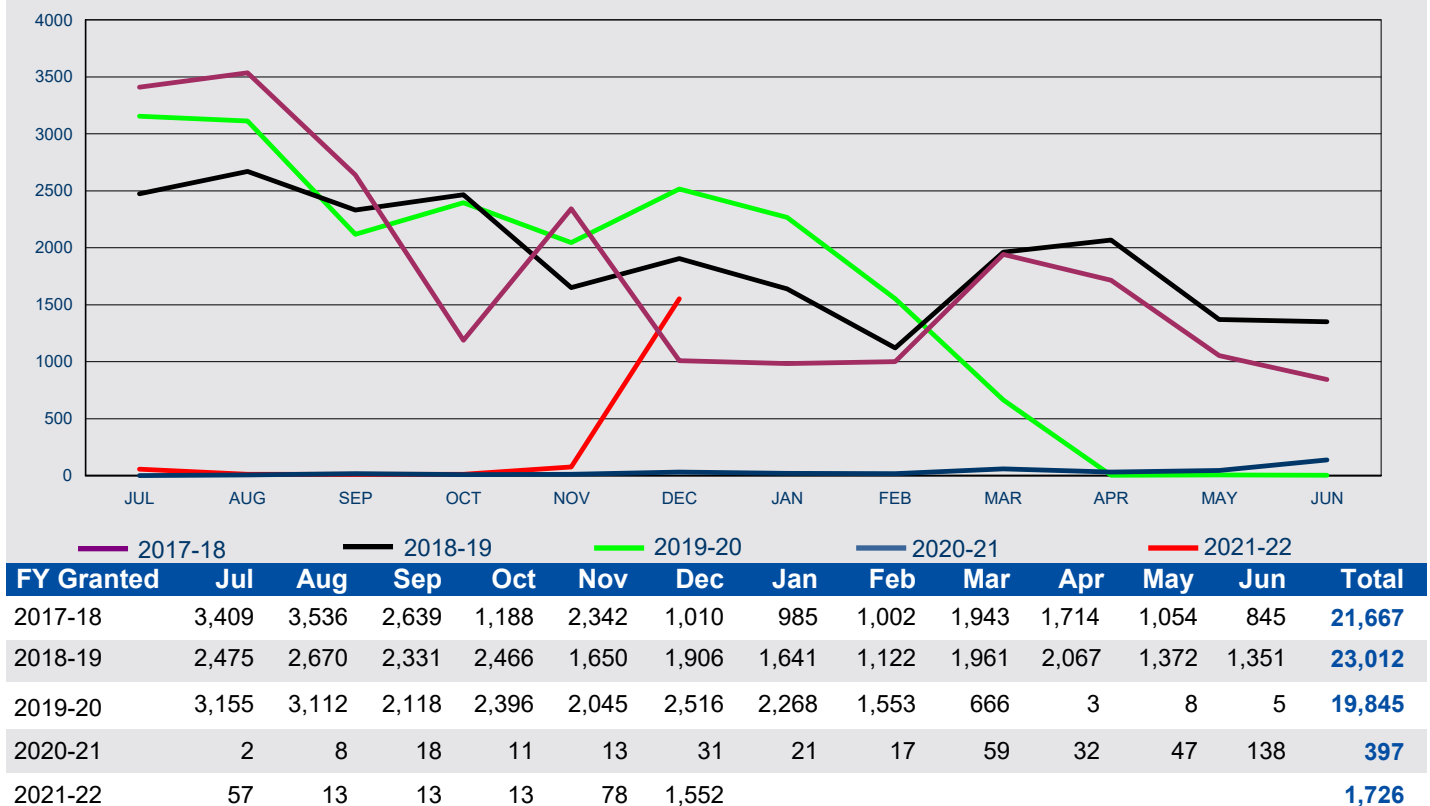

2.06 Total number of Work and Holiday (subclass 462) visa applications granted in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

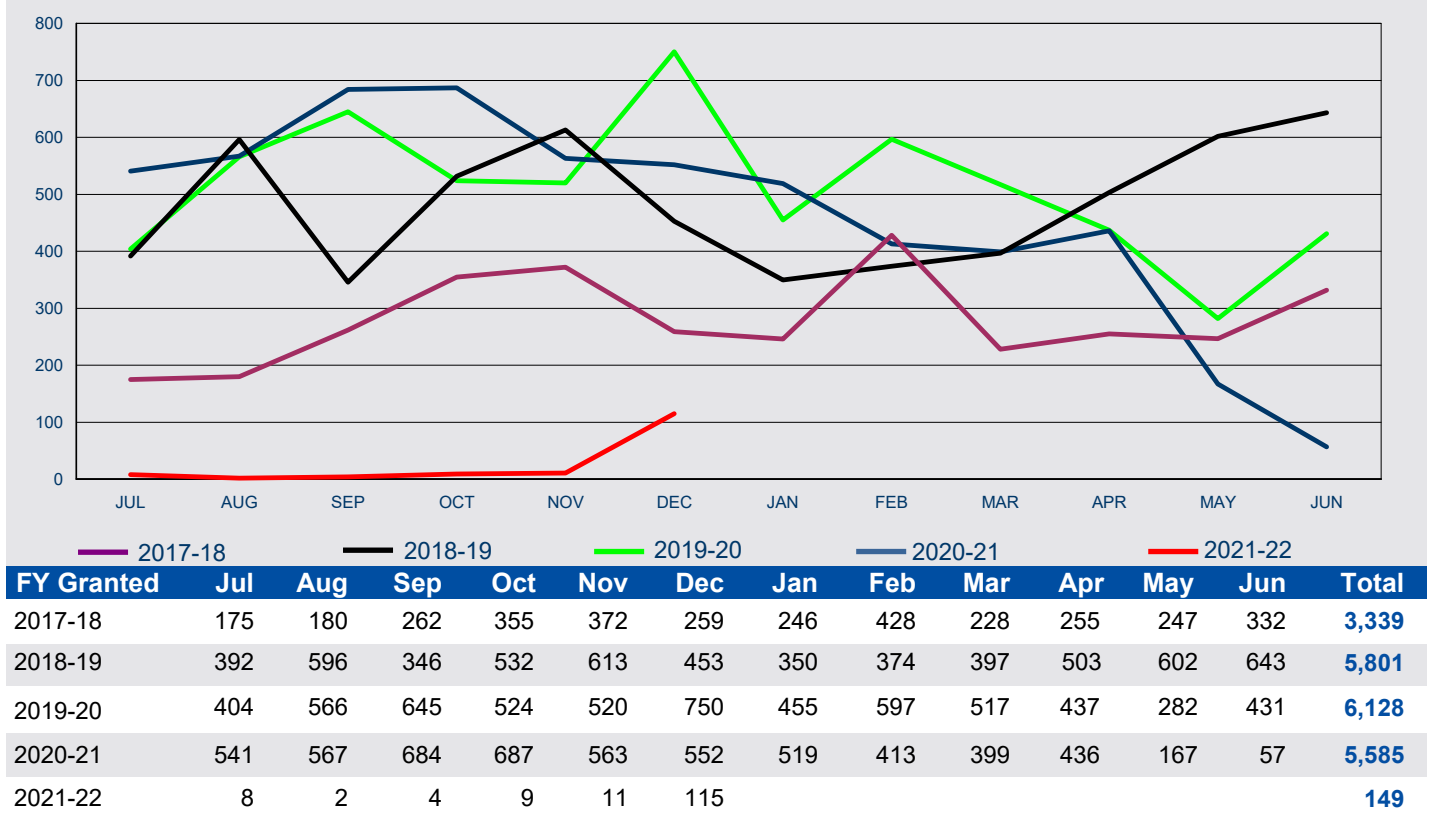


2.07 Number of first Work and Holiday (subclass 462) visa applications granted in 2021-22 to 31 December 2021 by month - comparison with previous four financial years

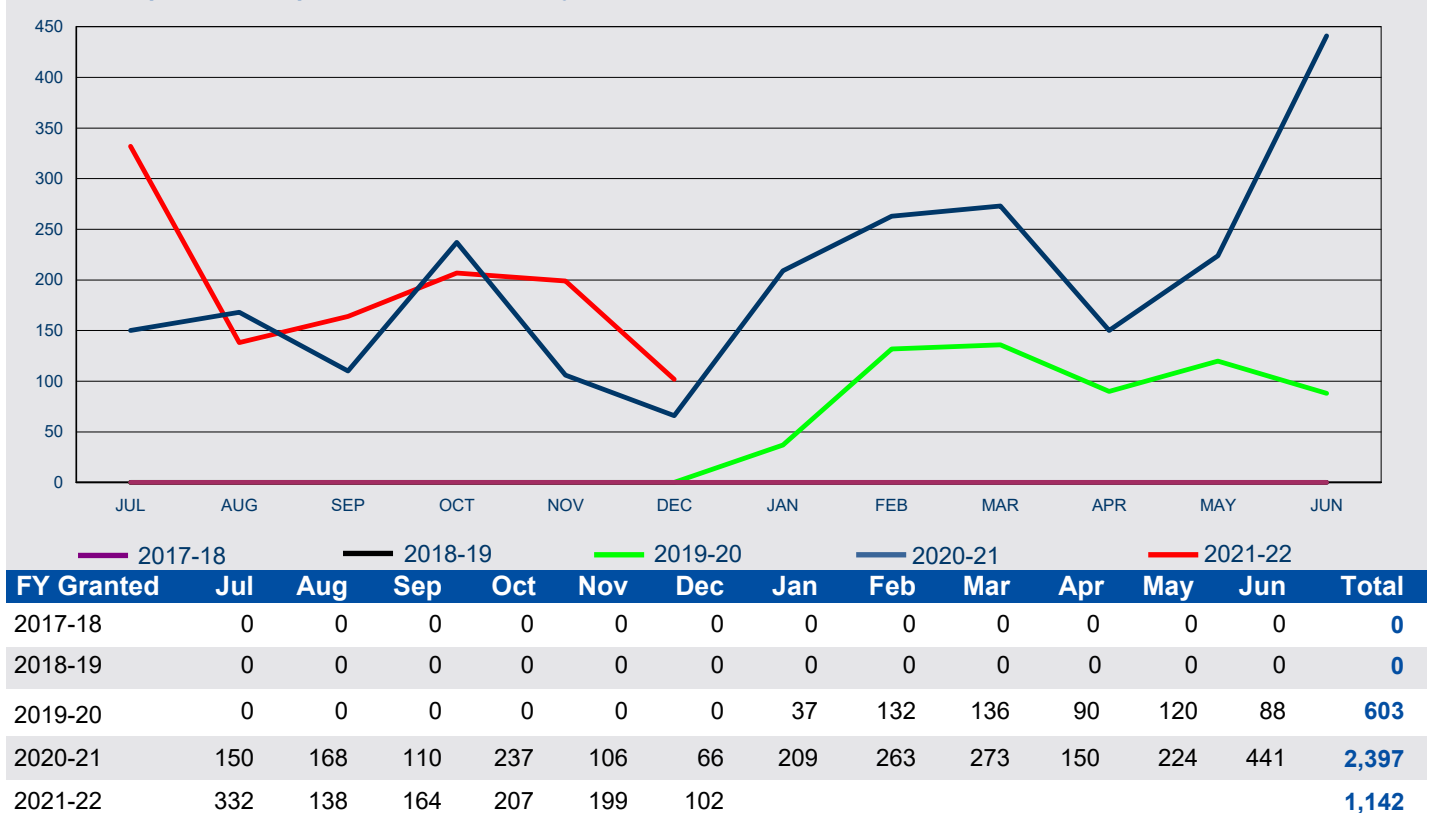

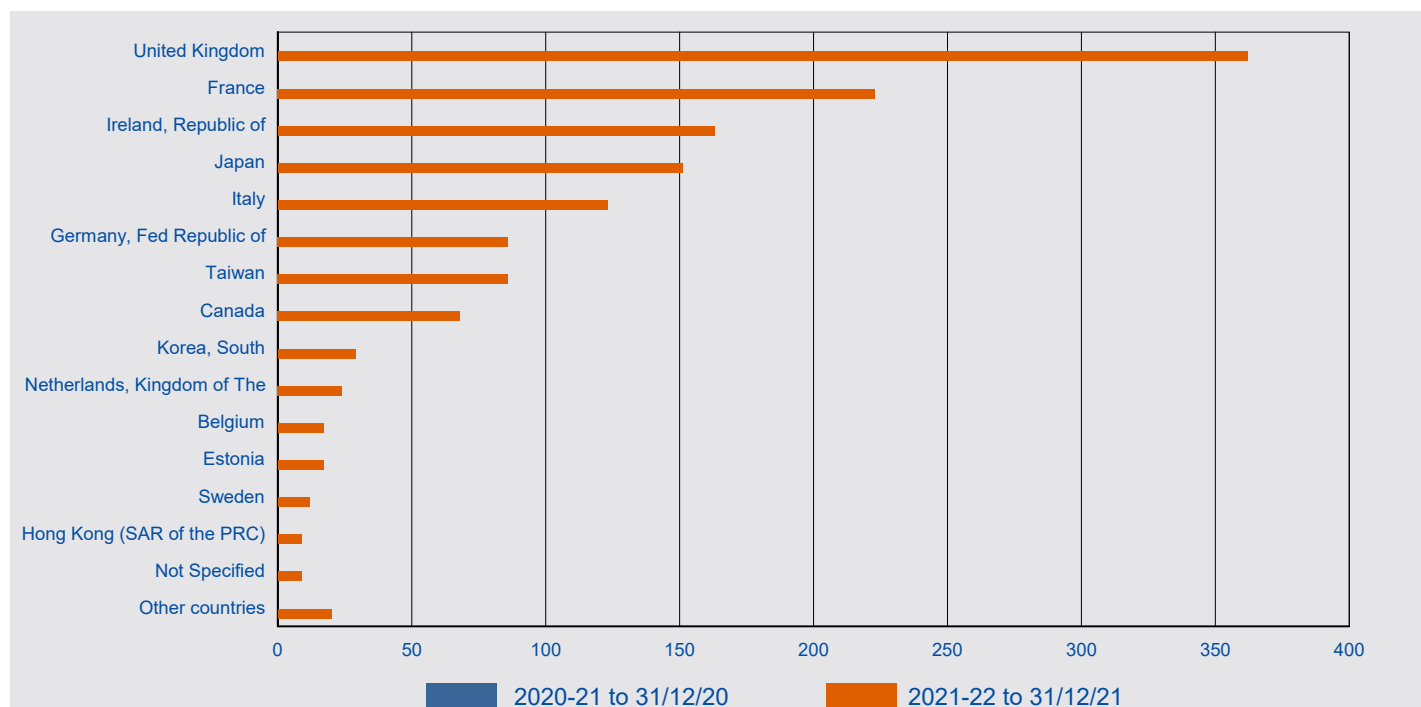

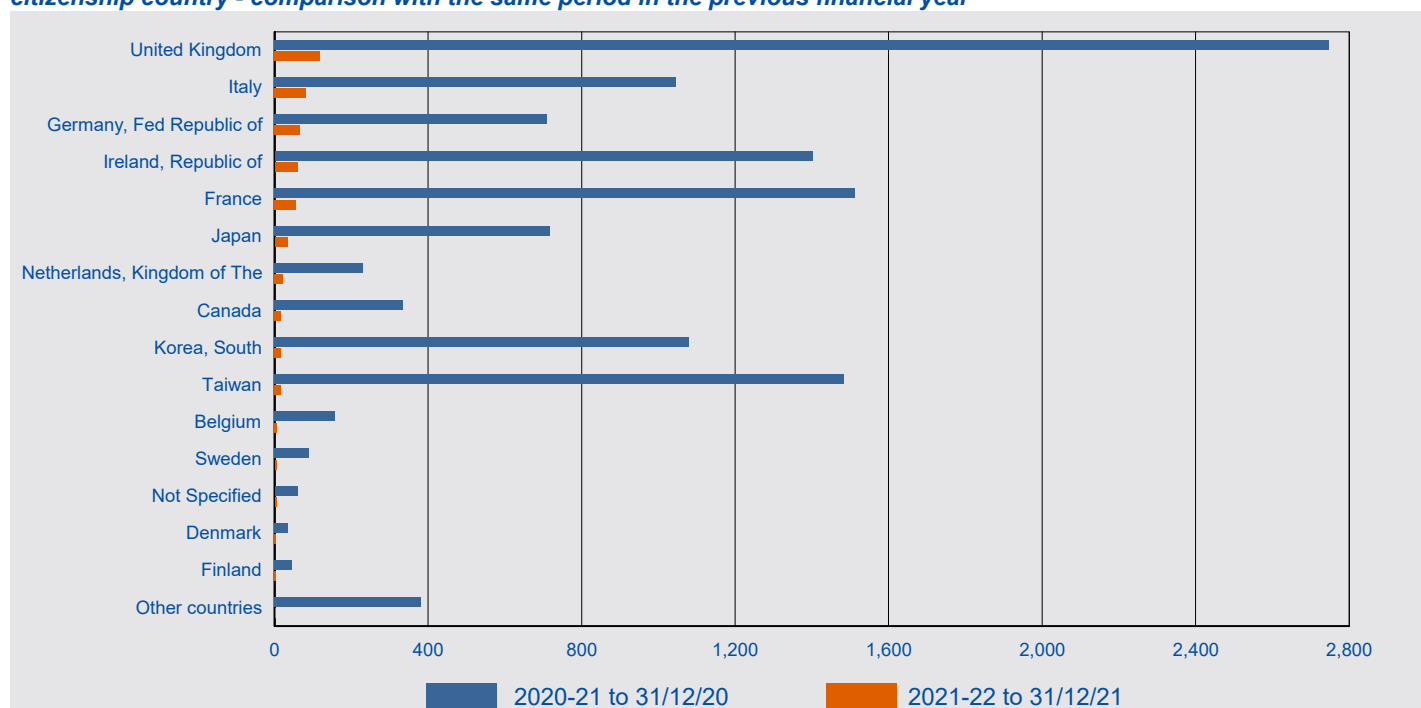

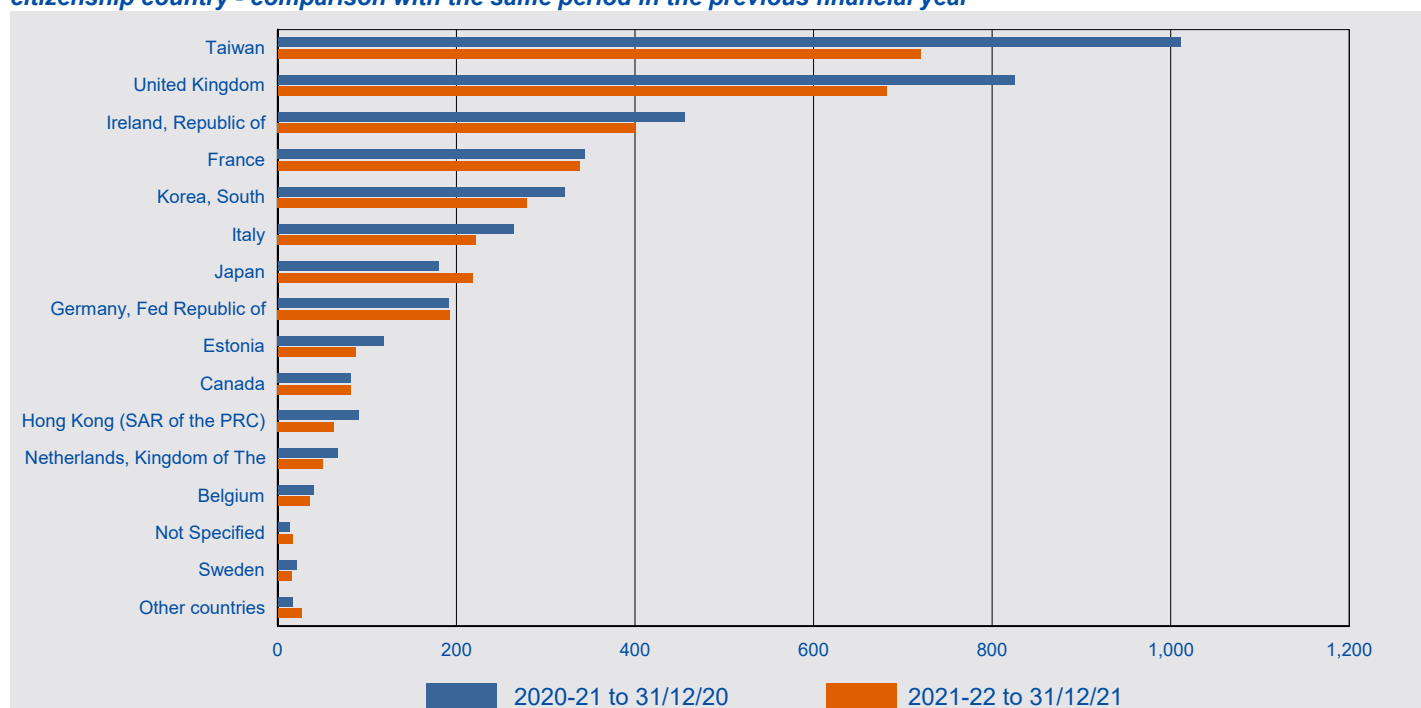

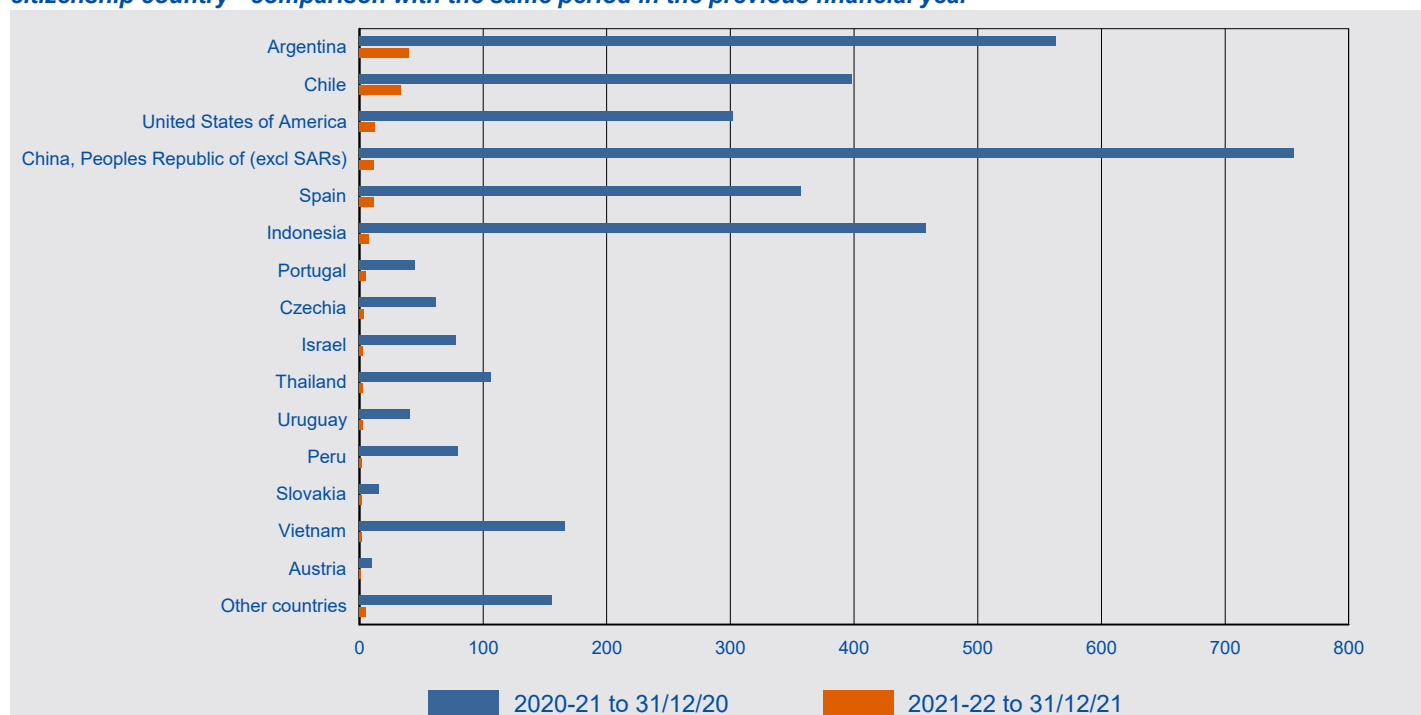

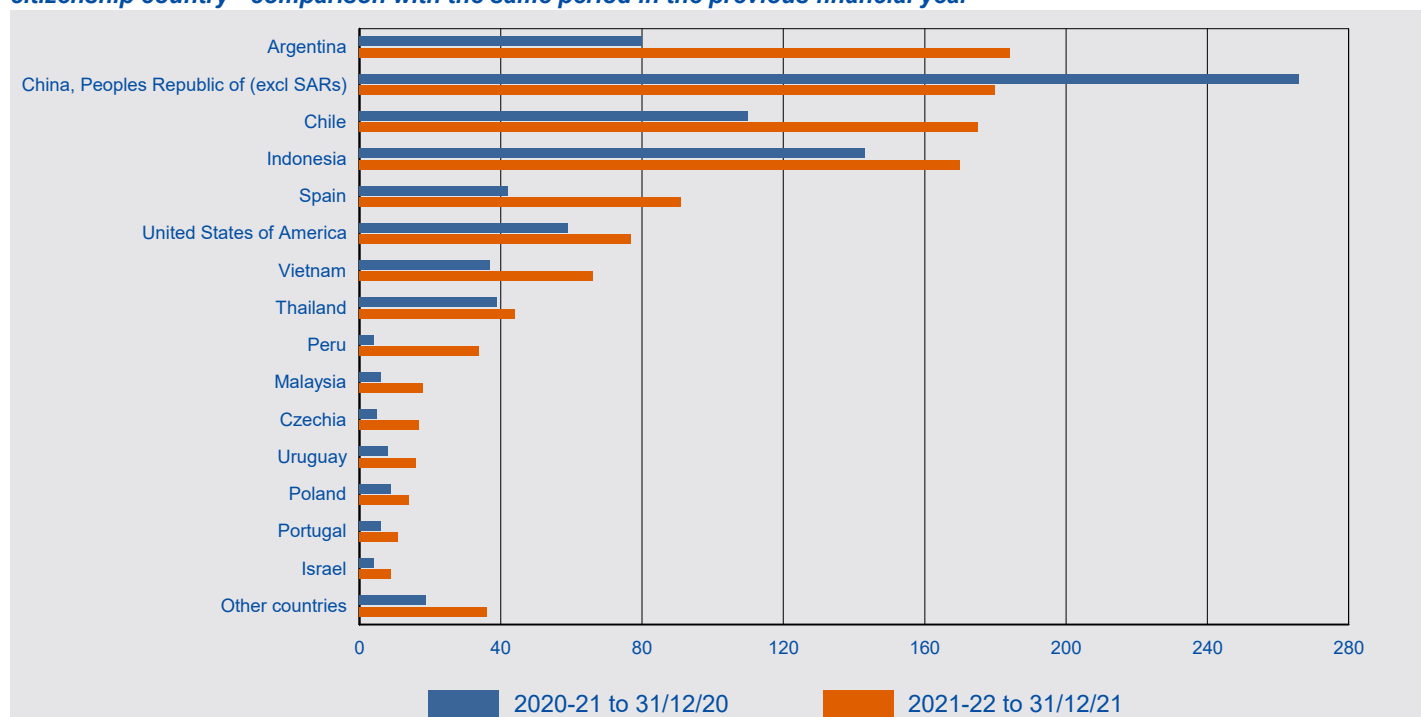

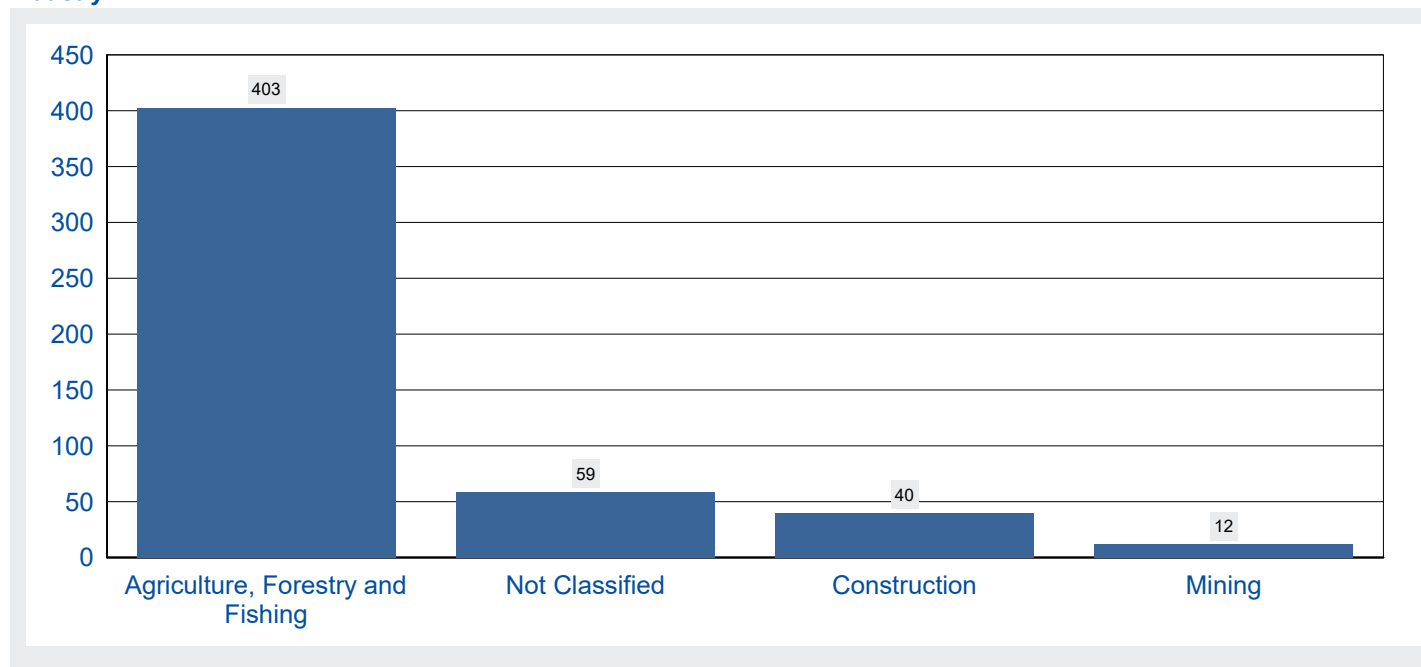

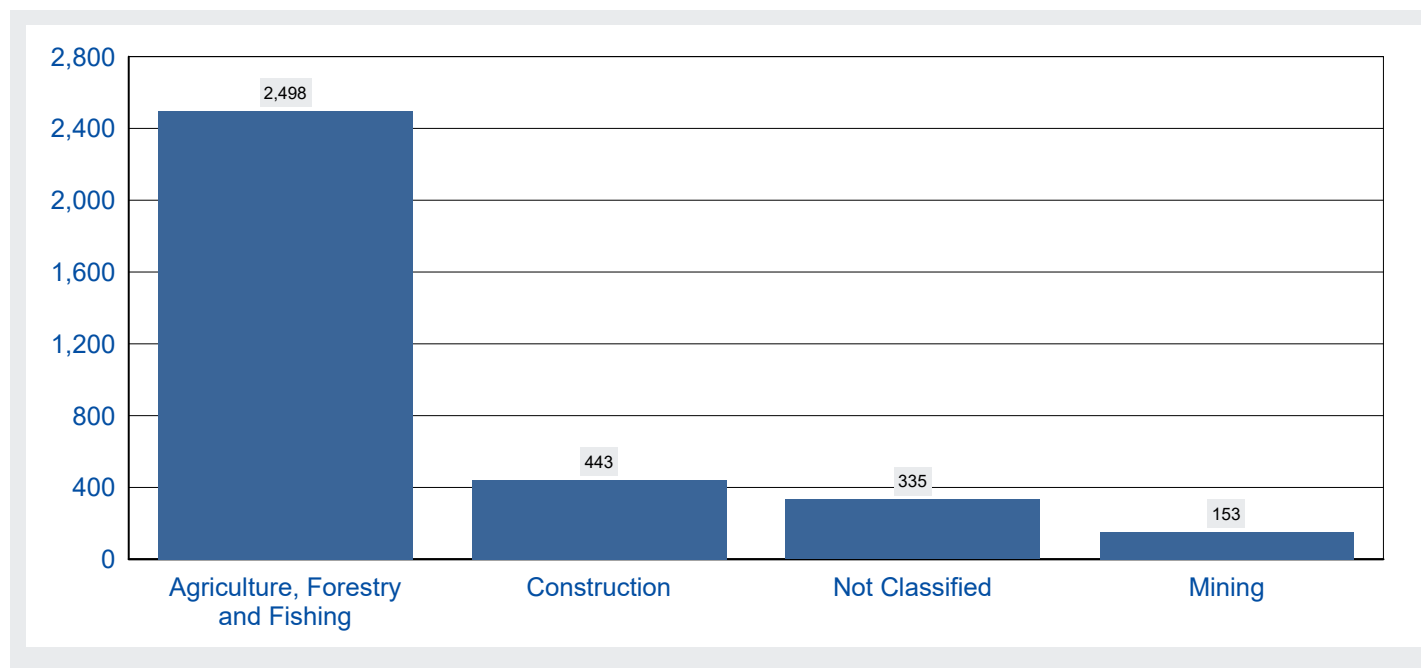

2.27 Second Working Holiday (subclass 417) visa applications granted in 2021-22 to 31 December 2021 by employer industry

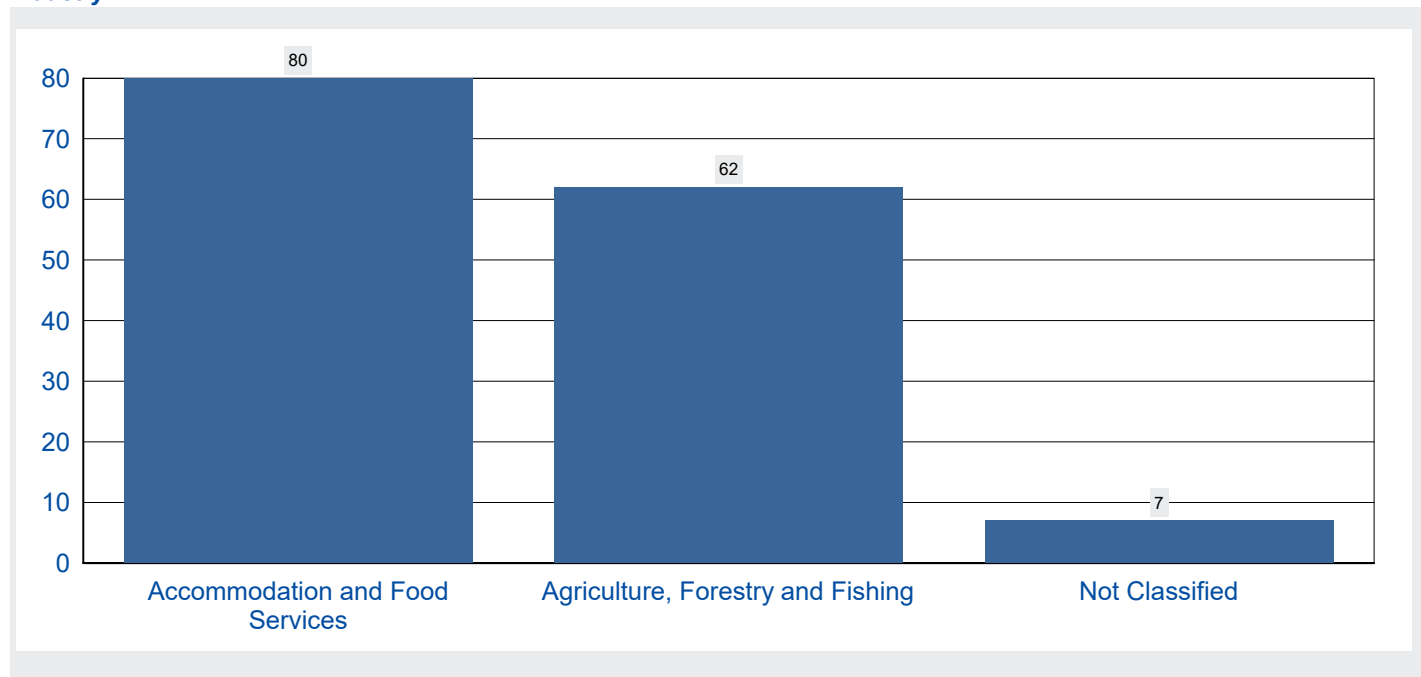


2.28 Third Working Holiday (subclass 417) visa applications granted in 2021-22 to 31 December 2021 by employer industry

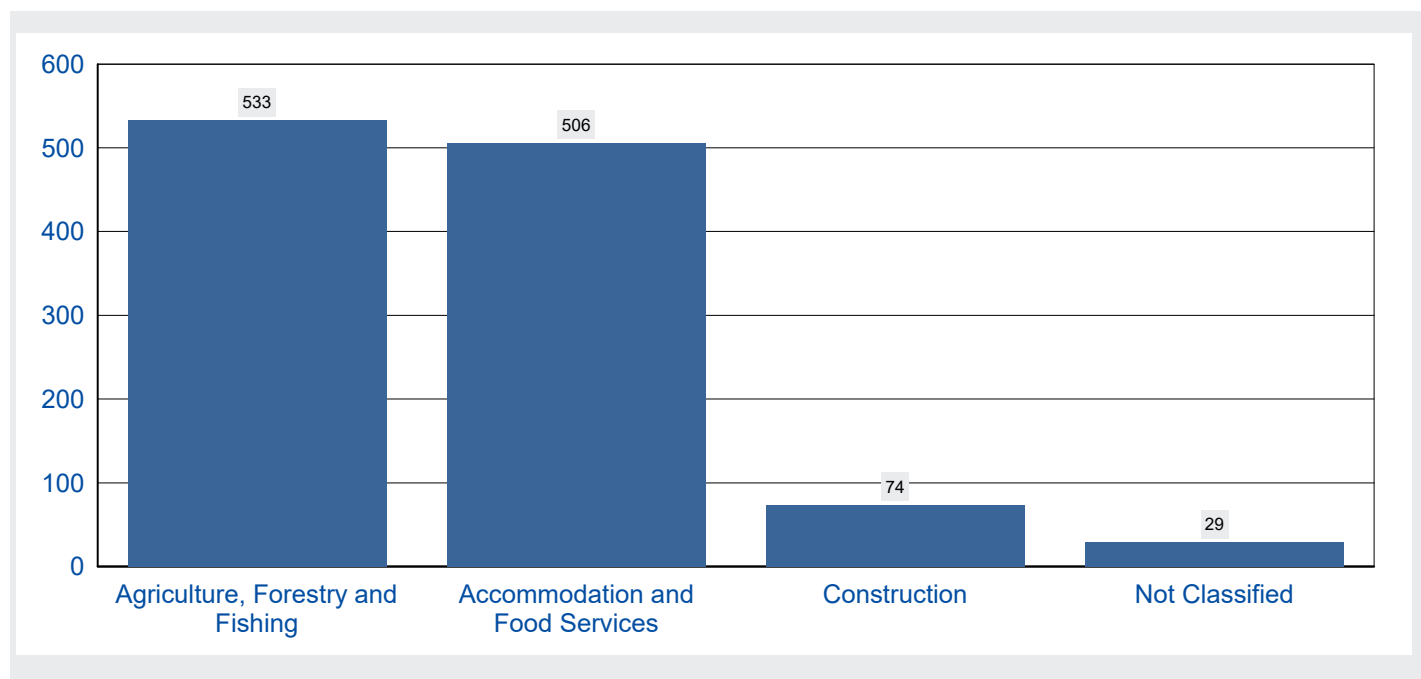

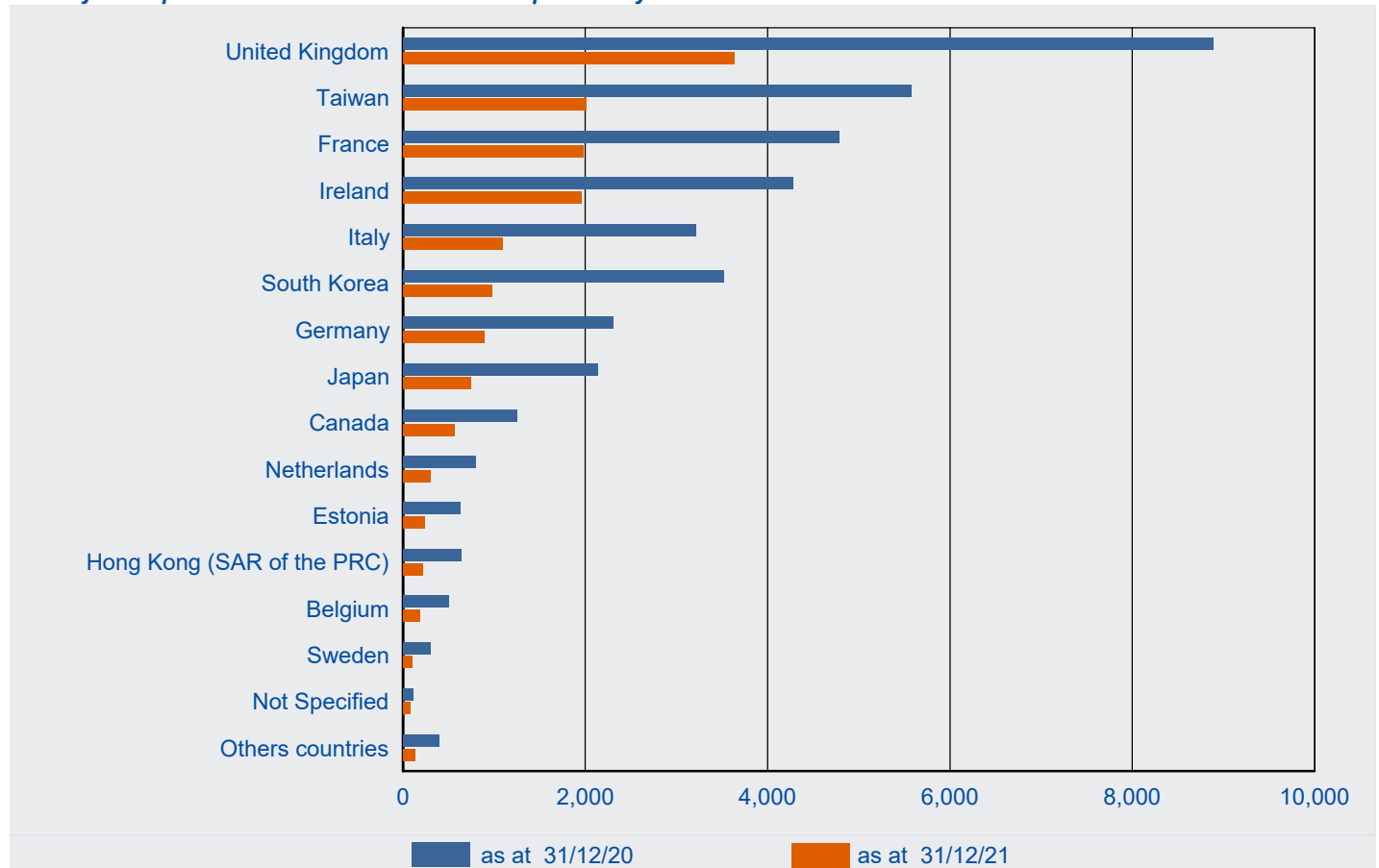

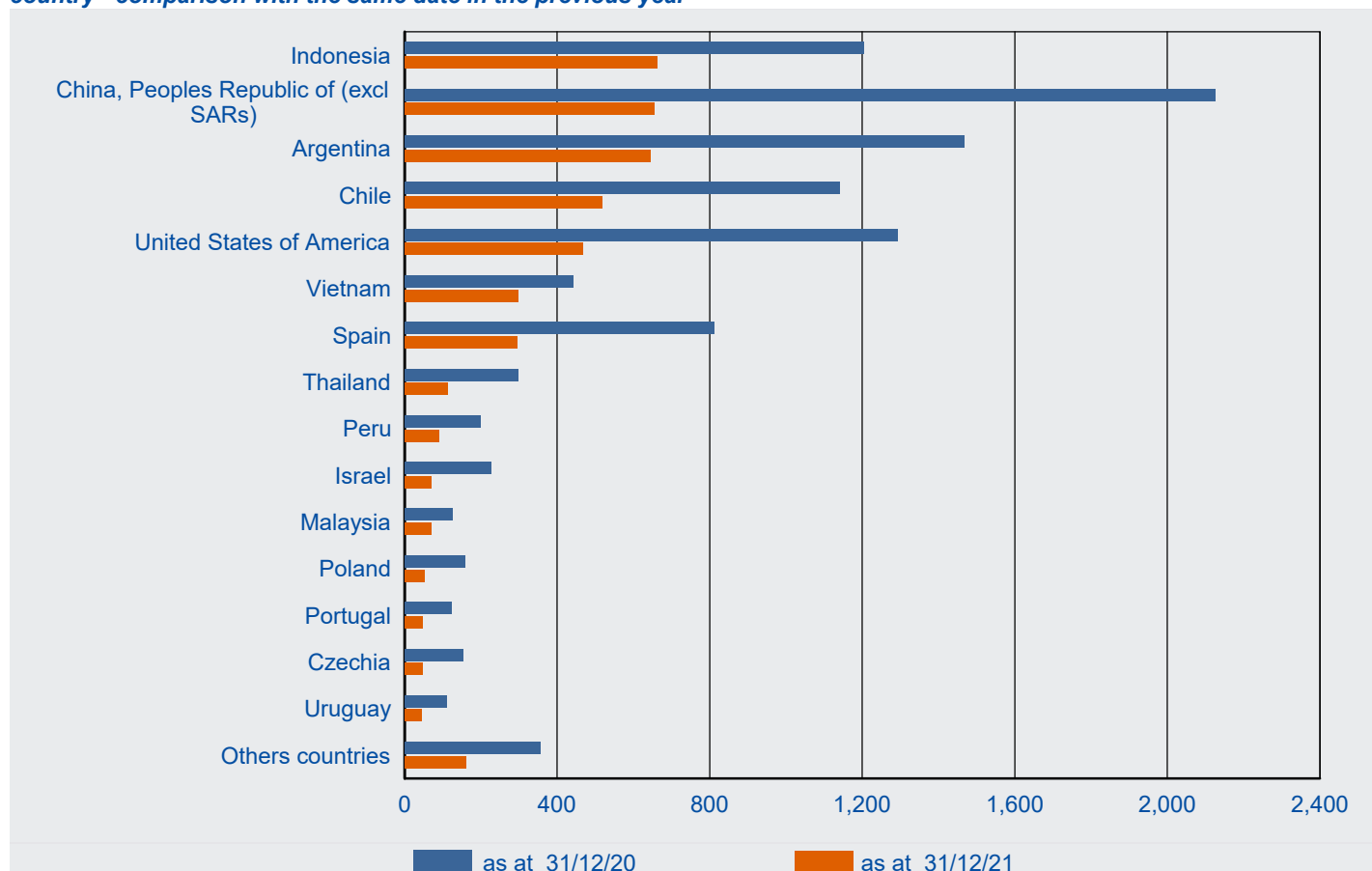
