Notes on statistical tables presented by citizenship country

A result of 'na' indicates that the country did not have a Working Holiday Maker arrangement with Australia during the specified period. This may be because the arrangement had not yet commenced or the arrangement is no longer in place. Refer to the table 'Australia's Working Holiday Maker arrangements' in the 'Background to the Working Holiday Maker visa program' section.

A citizenship country of 'Not Specified' can result from eligible dual nationality applicants where the non-eligible nationality has been recorded for the WHM application.

Note 1: Data in years prior to 2017-18 was revised on 1 October 2019, due to better source data becoming available. This may result in minor discrepancies with previously published statistics.

Definition of terms

Citizenship country:	The country of citizenship of the visa applicant or visa holder. Where a visa applicant or visa holder has more than one citizenship country, either the citizenship of the travel document or the citizenship nominated by the visa applicant is used.
Granted:	Unless otherwise specified, the number of visas granted includes all visa grants.
Snapshot date:	The snapshot date is a point in time at which a count is undertaken. In this report, the number of visa holders in Australia at a point in time is used.
Visa applicant:	Used to refer to clients applying for a visa.
Working Holiday Maker:	Refers collectively to both the Working Holiday (subclass 417) visa and the Work and Holiday (subclass 462) visa.

Background to the Working Holiday Maker visa program

The purpose of the Working Holiday Maker (WHM) visa program is to foster people-to-people links between Australia and partner countries, with particular emphasis on young adults. It has been in existence since 1975. Today, the WHM visa program includes two subclasses: the Working Holiday (subclass 417) visa and the Work and Holiday (subclass 462) visa. Partner countries initially comprised a relatively small number of Commonwealth countries. The program now has 49 partner countries and regions from across the world.

Australia has an overarching bilateral arrangement, usually in the form of a Memorandum of Understanding, with each partner country or region. Of the 49 partner countries or regions, 19 are Working Holiday (subclass 417) visa arrangements, and 30 are Work and Holiday (subclass 462) visa arrangements. The key difference between the two visas is that Work and Holiday visa arrangements generally have caps on the number of first visas granted in each program year and additional eligibility requirements.

WHM arrangements are largely reciprocal, providing Australians with similar opportunities overseas. In considering whether to add new WHM partner countries, the Australian Government considers a range of factors, including the ability of the prospective partner to offer reciprocity to Australians, and the strength of any people-to-people links.

Eligibility requirements

WHM (both Working Holiday and Work and Holiday) visa applicants must:

- be aged 18-30 (inclusive) at time of application. For Canada, France, Denmark, Ireland, Italy and The United Kingdom of Great Britain and Northern Ireland (including British National Overseas passport holders) the age is 18 to 35 (inclusive).
- hold a passport from an eligible partner country or region. A list of eligible countries and regions is provided in the 'Australia's Working Holiday Maker Visa Arrangements' section of this report
- not be accompanied by dependent children during their stay in Australia
- meet financial, health and character requirements.

Work and Holiday visa applicants must meet additional requirements, which vary between eligible countries, based on the agreements set out in the MOU for partner countries.

Working while in Australia

All WHMs may work for the full duration of their 12 month stay in Australia, but generally cannot remain with any one employer for longer than six months (by operation of mandatory visa condition 8547), unless an exemption applies or they have obtained written permission from the department.

Studying while in Australia

All WHMs are entitled to study for a period of up to four months during their 12-month stay in Australia.

Background to the Working Holiday Maker visa program - continued

Second and third Working Holiday visas

First-time Working Holiday (subclass 417) visa holders who complete three months of 'specified subclass 417 work' during their stay become eligible to apply for a second Working Holiday visa. Second Working Holiday visa holders who complete six months of 'specified subclass 417 work' during their stay become eligible to apply for a third Working Holiday visa.

Specified subclass 417 work includes work in the agriculture, mining, construction, and tourism and hospitality industries, as well as bushfire and natural disaster recovery work, and critical COVID-19 work in the healthcare and medical sectors.

Second and third Work and Holiday visas

First-time Work and Holiday (subclass 462) visa holders who complete three months of 'specified subclass 462 work' during their stay become eligible to apply for a second Work and Holiday visa. Second Work and Holiday visa holders who complete six months of 'specified subclass 462 work' during their stay become eligible to apply for a third Work and Holiday visa.

Specified subclass 462 work includes work in the agriculture, construction and tourism and hospitality industries, bushfire and natural disaster recovery work and critical COVID-19 work in the healthcare and medical sectors.

Recent developments in the Working Holiday Maker (WHM) visa program

- From 19 January 2022 to 30 June 2023, WHMs working in any sector anywhere in Australia were allowed to work for the same employer or organisation for longer than six months without requesting permission from the department.
- On 29 December 2022, the Australian Government agreed to extend access to the Work and Holiday (subclass 462) visa program to eligible citizens of India, with an annual cap of 1,000 places. This commitment was made under the Australia-India Economic Cooperation and Trade Agreement (AI-ECTA) to be delivered by 29 December 2024, within two years of the trade agreement entering into force. Work is underway to introduce changes to deliver on this commitment through a pre-visa application process that randomly select eligible citizens of India under the Work and Holiday (subclass 462) visa program.
- On 31 May 2023 the Australia-United Kingdom Free Trade Agreement (Australia-UK FTA) entered into force. Under the terms of Australia UK-FTA, the following arrangements apply for UK passport holders:
 - On 1 July 2023, the maximum age for Working Holiday visa applicants increased to 35 years; and
 - From 1 July 2024, applicants may be granted up to three Working Holiday visas without having to meet any specified work requirements.
- On 8 September 2023, Australia signed a Strategic Partnership with the Philippines, including a new reciprocal Work and Holiday visa for Australians and Filipinos, supporting stronger economic, cultural and people-to-people links. This new Work and Holiday visa arrangement will allow up to 200 young Filipinos and Australians each year to enjoy a 12-month holiday in each other's country, during which they may undertake short-term work and study. This arrangement is expected to commence on 1 July 2024.
- From 2 February 2024, Working Holiday Makers will be able to count paid or volunteer work for natural disasters recovery work. This includes work in declared areas affected by cyclone or other severe weather, as 'specified work' to apply for a second or third WHM visa. Working holiday makers must have carried out this work from 31 December 2021 in declared disaster affected areas.

Executive Summary

Key Points

This executive summary covers the WHM program from 1 July 2023 to 31 December 2023.

The WHM program has responded strongly since full re opening of Australia's borders following the COVID-19 Pandemic. Lodgements and grants of WHM visas now exceed levels experienced before the COVID-19 Pandemic. It is not yet certain whether this increase represents a long-term trend.

- As at 31 December 2023 there were 170,437 WHM (subclass 417 and subclass 462) visa holders in Australia, up from 112,335 at 31 December 2022
- A total of 122,388 WHM (subclass 417 and subclass 462) visas granted, compared with 111,610 visa grants in the same period in 2022, including:
 - 66,870 first, 4,553 second and 1,320 third Working Holiday (subclass 417) visa grants
 - 16,146 first, 5,044 second and 1,078 third Work and Holiday (subclass 462) visa grants
- The United Kingdom, France, Republic of Ireland, Germany and Italy were the top five citizenship countries of the Working Holiday (subclass 417) visa grants in the six month period to 31 December 2023, cumulatively accounting for 68.7 percent of the total.
- Indonesia, The United States of America, Thailand, Argentina and Vietnam were the top five citizenship countries of the Work and Holiday (subclass 462) visa grants in the six month period to 31 December 2023, cumulatively accounting for 61.3 percent of the total.

1 Applications lodged for WHM program

In the six months to 31 December 2023, 128,539 visa applications were lodged across the total WHM program, a 16.1 per cent increase compared to 110,705 in the same period of 2022.

For Working Holiday (subclass 417), first visa applications increased by 21.7 per cent to 82,850 and second visa applications increased by 319.9 per cent to 17,198.

For Work and Holiday (subclass 462), first visa applications increased by 32.2 per cent to 19,329 and second visa applications increased by 209.9 per cent to 5,783.

2 Visas granted

Working Holiday (subclass 417) visa program

In the six months to 31 December 2023, a total of 100,119 visa applications were granted for the Working Holiday program, compared to 91,218 in the same six months of 2022.

First Working Holiday (subclass 417) visa program

A total of 83,351 first Working Holiday visas were granted in the six months to December 2023, compared to 66,870 in the same period in 2022.

Top five countries for first Working Holiday visa grants were:

- Italy (6,080)

Second Working Holiday (subclass 417) visa program

A total of 15,439 second Working Holiday visas were granted in the six months to December 2023. This is a 239.1 per cent increase compared to 4,553 in the same period in 2022.

The top five countries for second Working Holiday visa grants were:

- United Kingdom (3,392)
- Ireland (2,490)
- Taiwan (2,174)
- France (1,927)
- Italy (1,198)

In the six months to 31 December 2023, 48.9 per cent of those granted a second Working Holiday visa nominated *agriculture, forestry & fishing* as the industry in which they had undertaken "specified work" in order to acquire eligibility. A further 20.5 per cent nominated *accommodation & food services*, and 14 per cent for *construction*.

Executive Summary – continued

Third Working Holiday (subclass 417) visa program

A total of 1,320 third Working Holiday visas were granted in the six months to 31 December 2023.

The top five countries or regions for third Working Holiday (subclass 417) visa grants were:

- Taiwan (482)
- United Kingdom (167)
- France (145)
- Ireland (110)
- South Korea (91)

In the six months to 31 December 2023, 55 per cent of those granted a third Working Holiday visa nominated *agriculture, forestry & fishing* as the industry in which they had undertaken “specified work” in order to acquire eligibility. A further 13.8 per cent nominated *accommodation & food services*, and 9.1 per cent *construction*.

Work and Holiday (subclass 462) visa program

In the six months to 31 December 2023 a total of 22,269 visa applications were granted, compared to 20,392 in the same period in 2022.

First Work and Holiday (subclass 462) visa program

A total of 16,146 first Work and Holiday visas were granted in the six months to 31 December 2023, compared to 13,783 in the same period of 2022.

The top five countries for first Work and Holiday (subclass 462) visa grants were:

- Indonesia (2,696)
- United States of America (2,542)
- Thailand (1,920)
- Spain (1,657)
- Argentina (1,546)

Second Work and Holiday (subclass 462) visa program

A total of 5,044 second Work and Holiday visas were granted in the six months to 31 December 2023, compared to 1,940 in the same period of 2022.

The top five countries for second Work and Holiday visa grants were:

- Indonesia (1,231)
- Vietnam (766)
- China (619)
- Thailand (592)
- Argentina (538)

In the six months to 31 December 2023, 57 per cent of those granted a second Work and Holiday visa nominated *agriculture, forestry & fishing* as the industry in which they had undertaken ‘specified work’ in order to acquire eligibility. A further 30.3 per cent nominated *accommodation & food services*, and 3.8 per cent *construction*.

Third Work and Holiday (subclass 462) visa program

A total of 1,078 third Work and Holiday visas were granted in the six months to 31 December 2023.

The top five countries for third Work and Holiday visa grants were:

- Vietnam (361)
- Indonesia (358)
- China (116)
- Thailand (81)
- Argentina (61)

In the six months to 31 December 2023, 56.7 per cent of those granted a third Work and Holiday visa nominated *agriculture, forestry & fishing* as the industry in which they had undertaken “specified work” in order to acquire eligibility. A further 33.6 per cent nominated *accommodation & food services* and 2.3 per cent *construction*.

3 Grant rates

Working Holiday (subclass 417) visa program

The grant rate for first Working Holiday visas in the six month period ending 31 December 2023 was 99.8 per cent. The grant rate for second Working Holiday visas was 99.6 per cent. The grant rate for third Working Holiday visas was 98.5 per cent.

Work and Holiday (subclass 462) visa program

The grant rate for first Work and Holiday visas was 97.2 per cent. The grant rate for second Work and Holiday visas was 99.8 per cent. The grant rate for third Work and Holiday visas was 98.9 per cent.

The generally high grant rates for WHM visas are indicative of the low risk nature of this caseload. The large proportion of online applications for this caseload also contributes to the high grant rate. A number of automated eligibility checks occur during online applications, alerting clients early in the process if they do not meet visa requirements.

4 Working Holiday Makers in Australia

Working Holiday (subclass 417) visa holders

As at 31 December 2023, there were 136,502 first, second and third and Nil VAC Working Holiday visa holders in Australia. This is a 41.5 per cent increase compared to 96,464 on 31 December 2022.

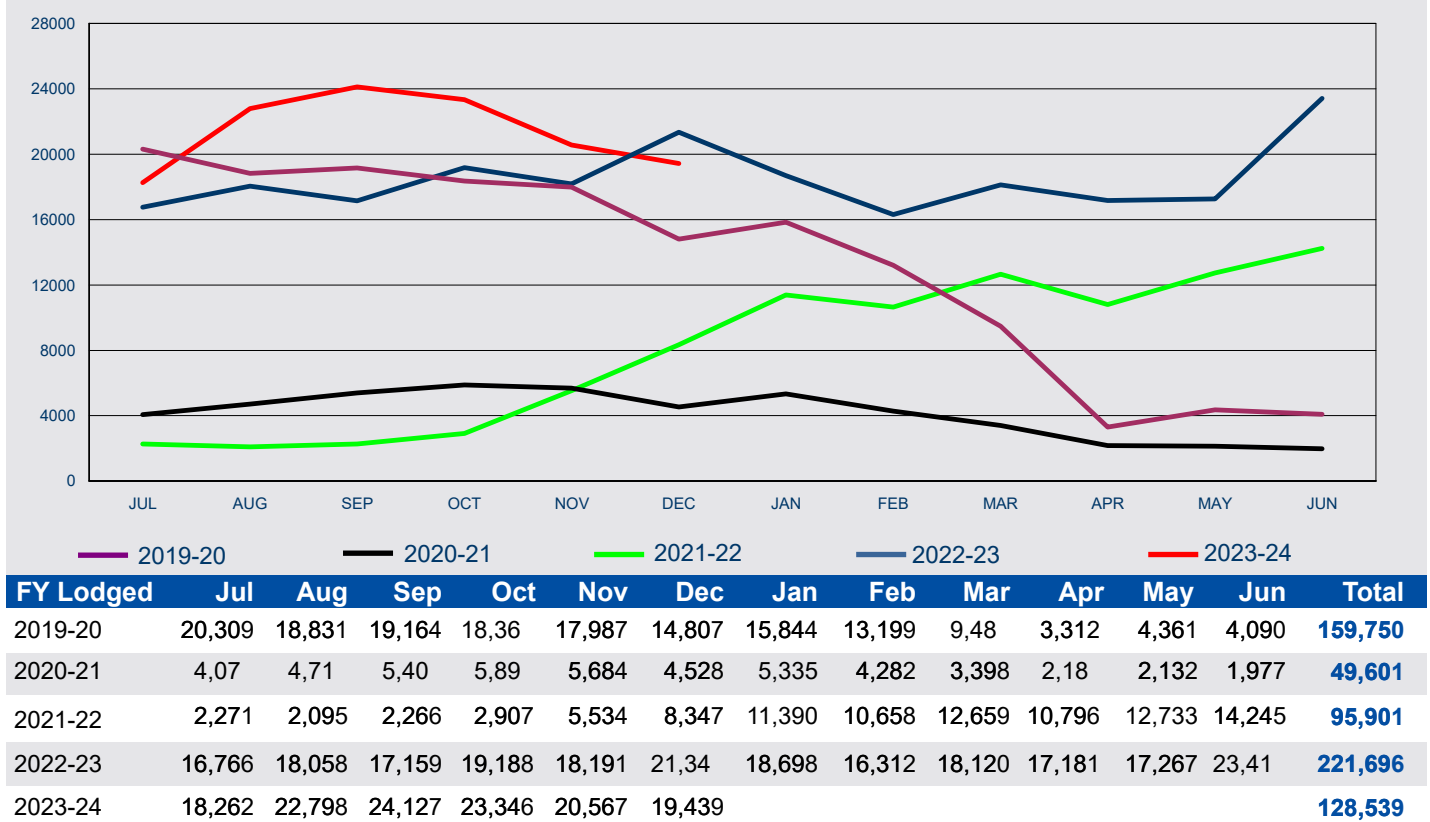
Work and Holiday (subclass 462) visa holders

As at 31 December 2023, there were 33,935 first, second and third and Nil VAC Work and Holiday visa holders in Australia. This is a 79.8 per cent increase compared to 18,871 on 31 December 2022.

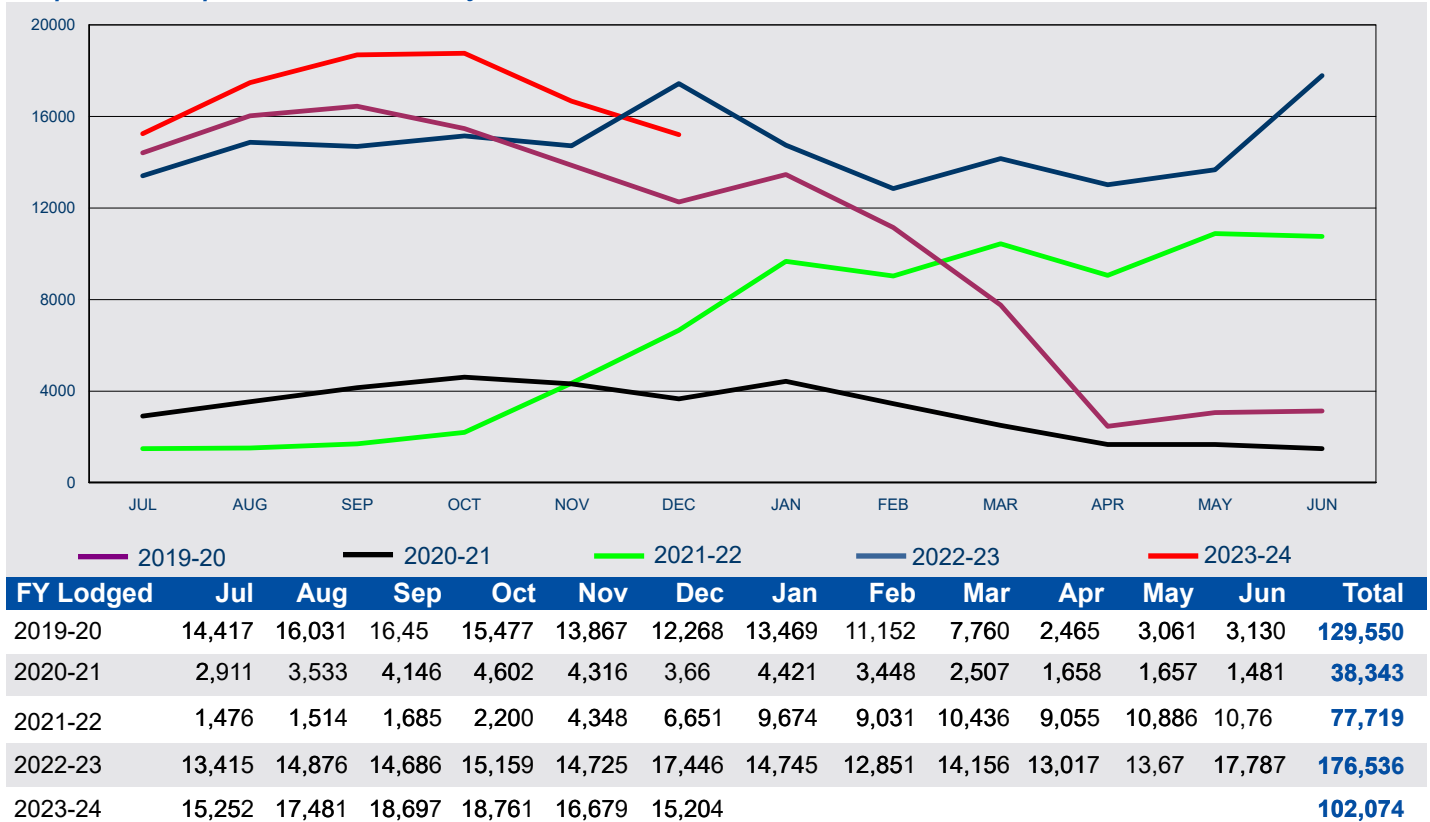

1.01 Total number of Working Holiday Maker visa applications lodged in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

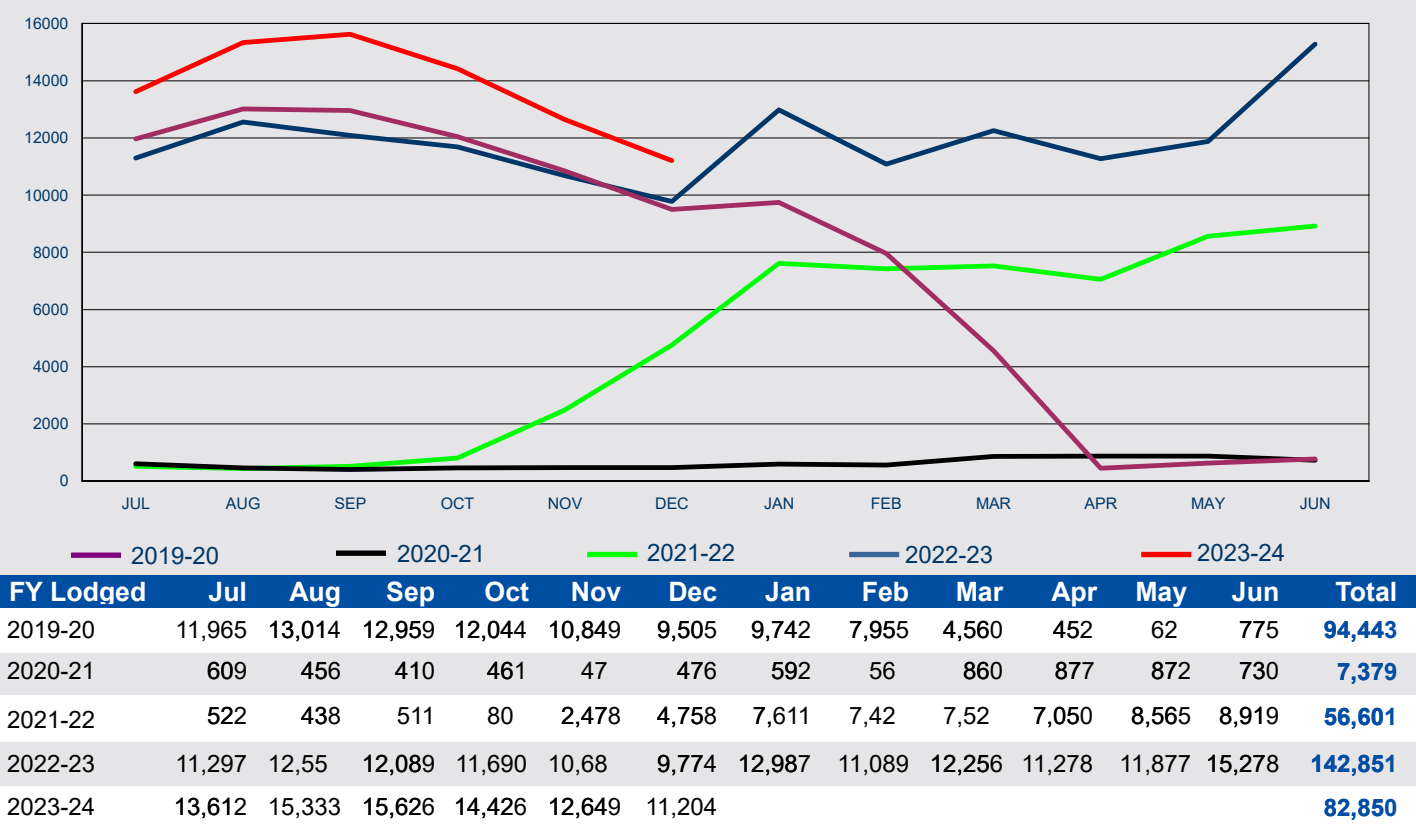


1.02 Total number of Working Holiday (subclass 417) visa applications lodged in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

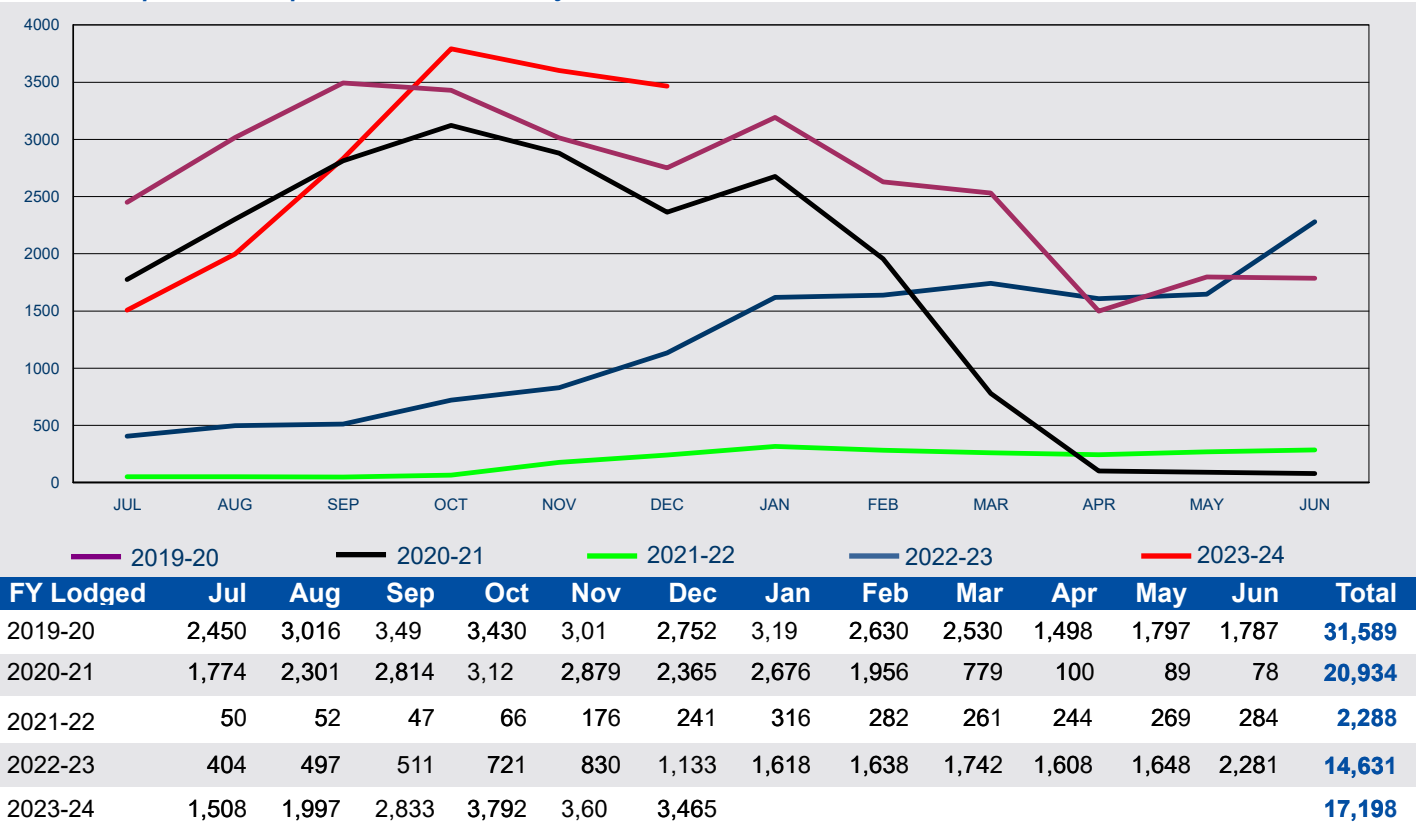

1.03 Number of first Working Holiday (subclass 417) visa applications lodged in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

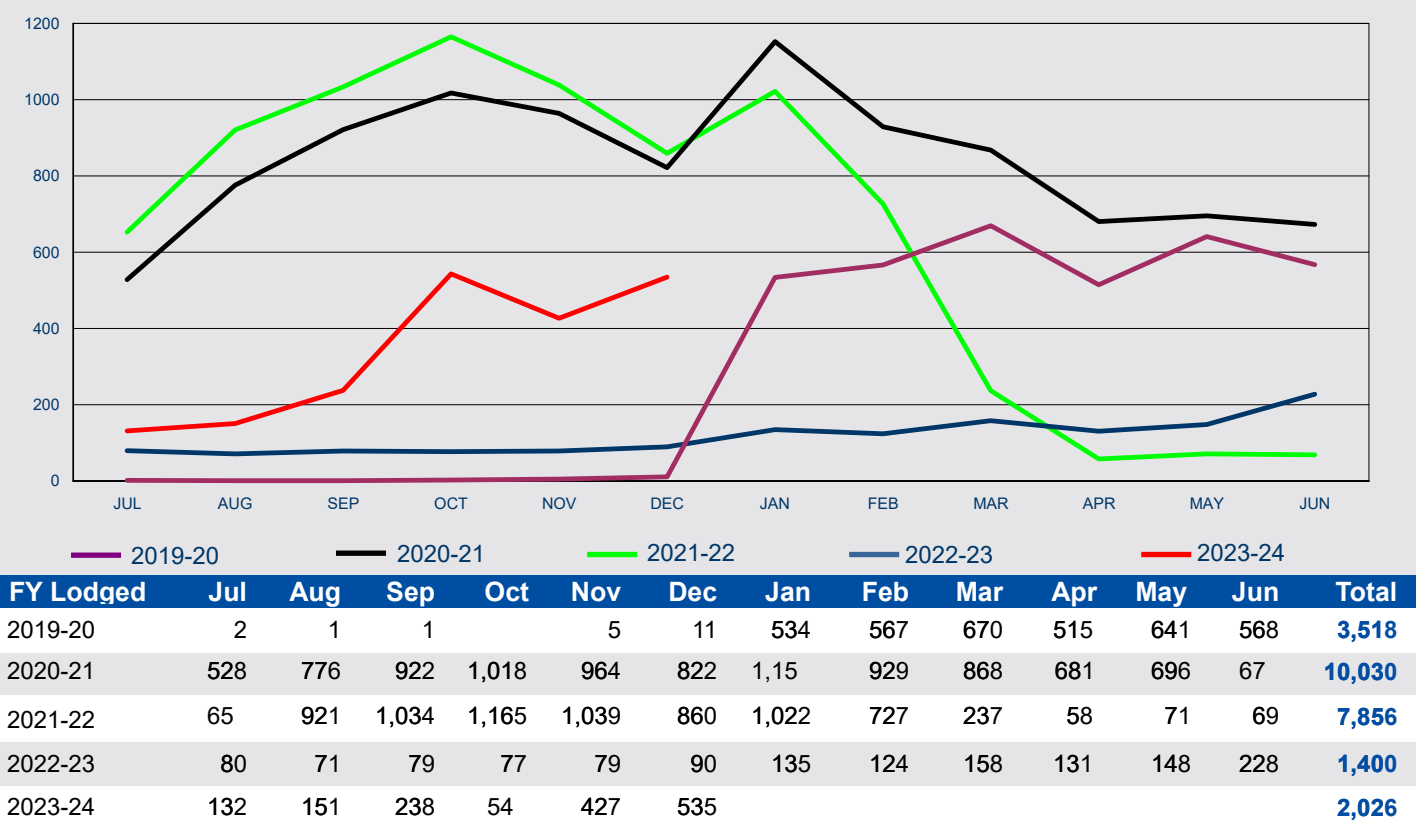


1.04 Number of second Working Holiday (subclass 417) visa applications lodged in 2023-24 to 31 December 2023 by month - comparison with previous four financial years



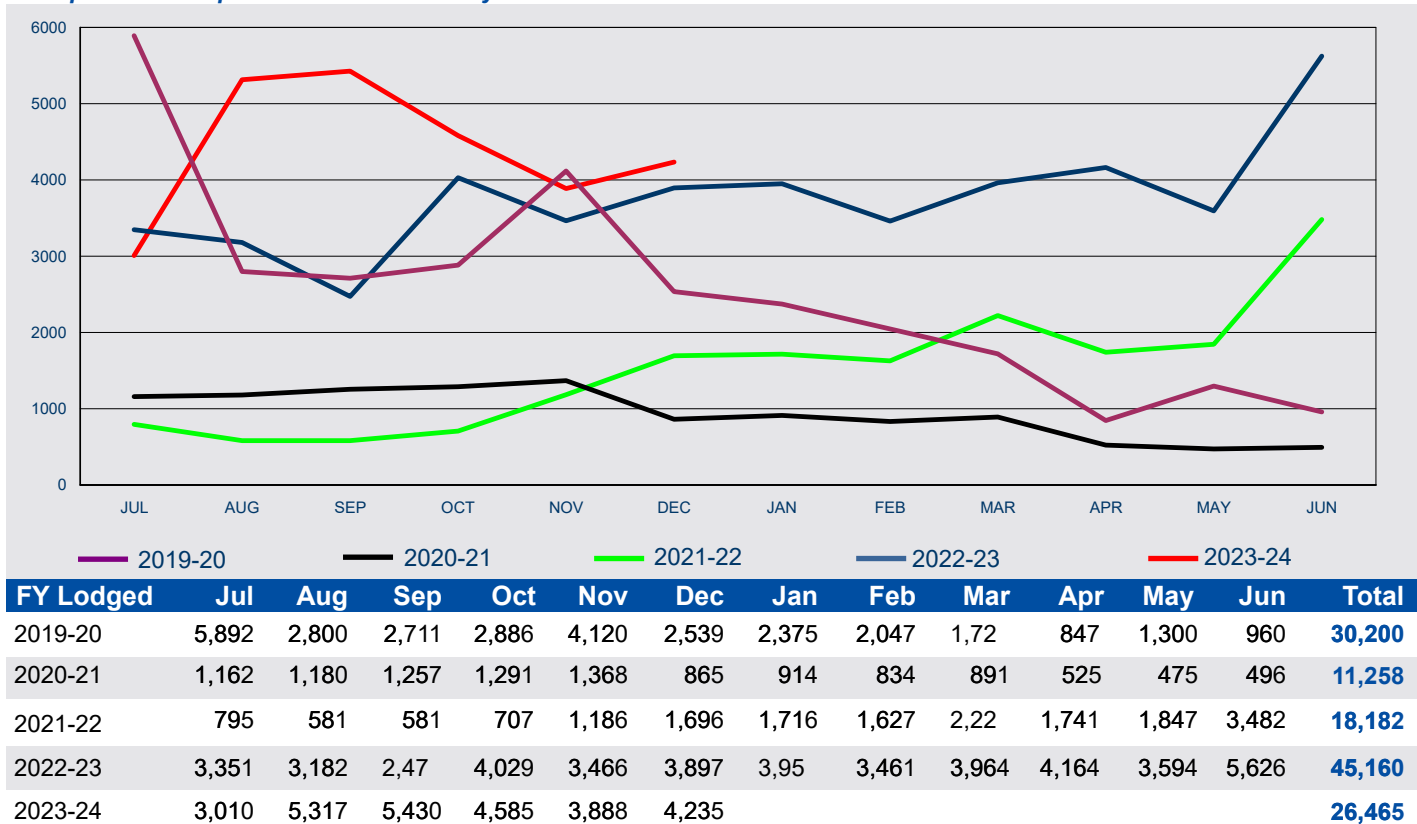

1.05 Number of third Working Holiday (subclass 417) visa applications lodged in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

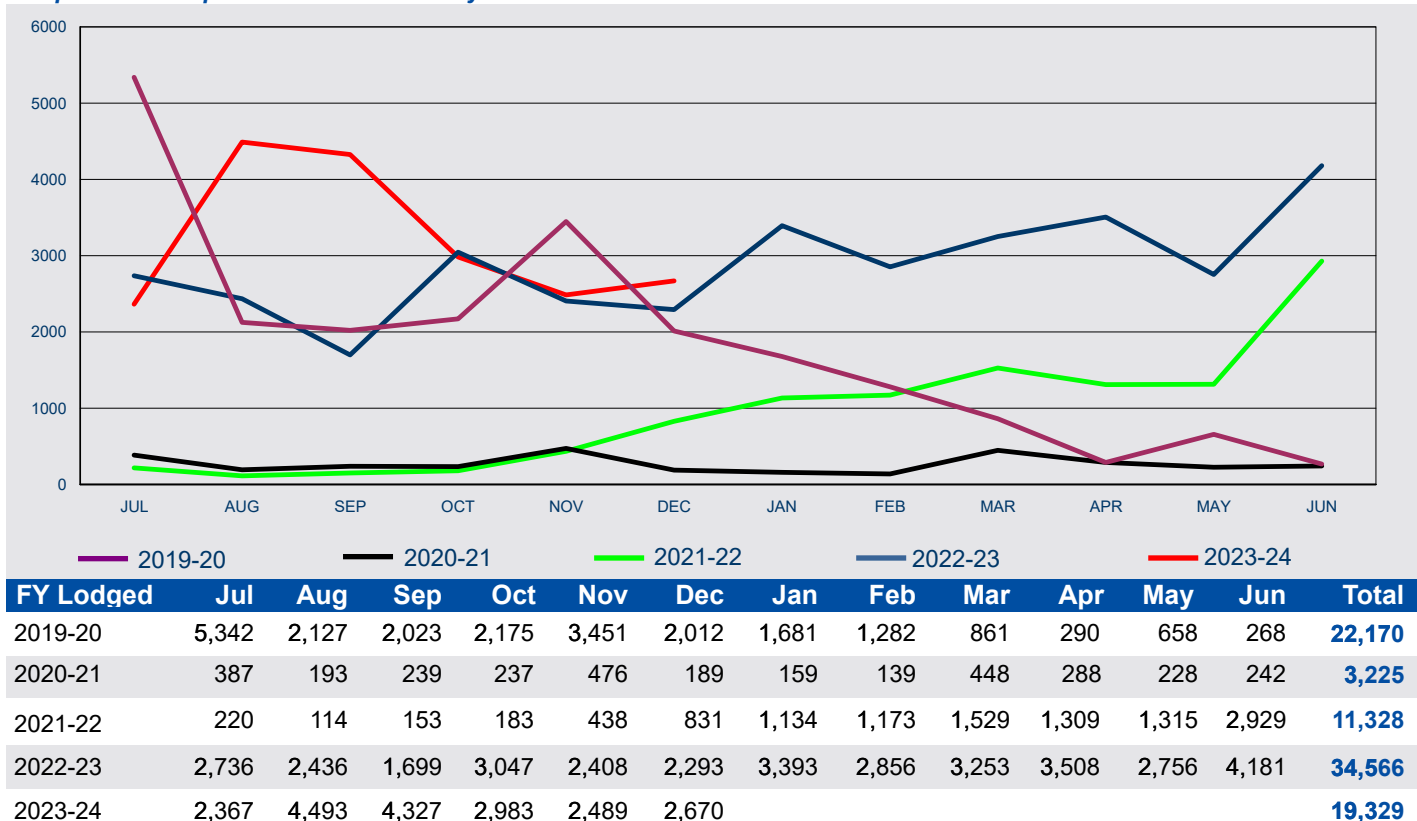

1.06 Total number of Work and Holiday (subclass 462) visa applications lodged in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

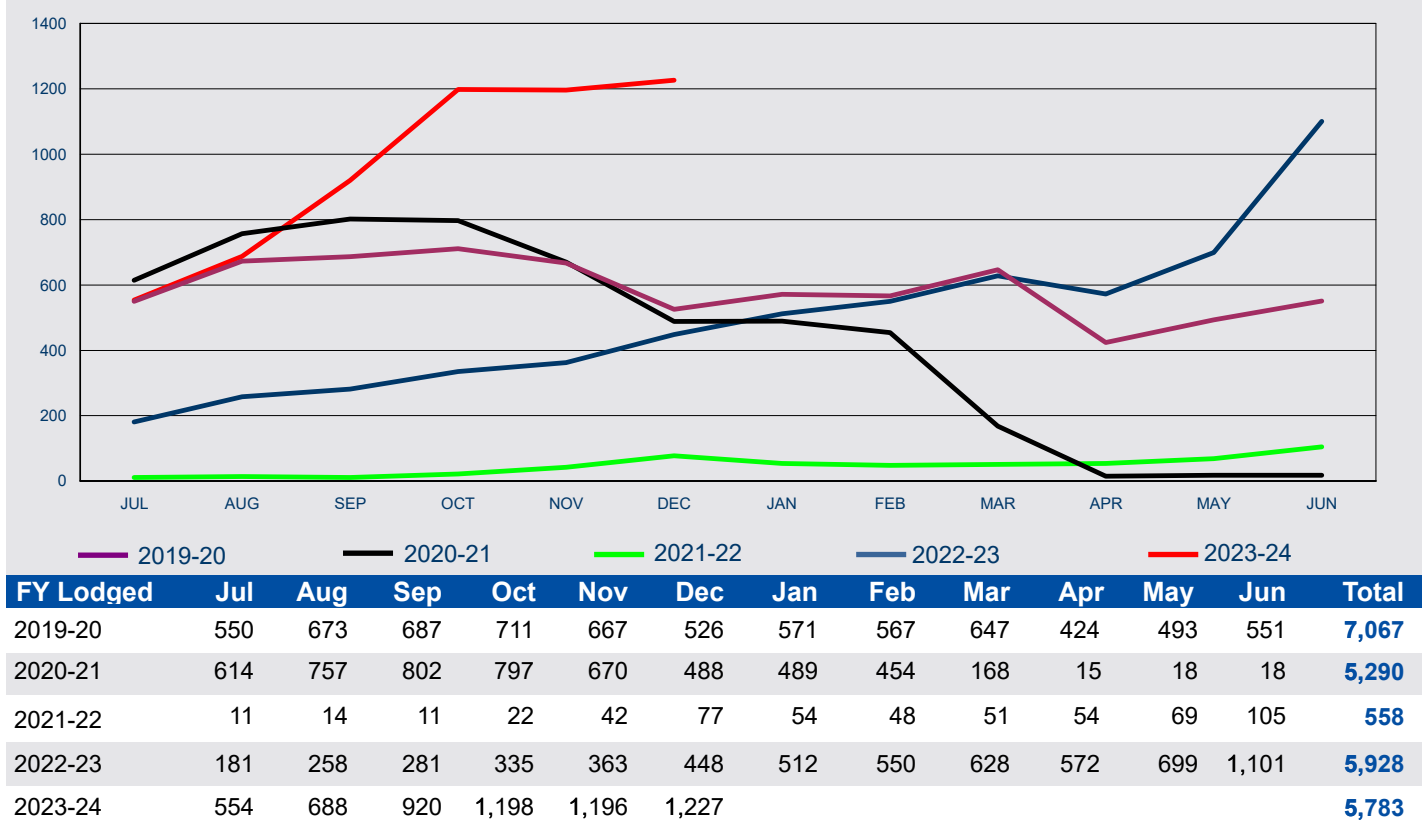


1.07 Number of first Work and Holiday (subclass 462) visa applications lodged in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

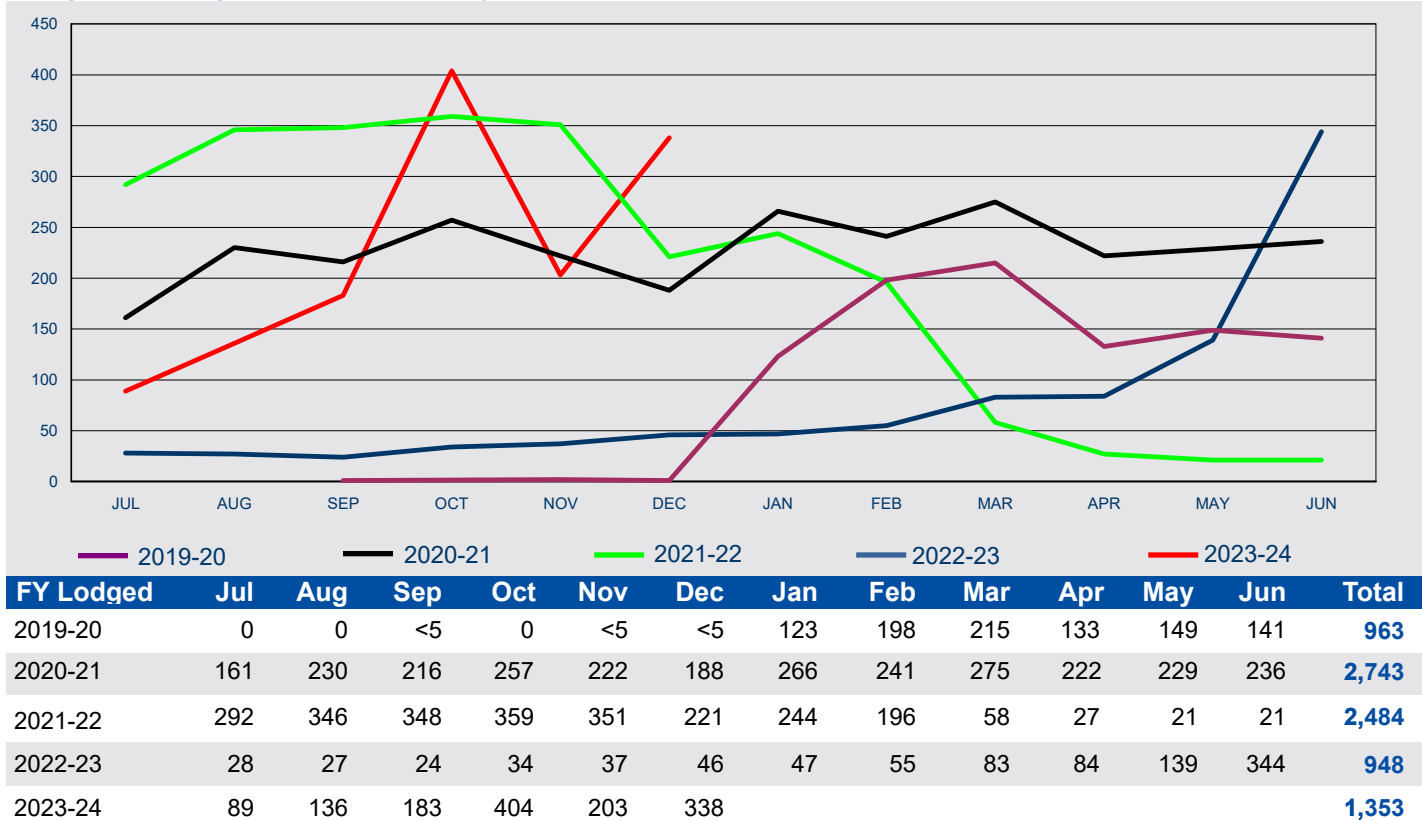

1.09 Number of third Work and Holiday (subclass 462) visa applications lodged in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

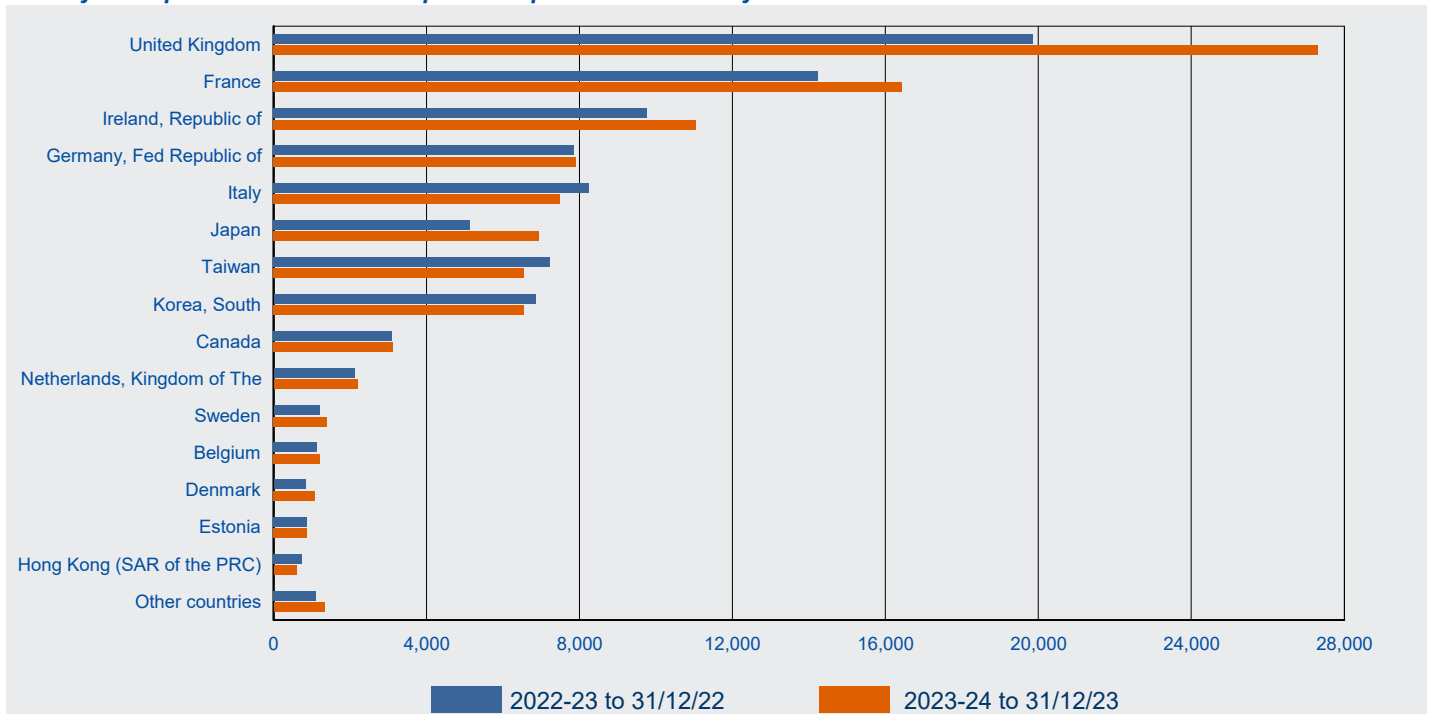

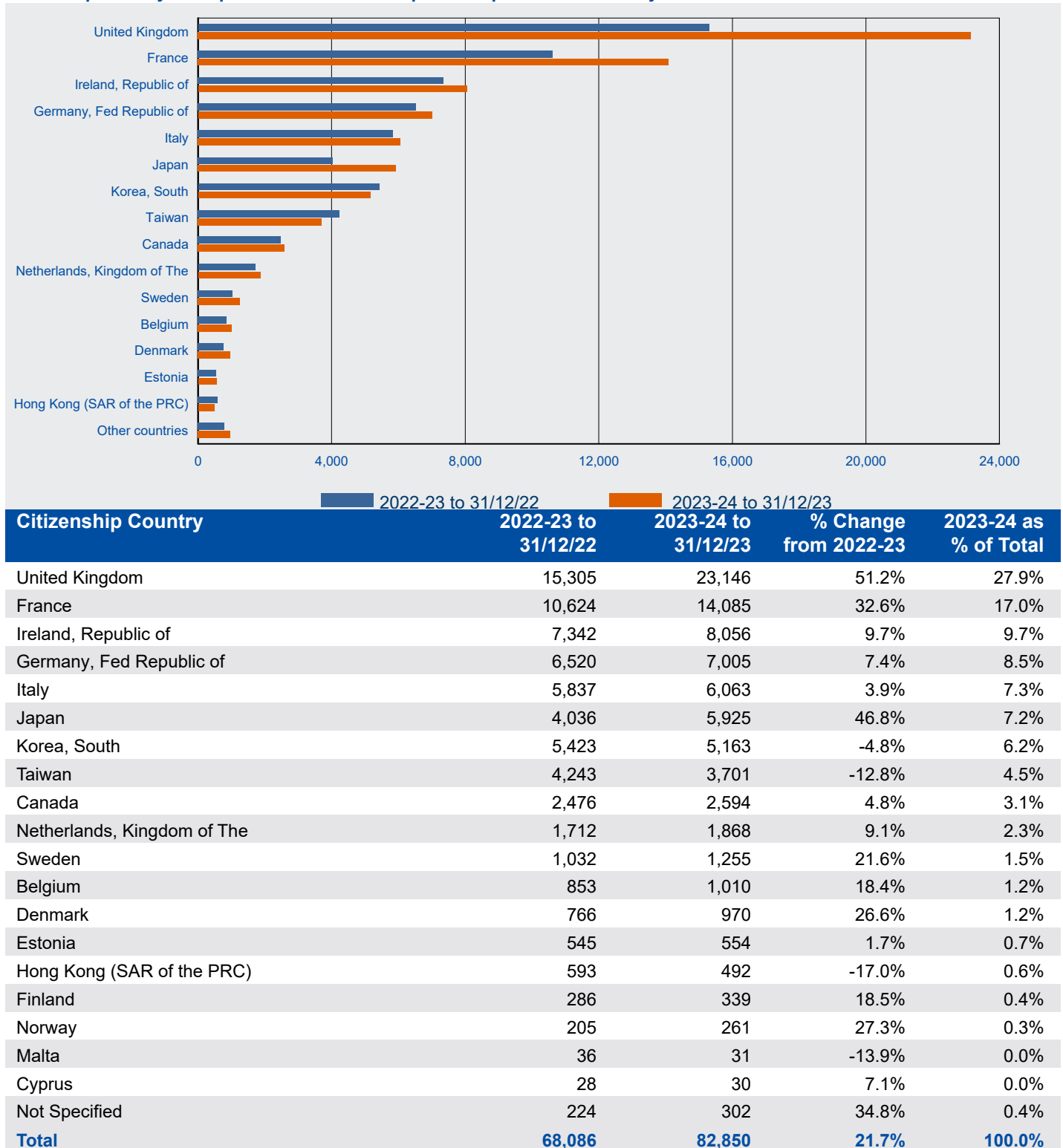

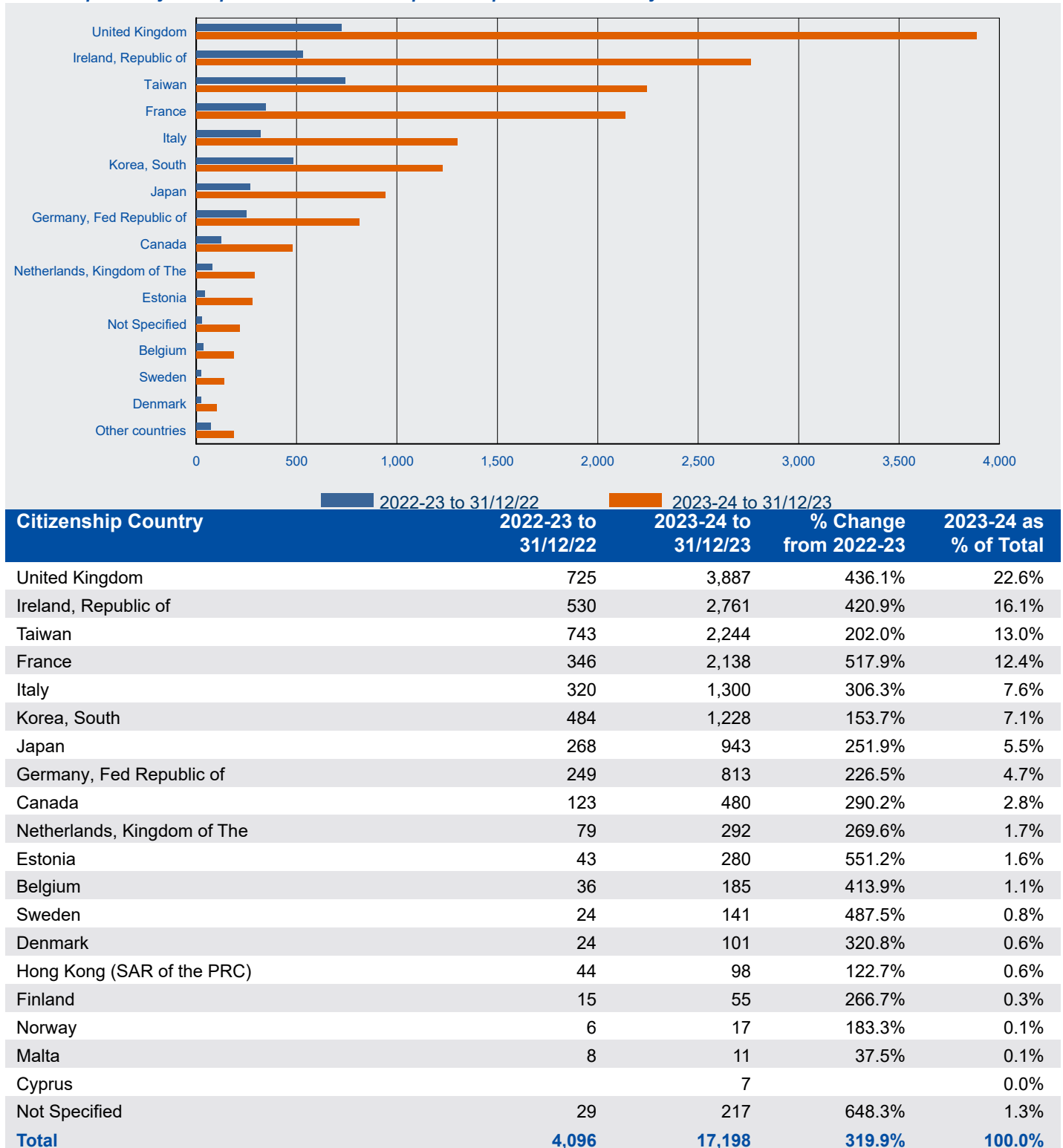

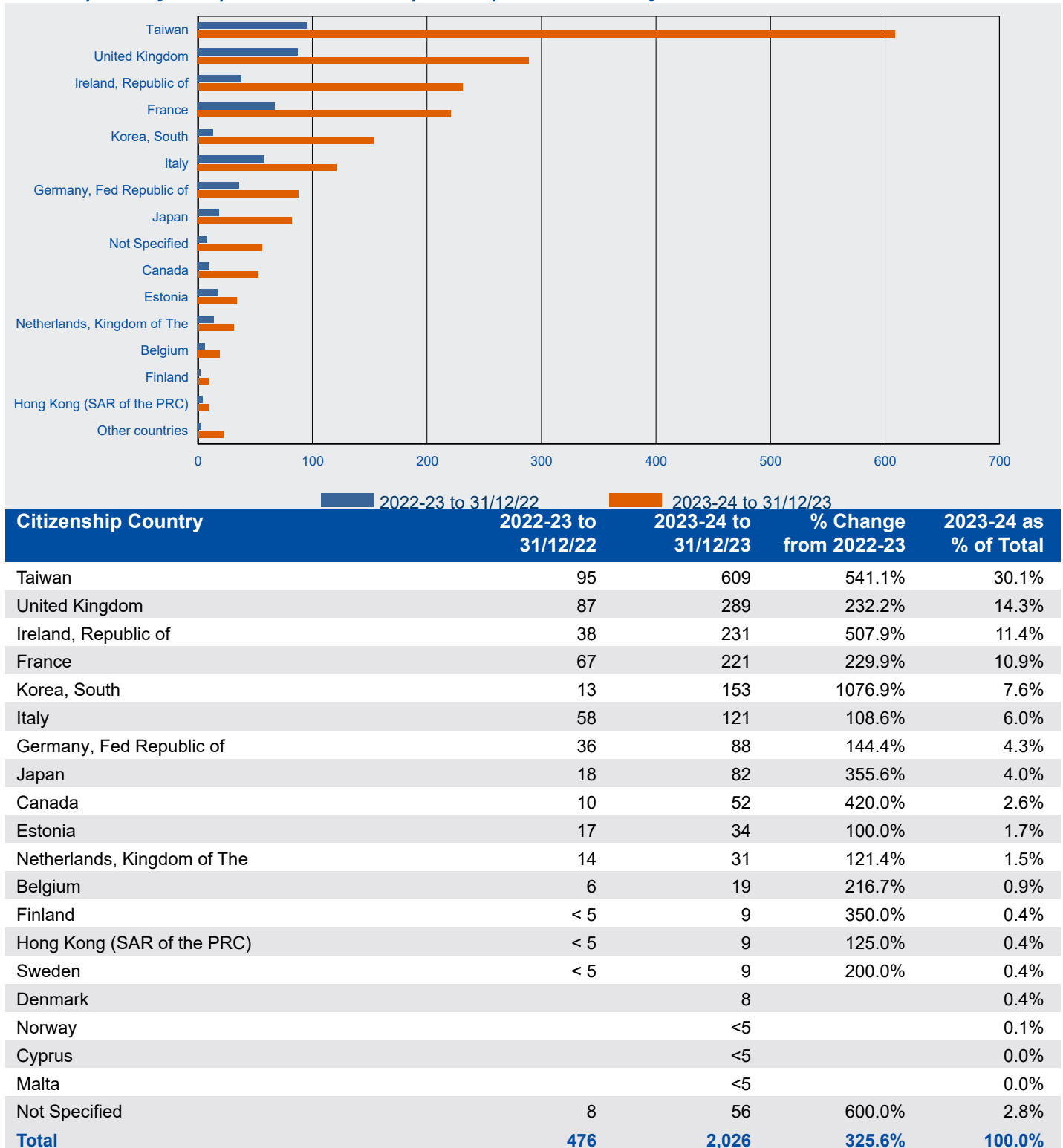

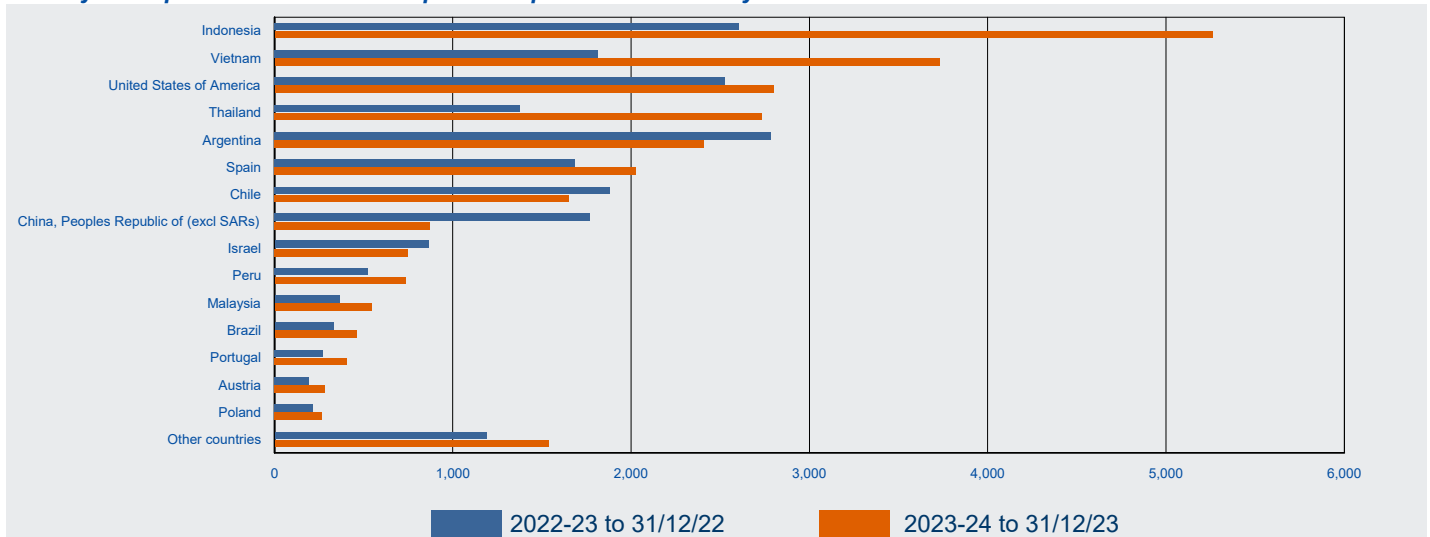

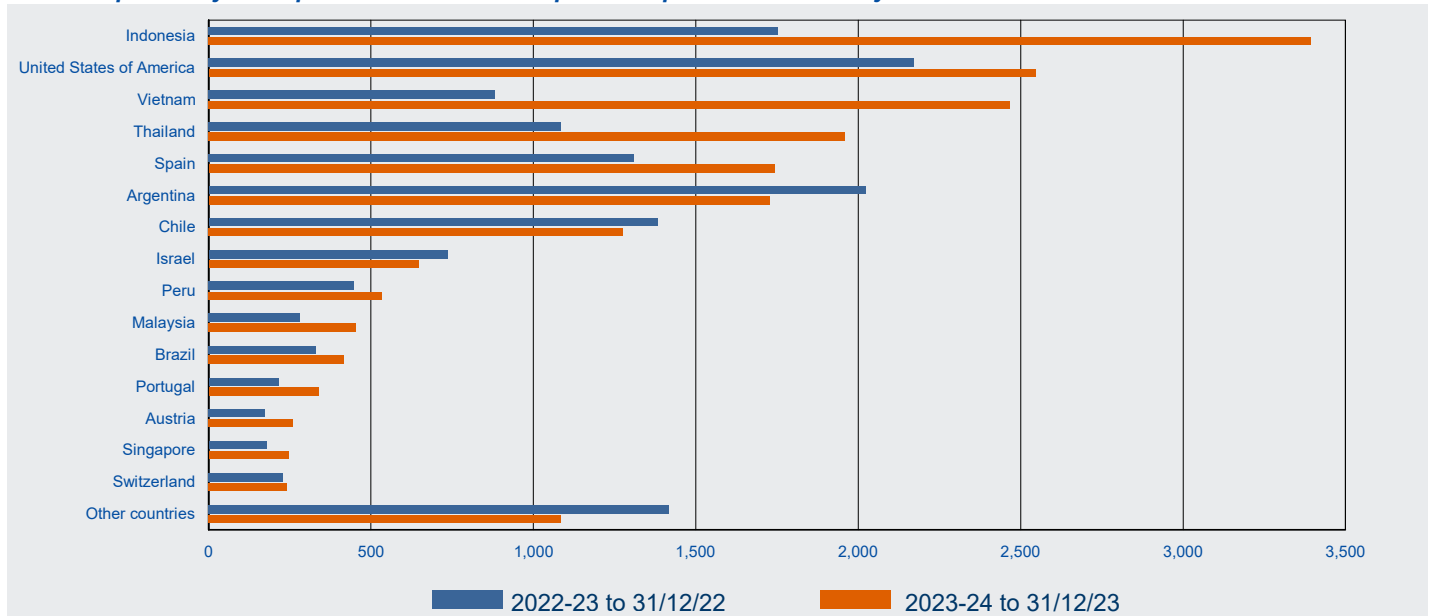

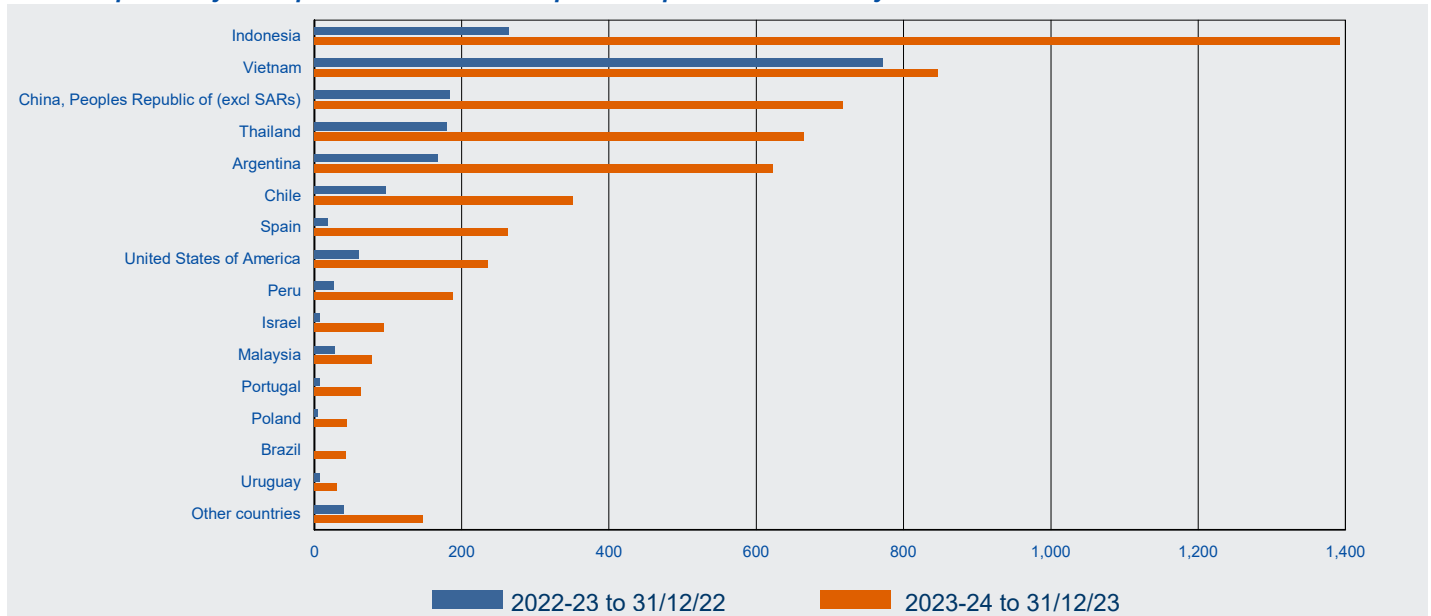

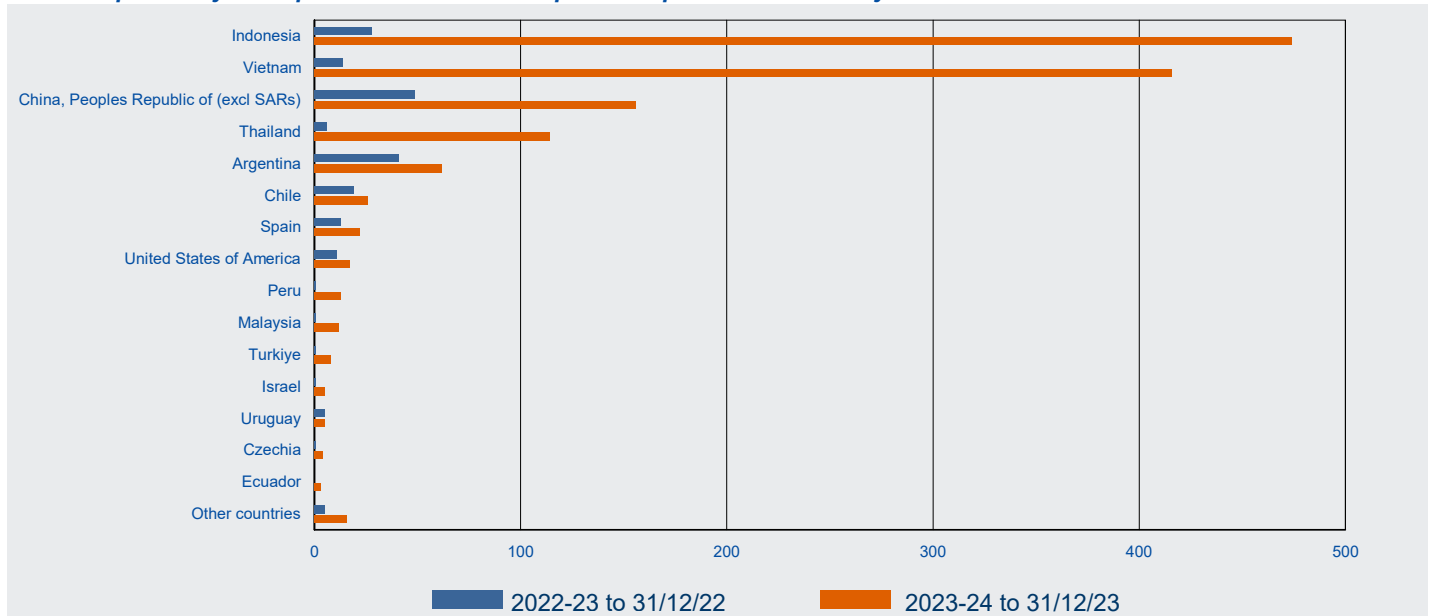

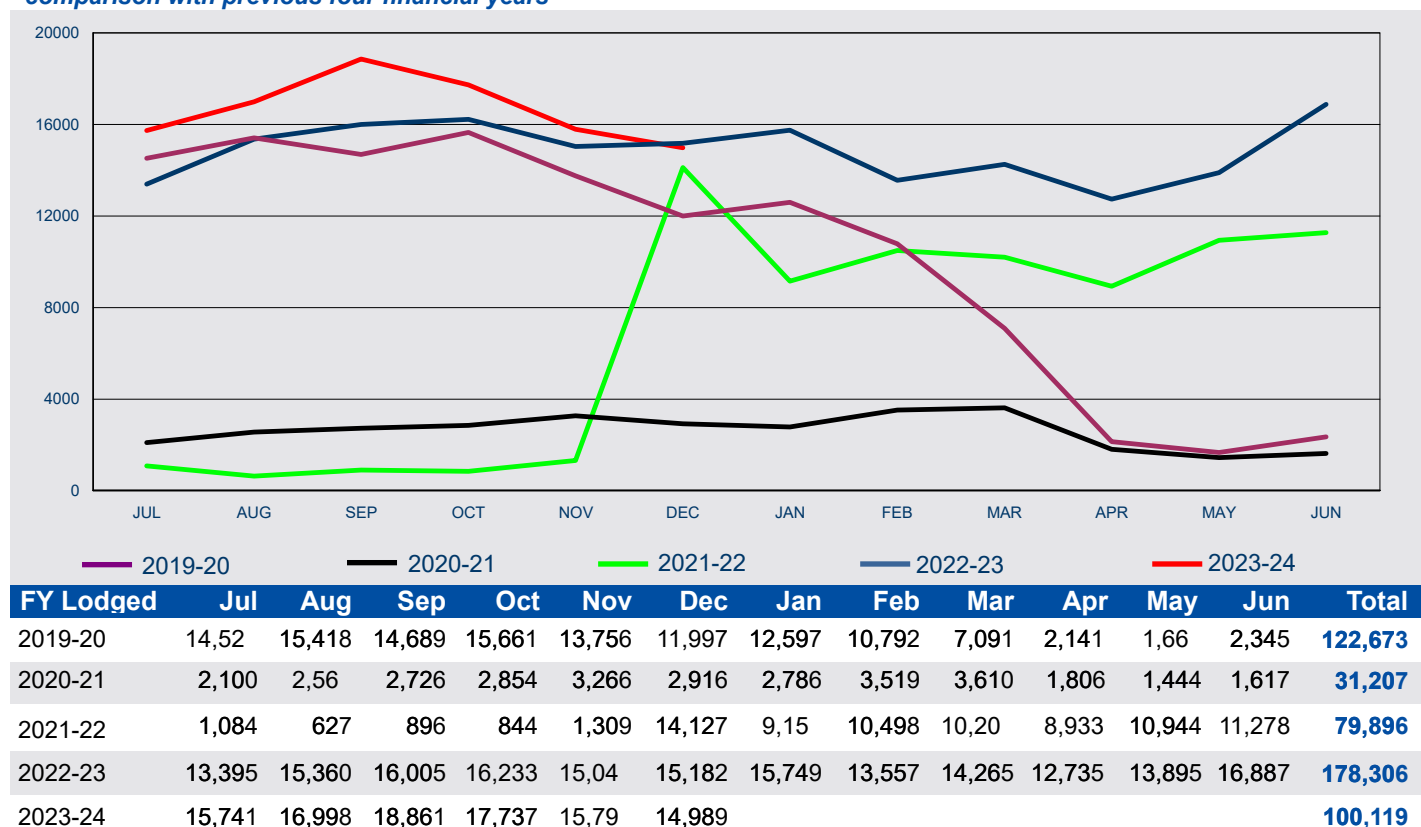

2.01 Total number of Working Holiday Maker visa applications granted in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

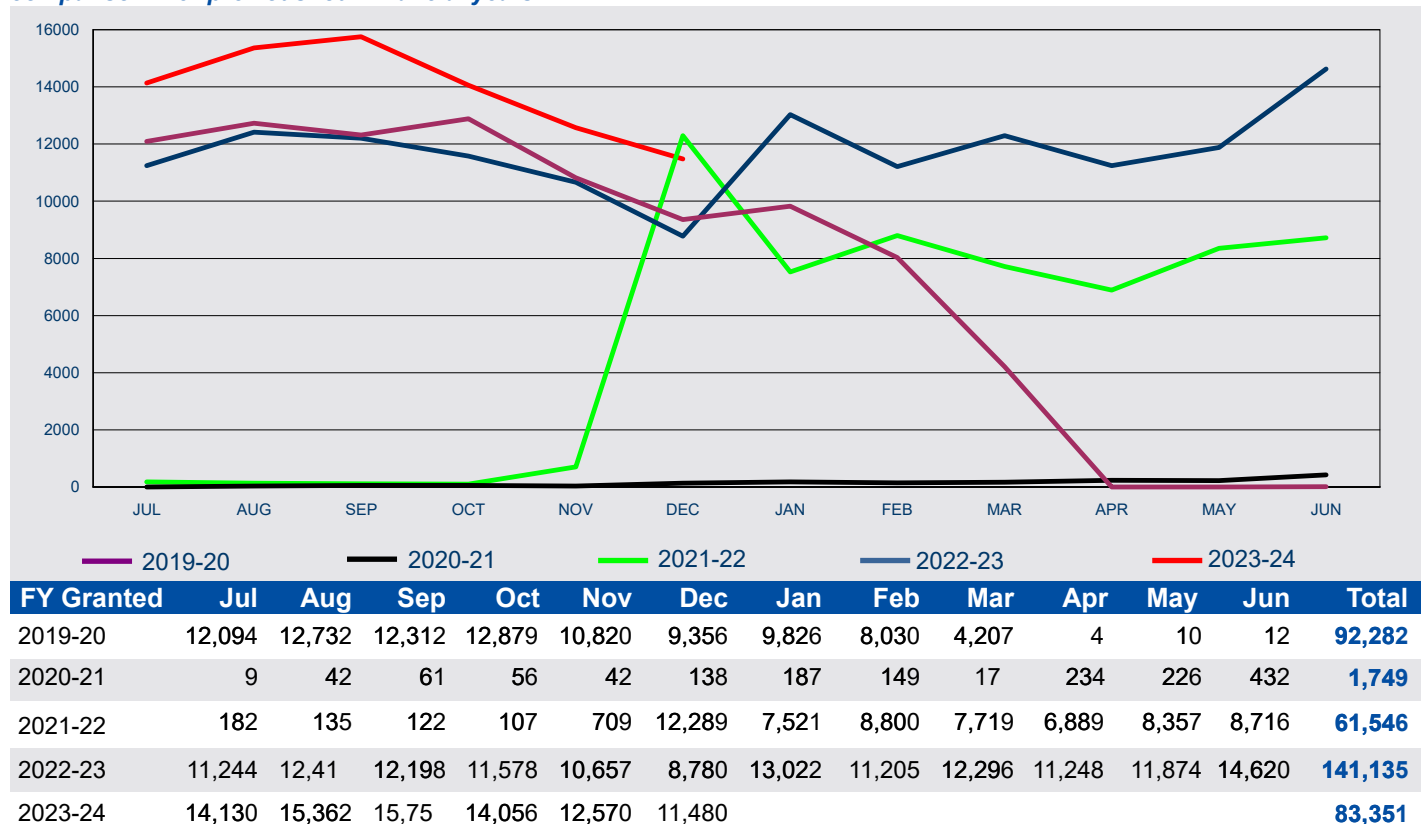


2.02 Total number of Working Holiday (subclass 417) visa applications granted in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

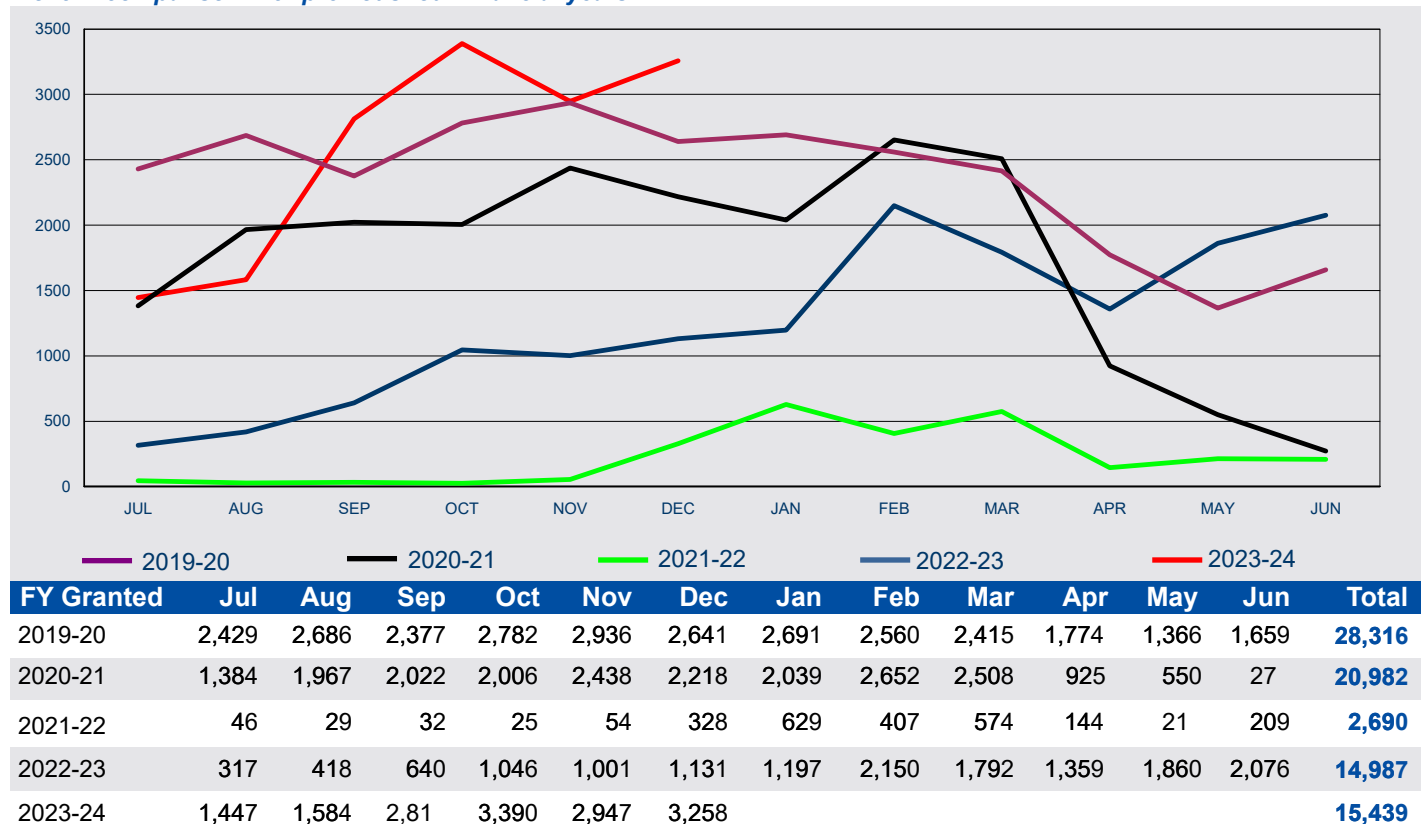

2.03 Number of first Working Holiday (subclass 417) visa applications granted in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

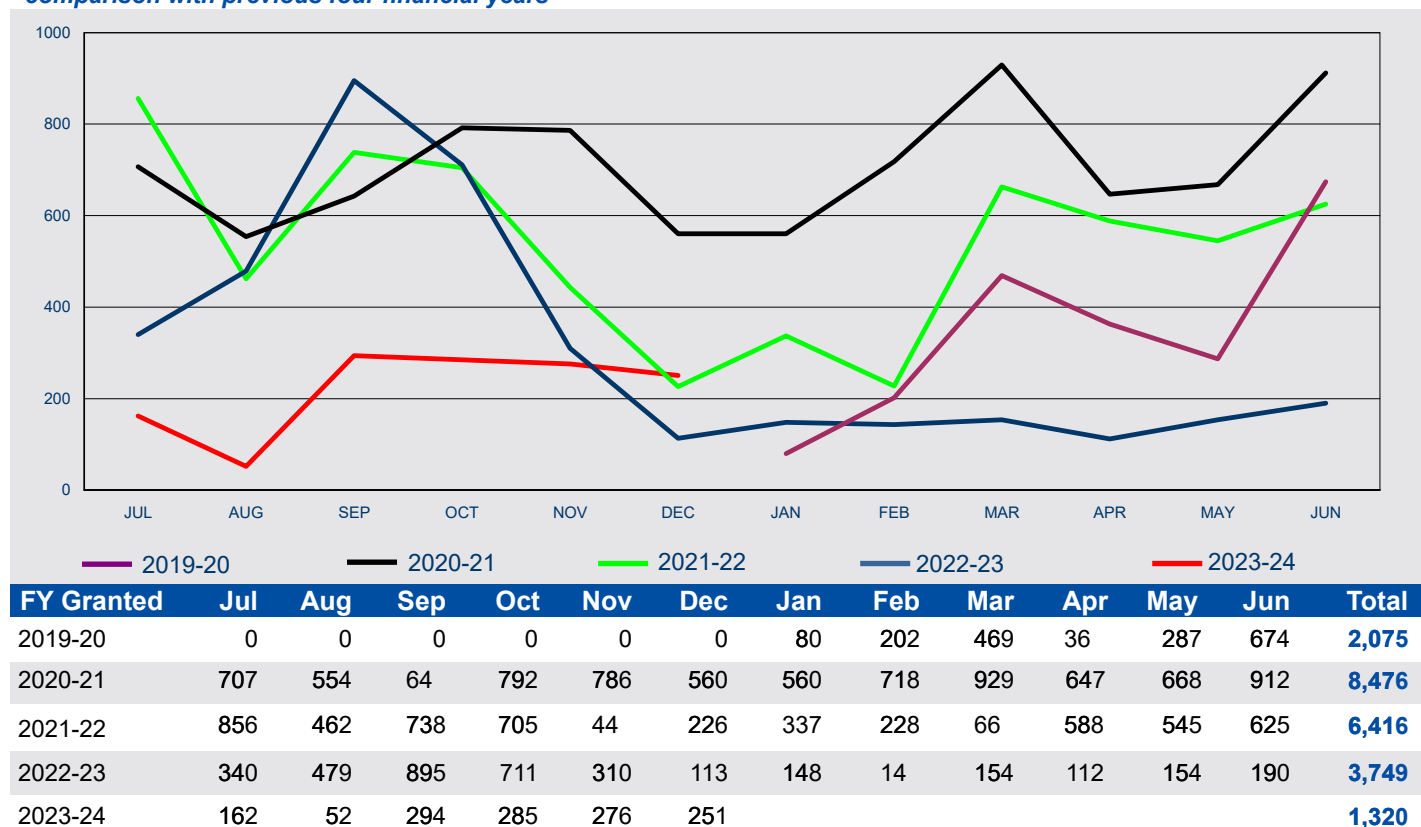


2.04 Number of second Working Holiday (subclass 417) visa applications granted in 2023-24 to 31 December 2023 by month - comparison with previous four financial years



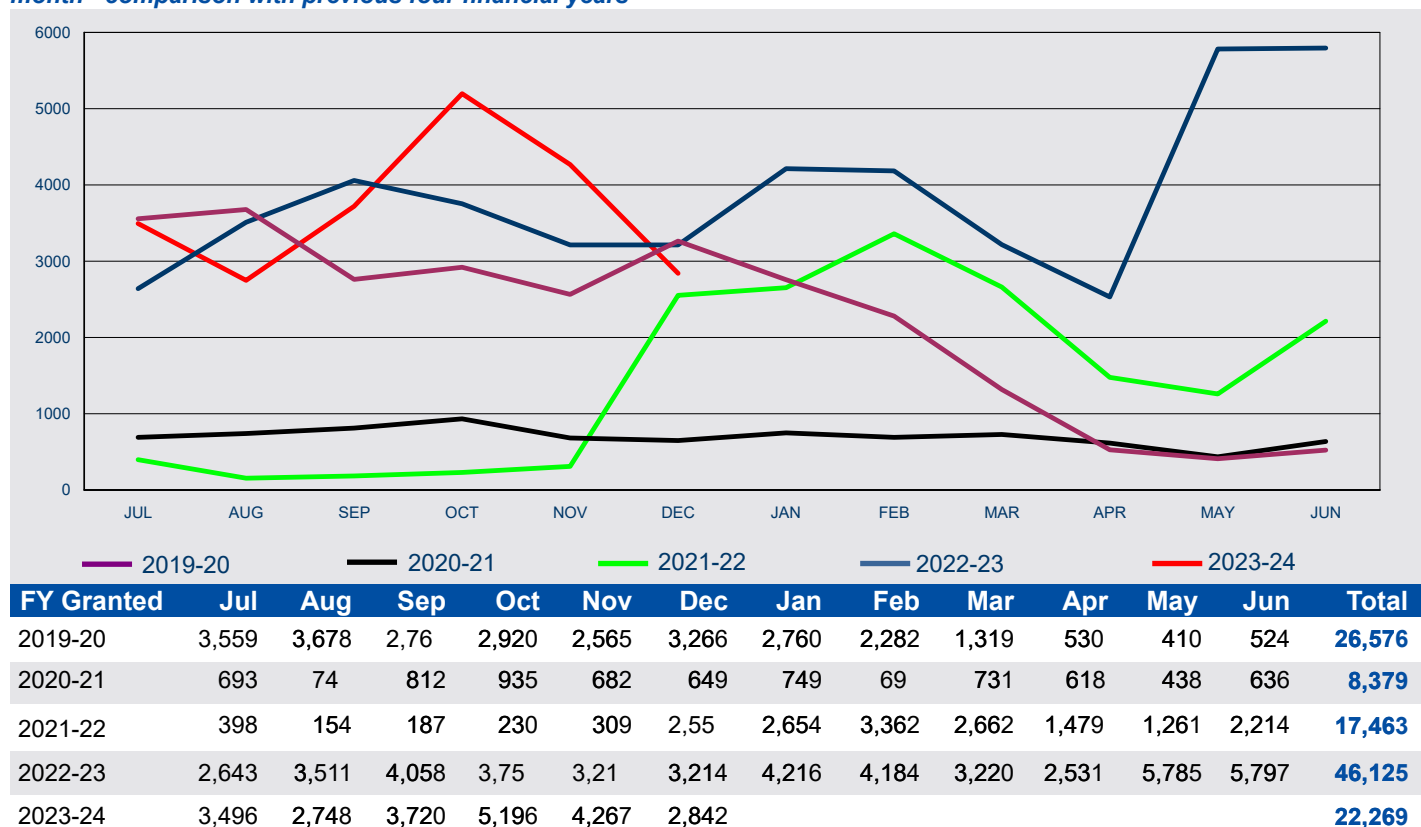

2.05 Number of third Working Holiday (subclass 417) visa applications granted in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

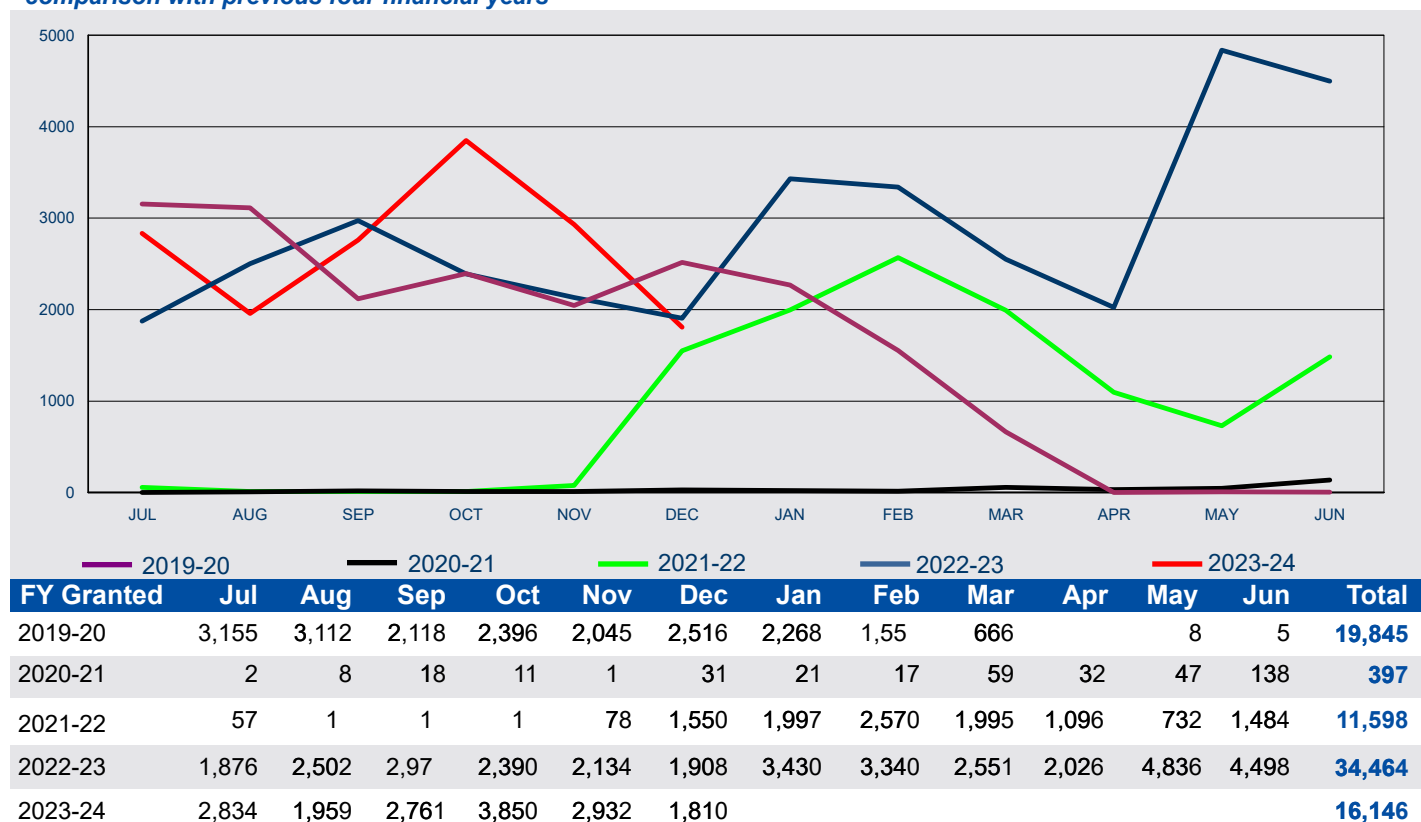

2.06 Total number of Work and Holiday (subclass 462) visa applications granted in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

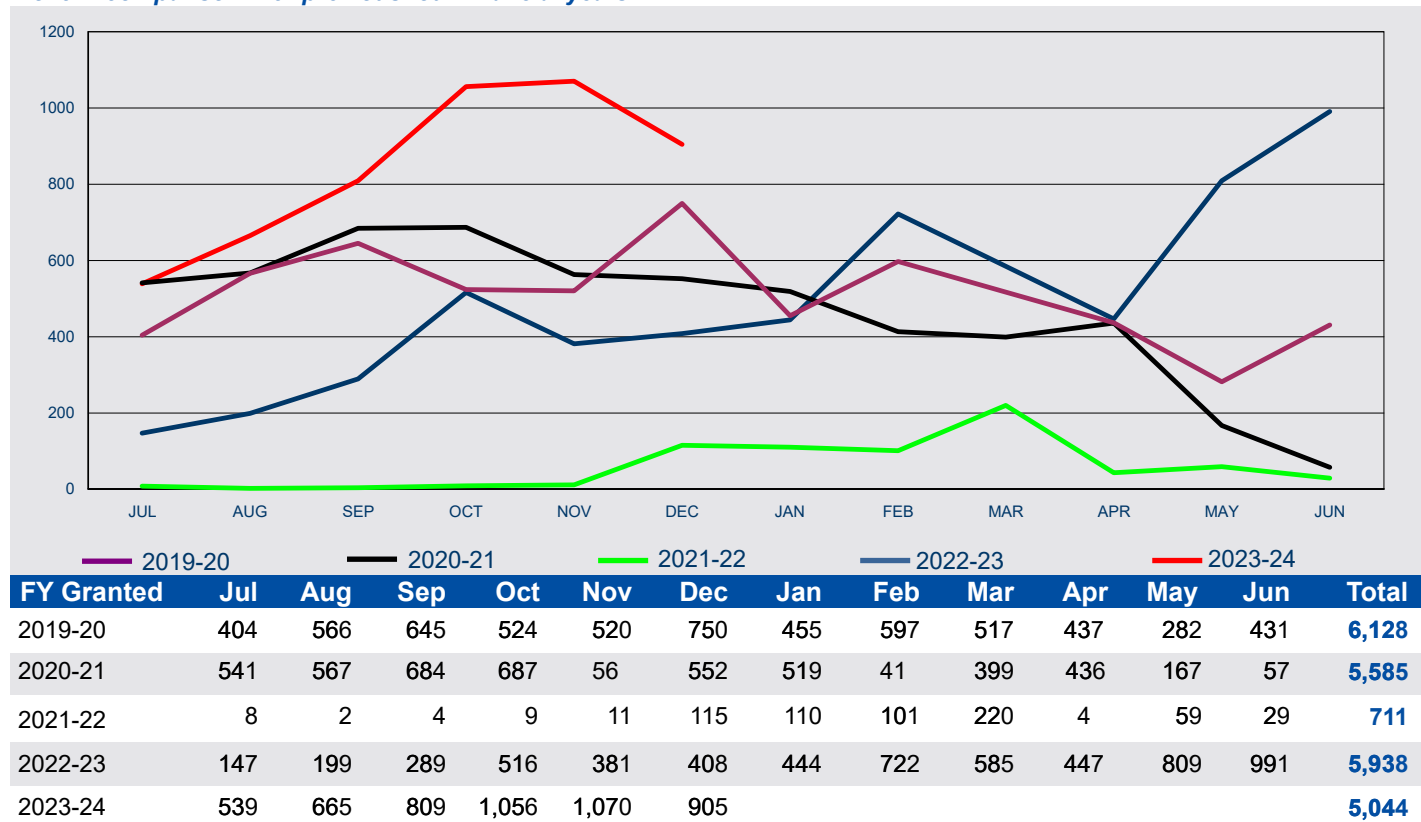


2.07 Number of first Work and Holiday (subclass 462) visa applications granted in 2023-24 to 31 December 2023 by month - comparison with previous four financial years

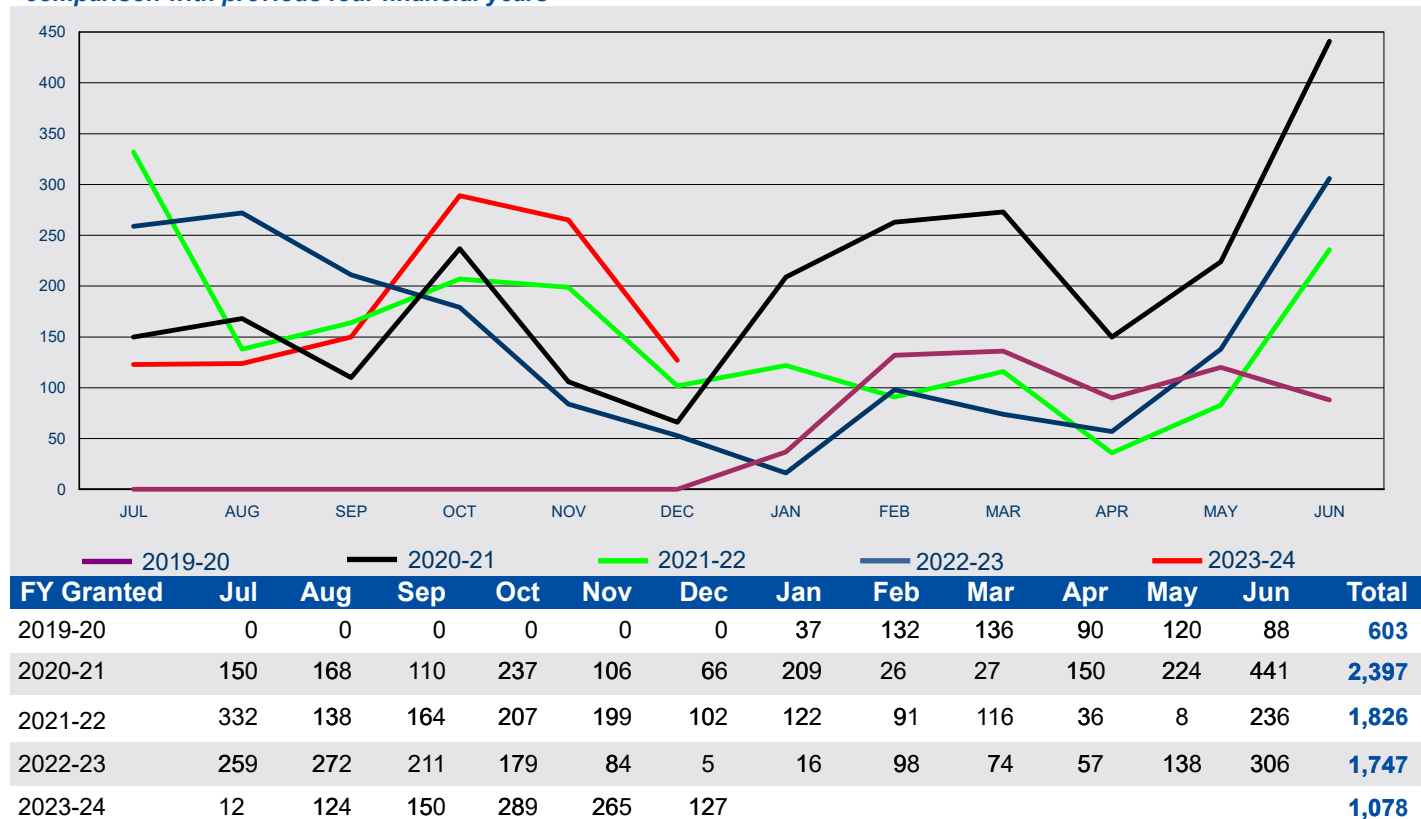

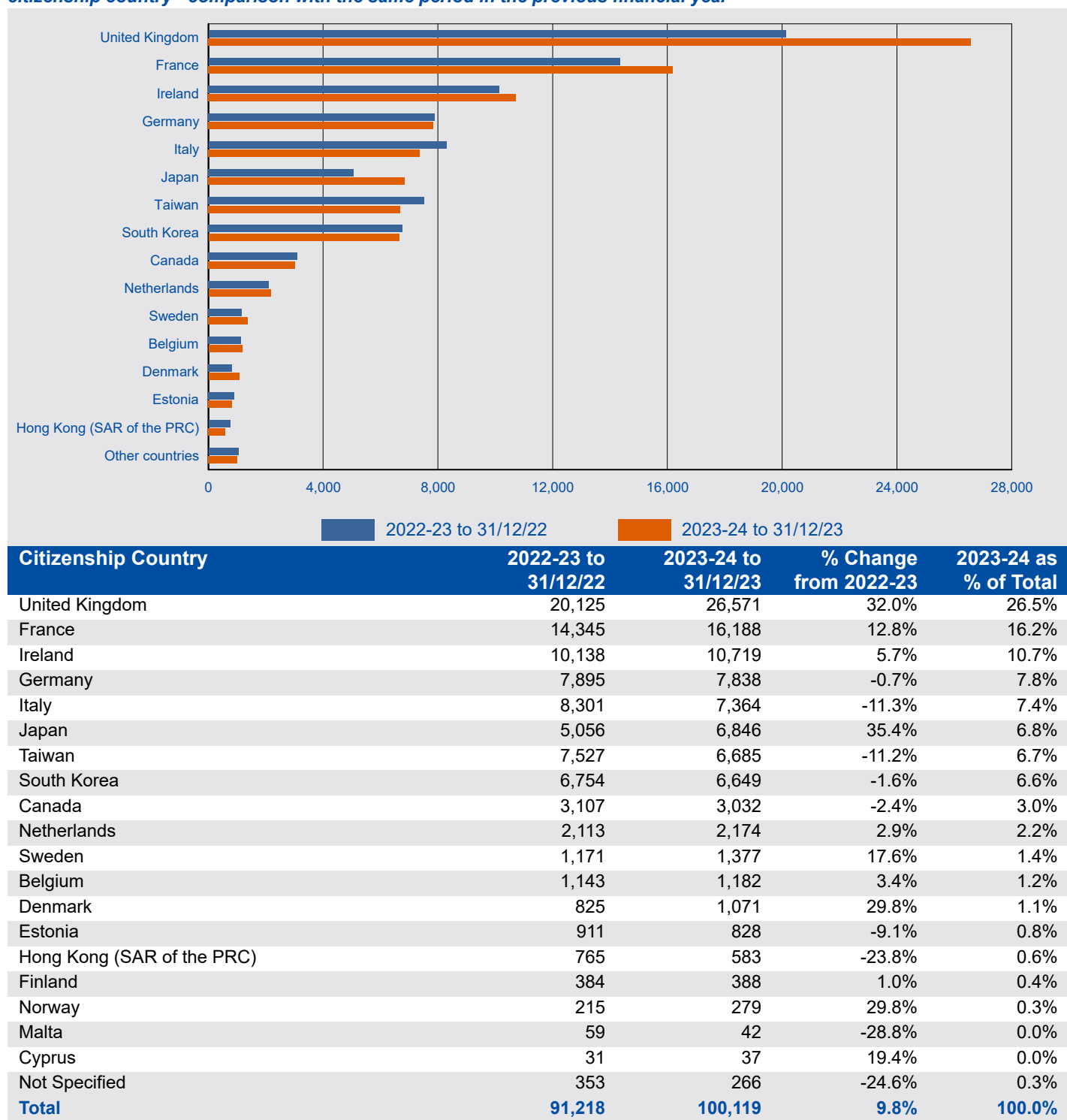

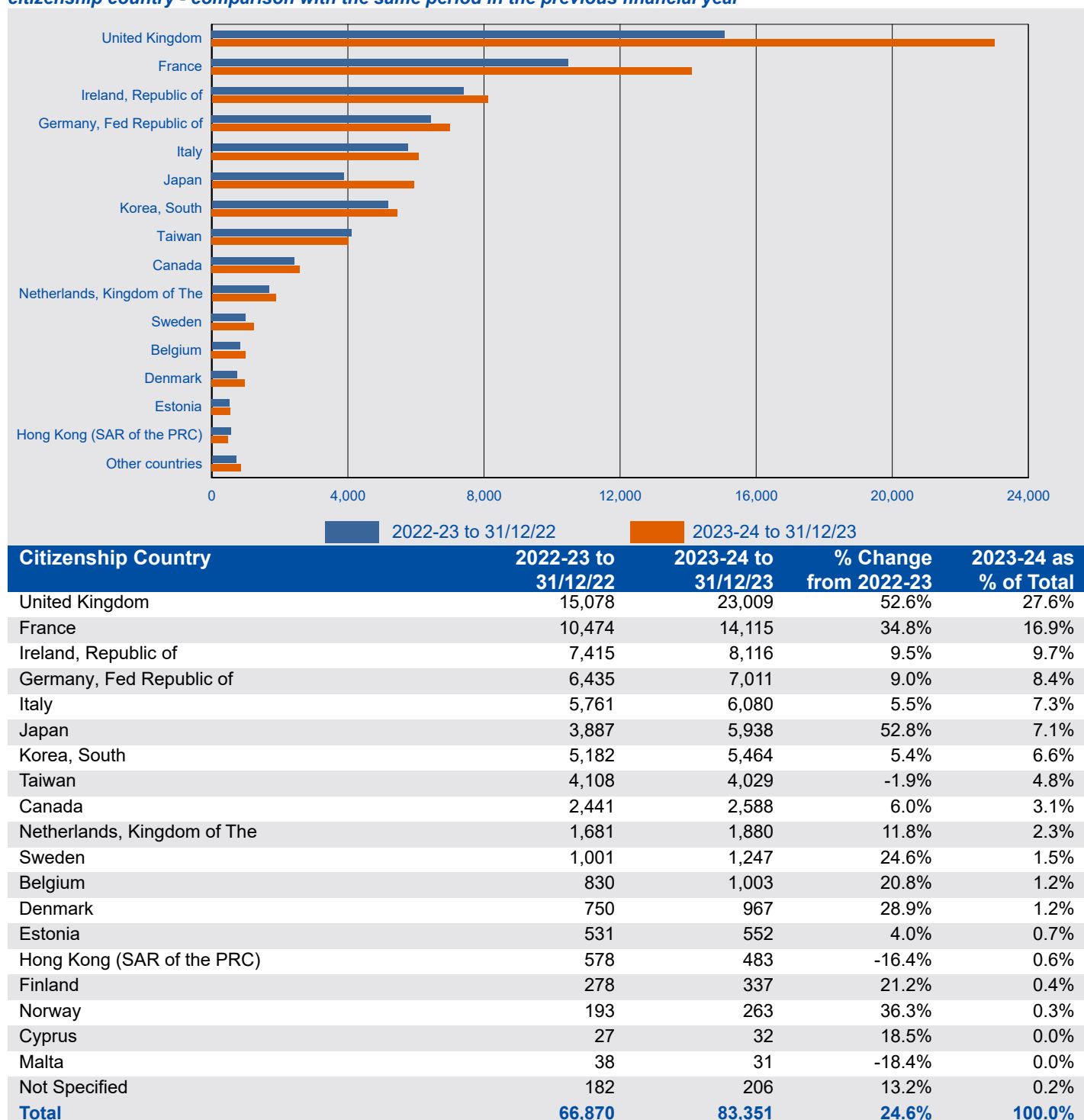

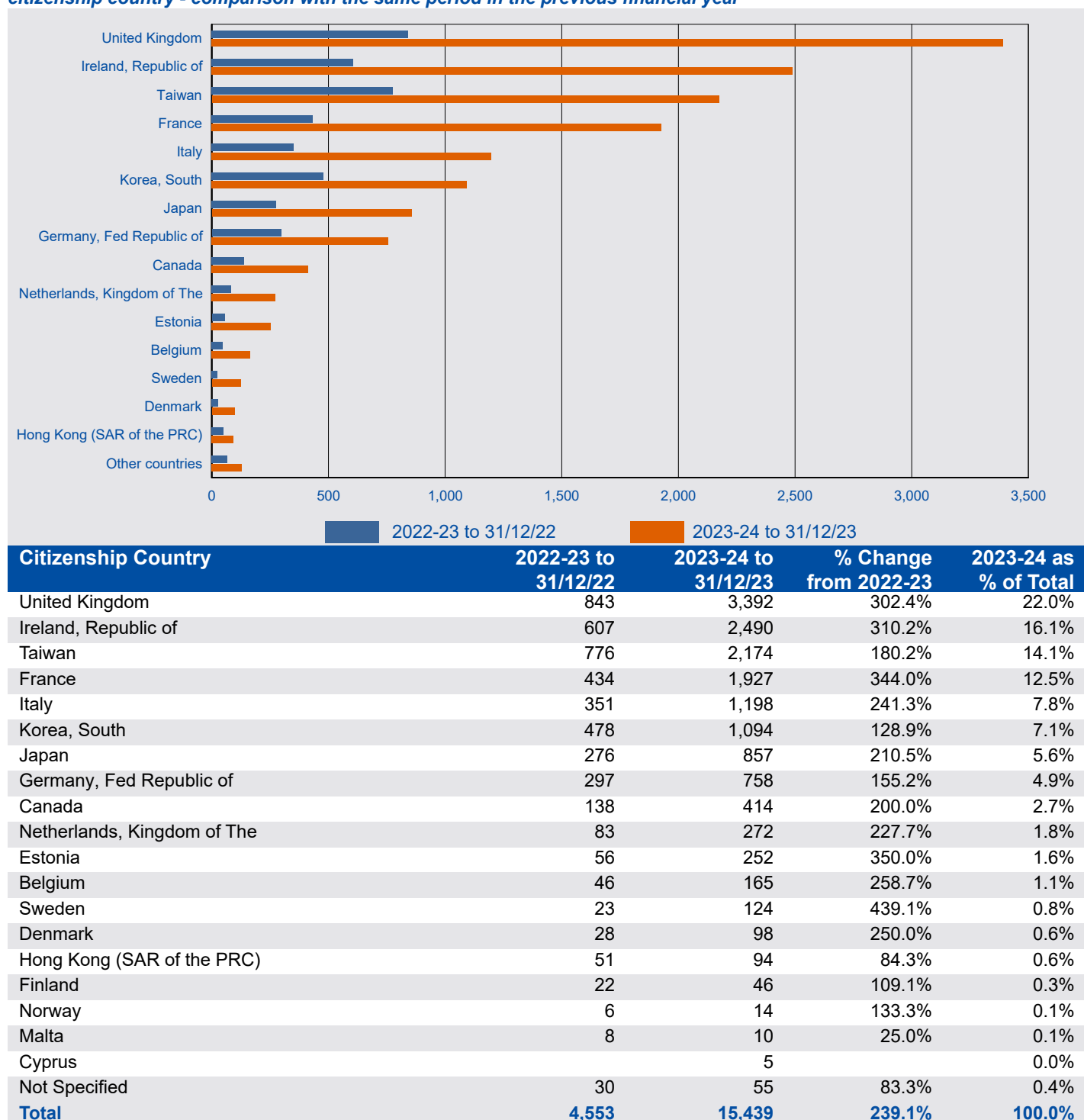

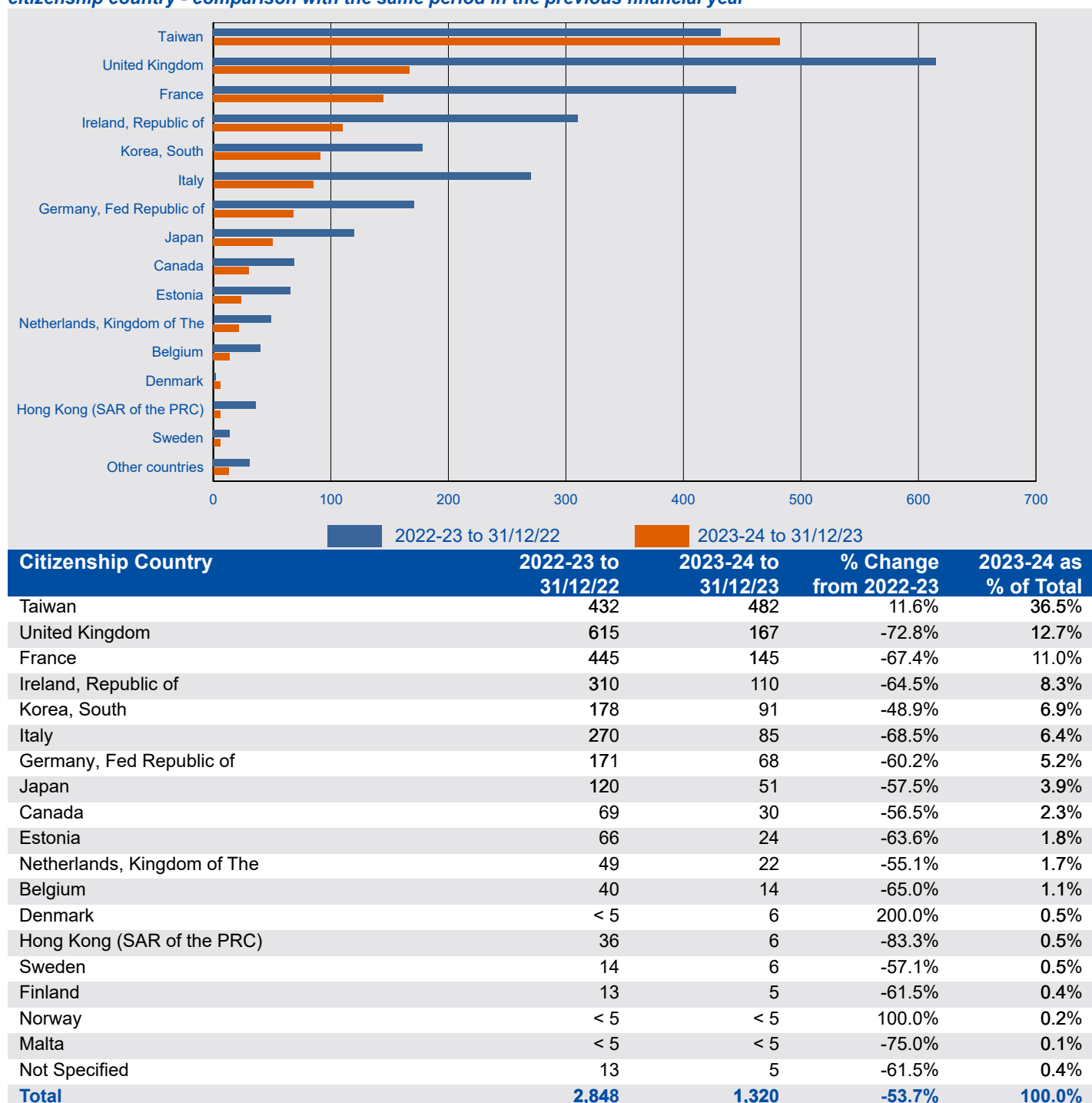

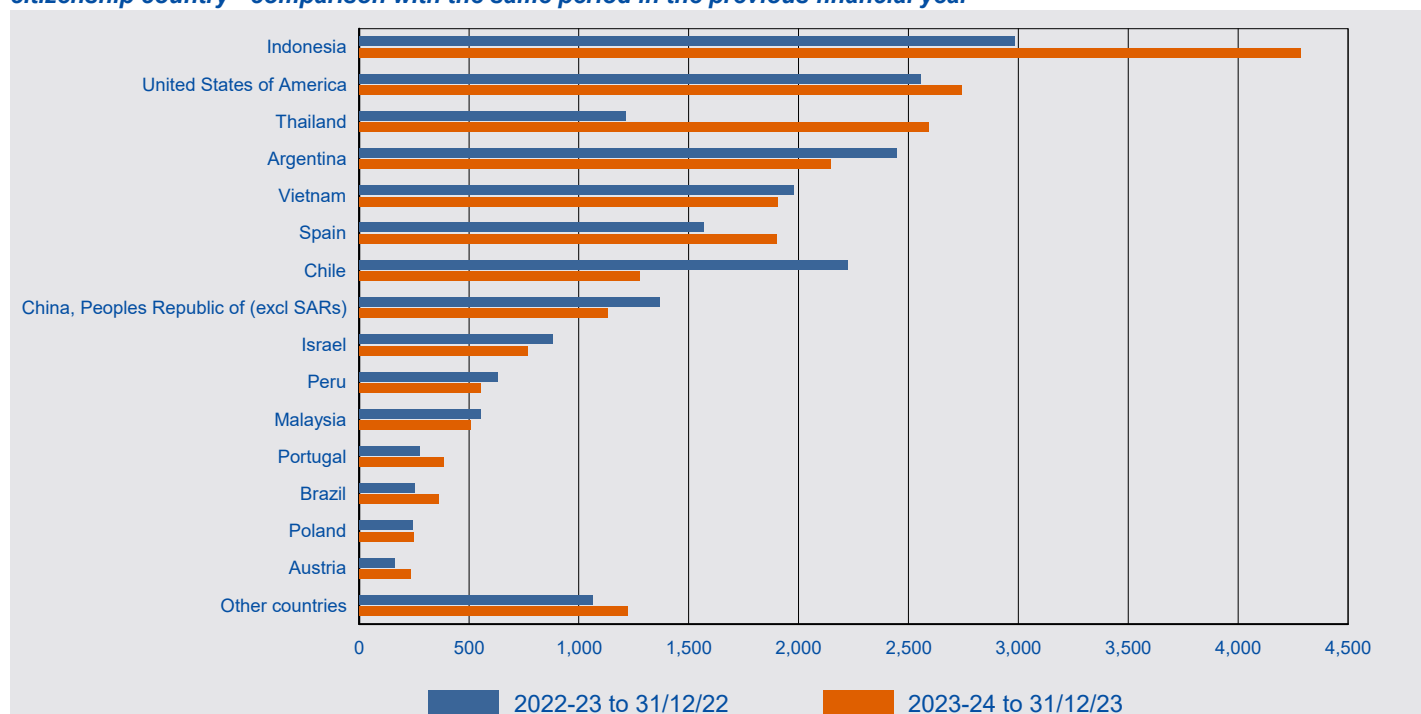

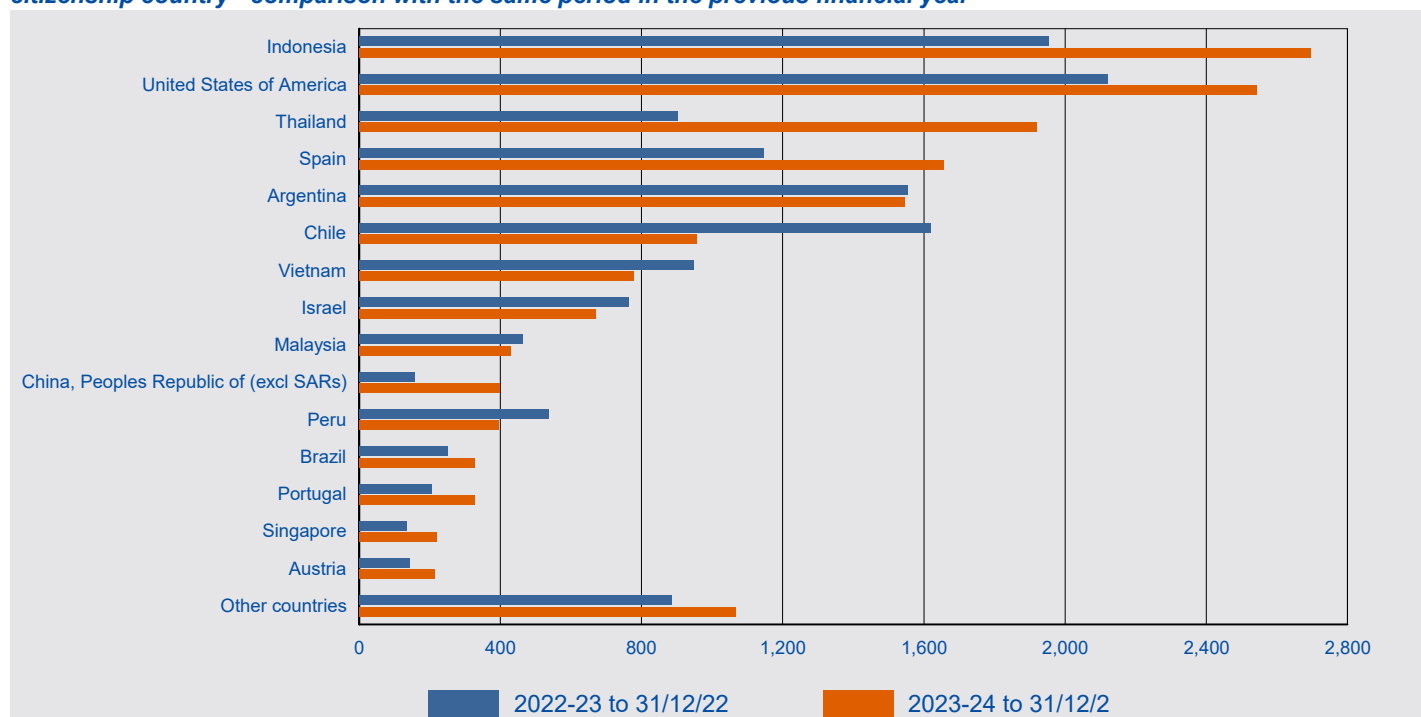

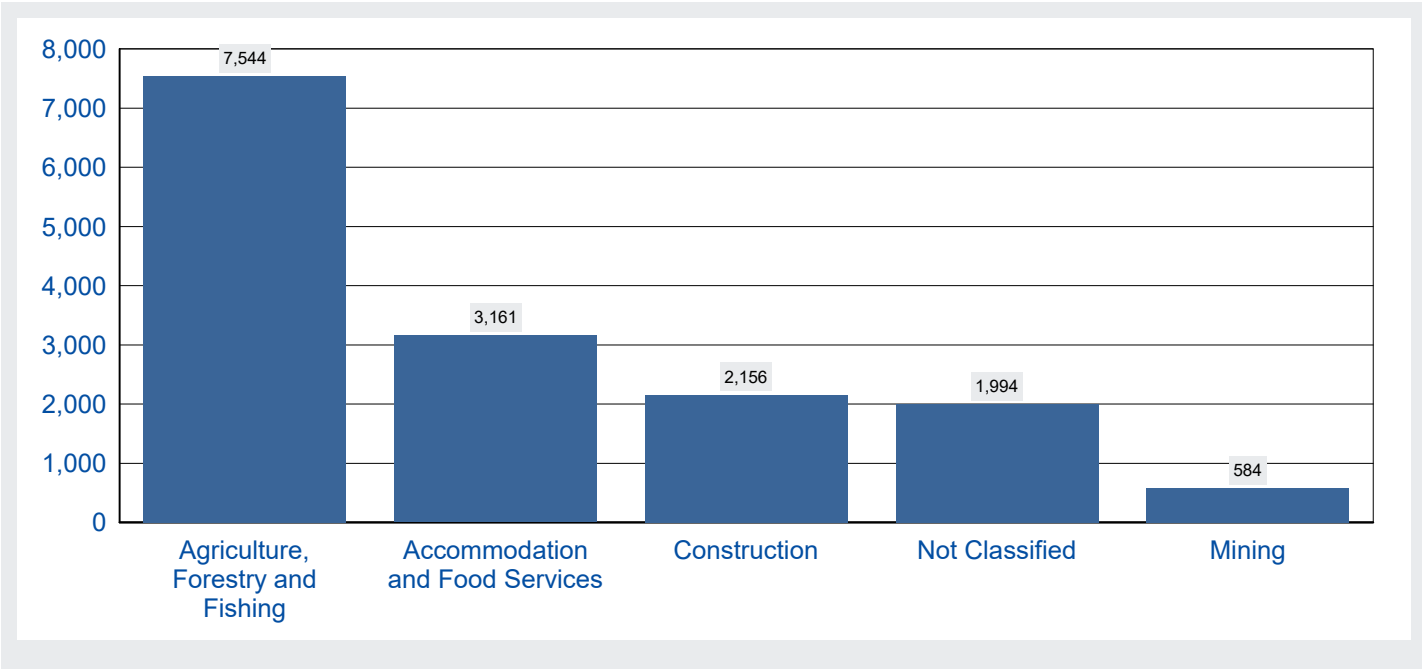

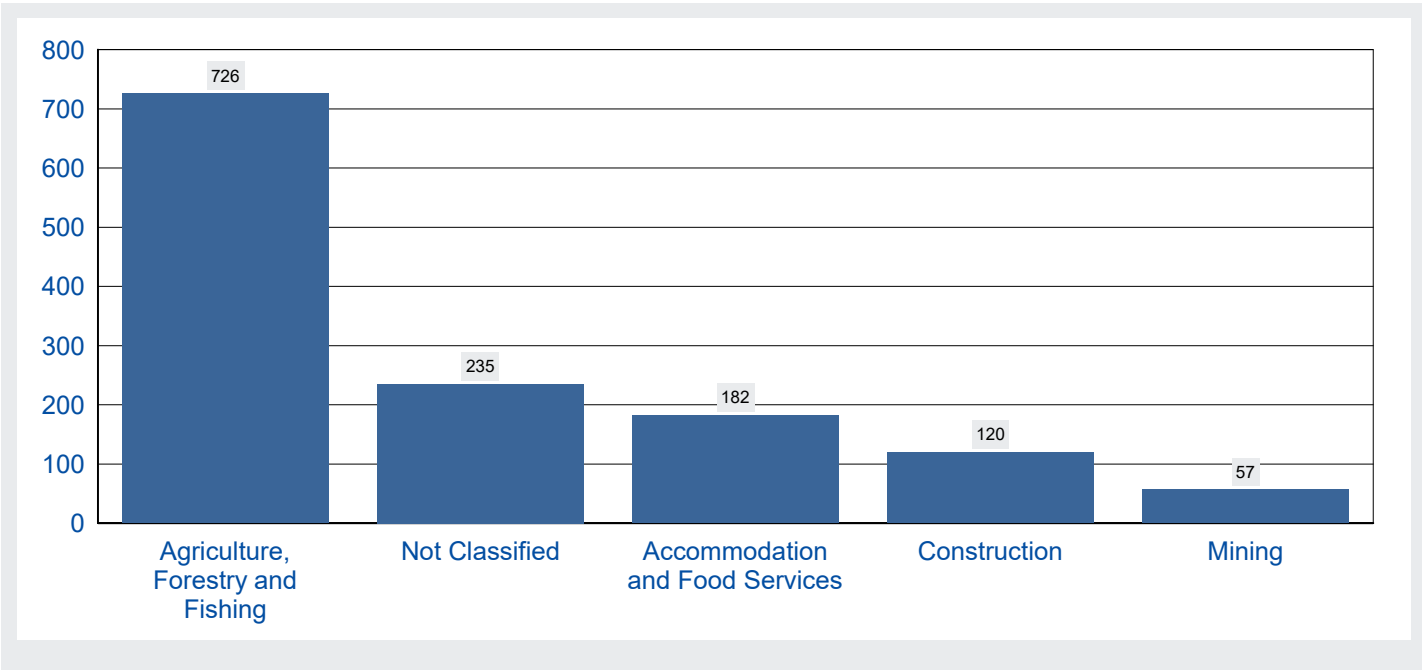

2.27 Second Working Holiday (subclass 417) visa applications granted in 2023-24 to 31 December 2023 by employer industry

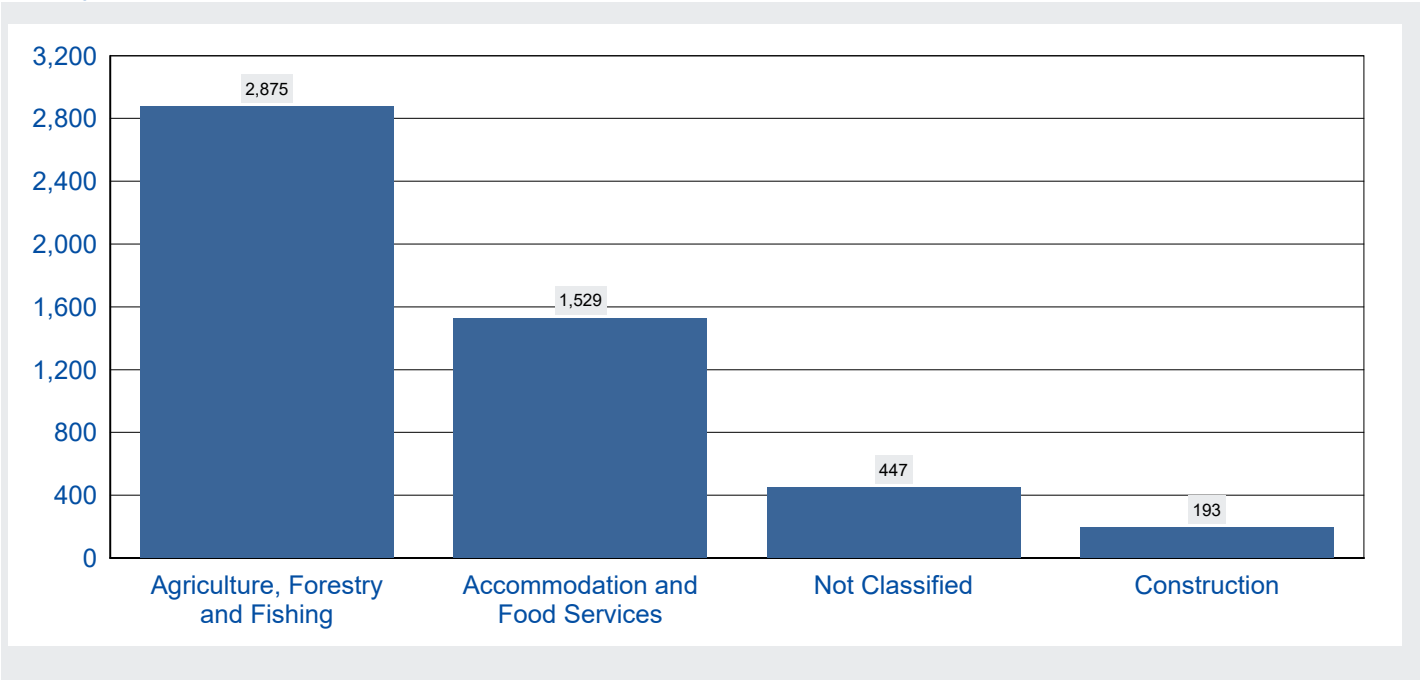


2.28 Third Working Holiday (subclass 417) visa applications granted in 2023-24 to 31 December 2023 by employer industry

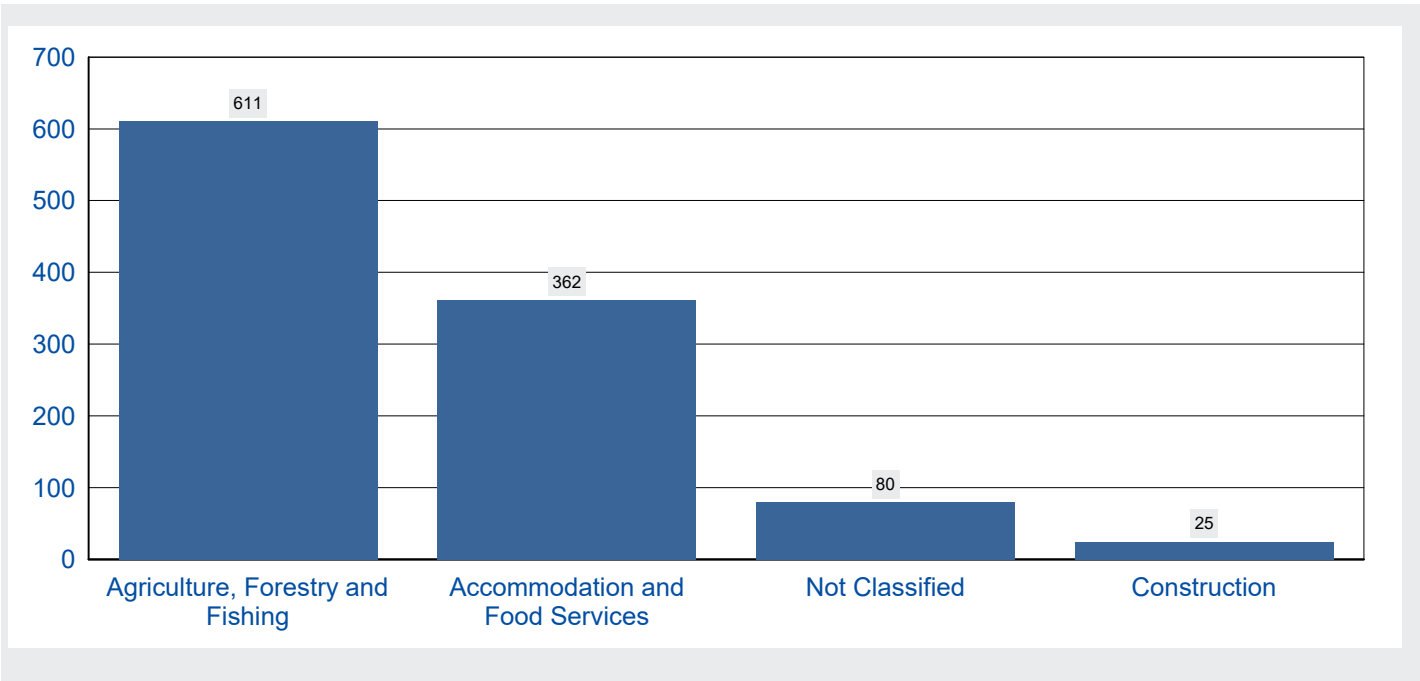

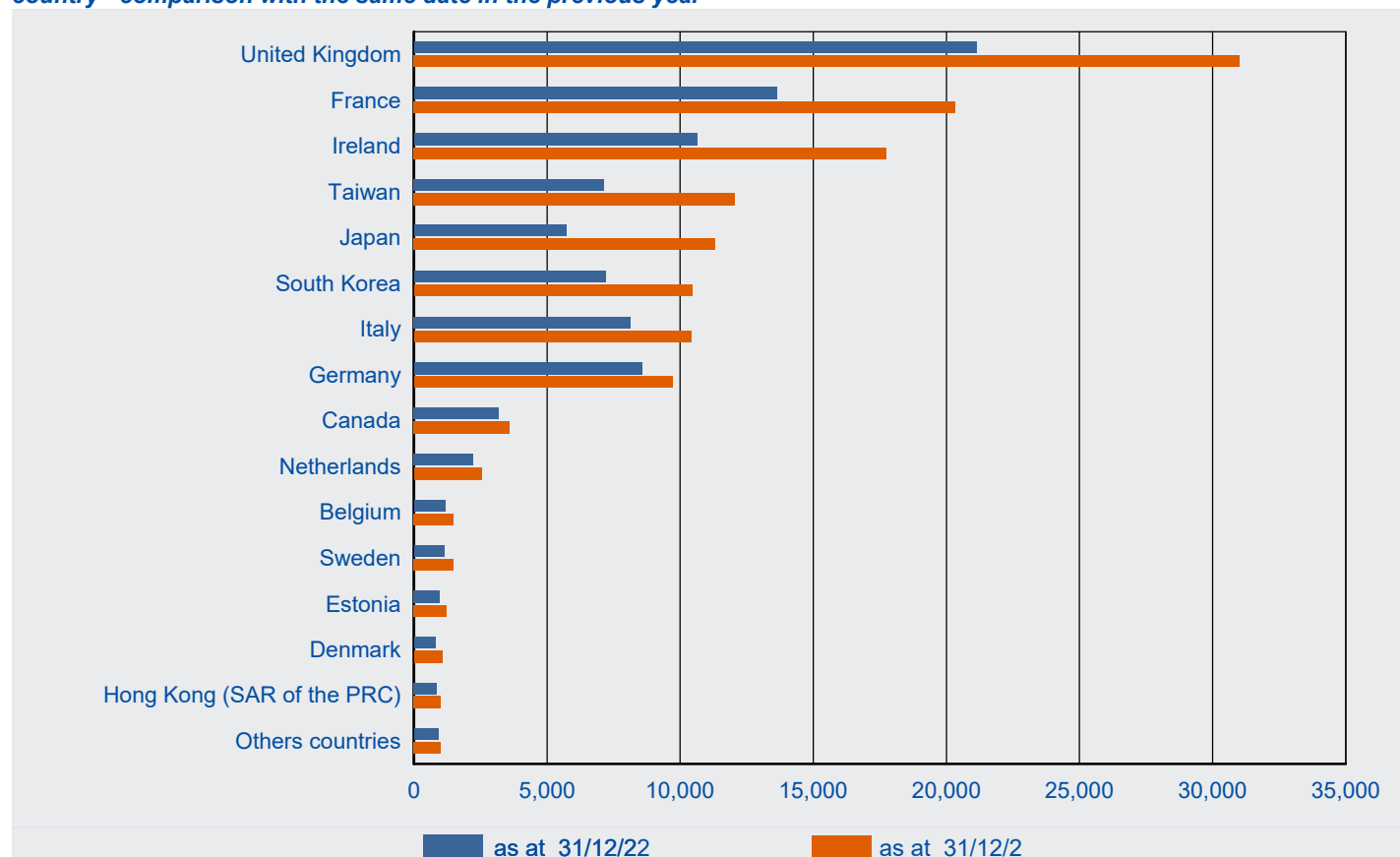

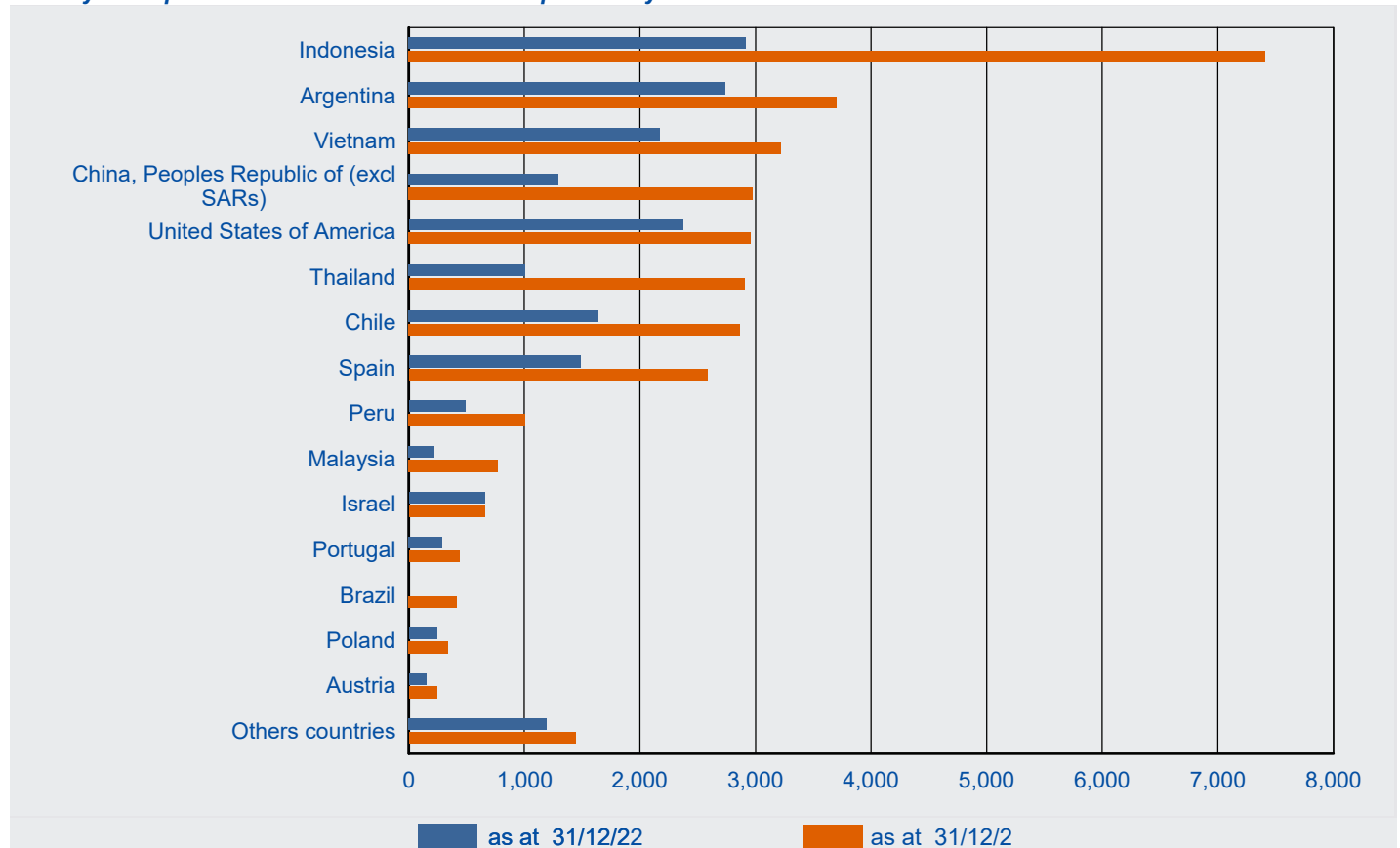
